SUMMARY

Issue for Discussion

Should the Board of Regents review last year's Non-State Aid budget and legislative priorities to identify modifications, as appropriate, and any new proposals for inclusion in the Board's 2022-2023 Non-State Aid budget and legislative priorities?

The Board of Regents advance Non-State Aid budget and legislative requests every year, which reflect initiatives that support the Board's priorities by augmenting or adding funds to the State Education Department's budget. These funds are necessary to meet the Board's policy priorities.

Reason(s) for Consideration

Review and update of the Regent's Non-State Aid budget and legislative priorities.

Proposed Handling

This issue will come before the Board of Regents State Aid Subcommittee for discussion at its October 2021 meeting.

Procedural History

The process for advancing 2022 non-state aid budget priorities was presented and discussed with the full Board at the September Board of Regents meeting. Between the September and October Regents meetings, the State Aid Committee co-chairs met with SED staff in preparation for the review of previously discussed proposals at the

October Regents meeting. Additional consultations will occur between committee cochairs, SED staff, and stakeholders between the October and November Regents meetings. This will be in preparation for bringing updated proposals, including those previously advanced as well as new initiatives, to the Board and relevant program committees for further consideration at the November Board of Regents meeting. Between the November and December Regents meetings, additional conversations will occur between committee co-chairs and stake holders as needed with the consideration and approval of proposals in December to be advanced during the upcoming budget cycle and legislative session.
