STANDING COMMITTEE REPORTS

CULTURAL EDUCATION

Your Committee on Cultural Education Committee had its scheduled meeting on October 17, 2017. Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report.

In attendance were committee members: Regent Tilles, Chair, Regent Cea, Regent Cottrell, Regent Chin, Regent Ouderkirk, Regent Johnson and Regent Mead. Regents, in addition to CE Committee Members, in attendance were: Chancellor Rosa, Regent Young, Regent Cashin, Regent Reyes, and Regent Mittler. Also in attendance were

Commissioner Elia, Executive Deputy Commissioner Berlin, and Counsel and Deputy Commissioner for Legal Affairs Alison Bianchi.

ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and introduced Deputy Commissioner Mark Schaming. Mark provided a brief report on Office of Cultural Education news and activities including: honoring Dr. Janny Venema, Assistant Director of the New Netherland Research Center at the New York State Library, on her recent appointment as a Knight in the Order of Orange Nassau by the Netherlands government; two new acquisitions at the State Library: a collection of documents and photographs donated by newspaper editor Harry Rosenfeld and a collection of 3,000 books from the Holland Society of New York Library that expands the State Library's large local history and genealogy resources; and the State Museum's Votes for Women exhibition opens on Saturday, November 4 and there will be a special preview event on Wednesday, November 1 at 10:30 a.m. to celebrate the opening of the exhibition.

New York State Summer School of the Arts [CE (D) 1] - Molly Hennighausen, Executive Director of the New York State Summer School of the Arts (NYSSSA), presented on the 2017 season of NYSSSA and outreach plans for the future. The program provides talented high school students the opportunity to study with some of the world's foremost artists in the visual and performing arts in seven schools, including ballet, dance, choral studies, orchestral studies, theatre, visual arts, and media arts. Nearly 900 students auditioned or submitted portfolios to participate in the seven NYSSSA schools in 2017. 347 students gained acceptance and enrolled in the program. Students are accepted into the schools through a competitive audition process conducted by the artistic staff. Tuition rates are maintained at a modest level and tuition assistance is available, enabling every student who qualifies the opportunity to participate in the program.

Appointment of New Members to the Museum Regents Advisory Council and to the Library Regents Advisory Council [CE (A) 1] - Deputy Commissioner Mark Schaming introduced the recommended appointments to the Museum Regents Advisory Council and the Library Regents Advisory Council. Members of the Museum Regents Advisory Council offer advice and consultation on issues of policy and service pursuant to the Board's statutory mandate to operate the State Museum and oversee museums across New York State. The recommended appointment to the Museum Regents Advisory Council is Gretchen Sorin, Director of the Cooperstown Graduate Program in Museum Studies and Distinguished Professor. Members of the Library Regents Advisory Council advises the Board on issues concerning library policy, works with the officers of the State Education Department in developing a comprehensive statewide library and information policy, and makes recommendations to the Regents for implementing library programs and initiatives. The recommended appointments to the Library Regents Advisory Council are: Susan Kowalski, Librarian at Pine Grove Middle School at the East Syracuse Minoa Central School District; Mary-Alice Lynch, Trustee at the Clifton Park-Halfmoon Library; Susan Polos, School Library Media Specialist at Bedford Central School District; and Juan Rivera, Library Media Specialist at A. Philip Randolph Campus High School.

HIGHER EDUCATION

Your Higher Education Committee held its scheduled meeting on October 17, 2017. All members were present with the exception of Regents Brown, Norwood and Collins who were absent and excused.

ACTION ITEMS

Proposed Amendment to Subpart 80-6 of the Regulations of the Commissioner of Education Relating to Continuing Teacher and Leader Education for Teachers in Non-Public Schools to Implement Chapter 311 of the Laws of 2017 [HE (A) 1] - Your Committee discussed a proposed amendment to Subpart 80-6 of the Regulations of the Commissioner of Education Relating to Continuing Teacher and Leader Education for Teachers in Non-Public Schools to Implement Chapter 311 of the Laws of 2017. The 2015-2016 State Budget added Section 3006-A to the Education Law to require all holders of teaching certificates, teaching assistant certificates, and educational leadership certificates which are valid for life (Permanent, Professional and Teaching Assistant Level III) to register with the Department every five years and that holders of the Professional and Teaching Assistant Level III certificates complete 100 hours of continuing teacher and leader education during the five year registration period. Chapter 311 of the Laws of 2017 amends Education Law §3006-a to add nonpublic schools to the provisions relating to the mandatory continuing education requirements for all holders of professional certificates in the classroom teaching service, holders of level III teaching assistant certificates, and holders of professional certificates in the educational leadership service. In order to implement the new law, the proposed regulation amends the definition of applicable school in Section 80-6.1 of the Commissioner's Regulations to include non-public schools. VOTED that Section 80-6.1 of the Regulations of the Commissioner be amended, as submitted, effective October 17, 2017, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to immediately adopt the proposed amendment to timely implement the changes to Education Law §3006-a, as amended by Chapter 331 of the Laws of 2017. Following the 45-day public comment period required under the State Administrative Procedure Act, it is anticipated that the proposed amendment will be adopted by the Board of Regents at its January 2018 meeting. If adopted at the January 2018 meeting, the proposed amendment will become effective on January 25, 2018.

MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on October 17, 2017, copies of which have been distributed to each member of the Board of Regents.

Matters Not Requiring Board Action:

Proposed Amendment to Add a New Section 80-5.25 to the Regulations of the Commissioner of Education to Establish a Transitional H Pathway for Holders of a New York State License as a Certified Public Accountant to Pursue a School District Business Leader Certificate [HE (D) 1] - Department staff presented an amendment to add a new Section 80-5.25 to the Regulations of the Commissioner of Education to establish a Transitional H pathway for holders of a New York State license as a certified public accountant (CPA) with at least three years of experience auditing New York State school districts, BOCES and/or municipalities with the ability to pursue a school district business leader certificate. Following the 45-day public comment period required under the State Administrative Procedure Act, it is anticipated that the proposed amendment will come back to the Board of Regents at its January 2018 meeting. If adopted at the January 2018 meeting, the proposed amendment will become effective on January 25, 2018.

TeachNY Update - The Commissioner updated the Board on the work of the Department including teacher certification pathways, the development of national “teacher tables” and the work to implement teach.org.

Presentation on P-TECH Data [HE (D) 2] - Department staff and a panel of students provided a program overview of the NYS P-TECH Program and Smart Scholars Early College High School and the most up-to-date student enrollment and achievement data collected from all three cohorts of students.

Consent Agenda

The Board of Regents acted on the following consent agenda items at the October 2017 meeting.

P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on October 16, 2017. All members were present, except for Regent Finn, who was excused.

MATTERS NOT REQUIRING BOARD ACTION

Senior Deputy Commissioner's Report – Senior Deputy Commissioner Jhone Ebert updated the Committee on two important initiatives.

- **REL-NEI (Regional Educational Laboratory-Northeast and Islands)** – the Department is collaborating with REL-NEI on a study that will examine whether Regents diploma attainment in New York State has increased after implementation of the 4+1 graduation pathway, particularly among groups of students with historically low graduation rates. Additionally, the Department is partnering with REL-NEI to develop a research agenda to explore potential activities such as availability of CTE and teacher and principal preparation.
- **Building Educator Capacity** – the Department has formed a task force of educators and other stakeholders, including BOCES, district leaders, principals, teachers, and higher education representatives, to discuss strategies to help us improve the way we support all educators. The first strategy includes a Professional Learning Team (PLT) made up of representatives from BOCES, RICs, S/CDN, higher education, Big 5, SAANYs, NYSUT, UFT, ESSAA and PSPB. This fall, the group will meet to determine how various supports and tools support statewide priorities.

Charter School Performance Framework [P-12 (D) 1] – the Committee discussed key areas of the Charter School Performance Framework that guide the performance oversight of Board of Regents-authorized charter schools. Discussions with the field have taken place across the state where board members and administrators of Regents-authorized charter schools were given the opportunity to provide feedback and suggested changes to the Performance Framework. Discussion focused on the 10 benchmarks of charter school performance, specifically on benchmarks 1 – Student Performance, 3 – School Climate (which includes chronic absenteeism), 4 – Fiscal Dashboard, and 9 – Enrollment and Retention. Staff will collect comments and concerns from Committee members for discussion at a future meeting.

Review of the New York State High School Diploma Requirements [P-12 (D) 2] – the Committee continued their discussion of opportunities leading to a Regents diploma and key goals for potential changes to the diploma requirements, which include:

- Prepare students for 21st century postsecondary options;
- Offer more flexibility in completing credit requirements related to pathway choice

- and student interest;
- Expand external certification assessment options; and
- Allow students to demonstrate proficiency in multiple ways.

Department staff will continue to seek input from various stakeholder groups and return to the Board for further discussion and recommendations.

The Committee also heard a presentation by Dr. Patrick Michel, District Superintendent from the Hamilton-Fulton-Montgomery BOCES and the PTECH program at that BOCES. Students who enter this program are incoming ninth-graders who will simultaneously earn Regents high school diplomas and associate's degrees at no cost to their families from Fulton Montgomery Community College in four to six years. Students who participate are motivated to learn in new and exciting ways and thrive in non-traditional classroom settings. The BOCES is exploring ways to integrate this program into traditional high schools in its component districts due to the overwhelming number of students interested in participating.

P-12 EDUCATION/ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES) JOINT MEETING

Your P-12 Education and ACCES Committees held a joint meeting on October 16, 2017. All members were present, with the exception of Regent Finn, who was excused.

MATTERS NOT REQUIRING BOARD ACTION

Proposal for a new Pathway to a New York State High School Equivalency Diploma [P-12/ACCES (D) 1 – REVISED] – the Committee was presented with the proposed amendments to regulations for a new pathway to a NYS High School Equivalency (HSE) Diploma. There are currently three pathways toward earning a HSE diploma: TASC™ testing (Test Assessing Secondary Completion); approved 24-College-Credit Program; and National External Diploma Program (NEDP). The fourth pathway presented today would allow students who have passed any Regents high school examination in Mathematics, English language arts, Social Studies or Science, the opportunity to use passing scores in place of the corresponding TASC™ subtests. The four pathways to an HSE diploma will provide equitable access points and a diverse means by which New Yorkers can earn HSE credentials. The ability to use passing Regents examination scores toward earning an HSE diploma will expand the opportunity for high-school students at risk of dropping out as well as students with disabilities to stay engaged with their education and offer an incentive for meeting graduation requirements to those whose circumstances may not allow for completion of high school. Upon discussion, it was decided that the amendment would be presented to full Board for adoption.

P-12 EDUCATION/HIGHER EDUCATION JOINT MEETING

Your P-12 Education and Higher Education Committees held a joint meeting on October 16, 2017. All members were present, except for Regent Finn, who was excused.

ACTION ITEMS

Teachers Displaced from Puerto Rico and/or Another U.S. Territory as a Result of Hurricane Maria to Teach in New York State [P-12/HE (A) 1] - Your Committees recommend that Section 80-5.26 of the Regulations of the Commissioner of Education be added, as submitted, effective October 17, 2017, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to immediately certify teachers in New York State who were affected and displaced by Hurricane Maria for a temporary period of time.

MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your P-12 Education and Higher Education Committees recommend, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on October 17, 2017, copies of which have been distributed to each Regent.

MATTERS NOT REQUIRING BOARD ACTION

Students Displaced by Recent Hurricanes [P-12/HE (D) 1] – the Committees were updated on the guidance document that was sent to schools and districts on October 12, 2017, providing information on how to enroll and serve students displaced to New York State by recent hurricanes. Discussion focused on the McKinney-Vento Act which protects students who are temporarily displaced due to disaster. Under McKinney-Vento, students in temporary housing can enroll immediately in a school in the district where they are temporarily living even if they don't have the documents normally needed for enrollment and even if they have missed application or enrollment deadlines during any period of homelessness. The Committee also discussed implications for Students with Disabilities and English language learners/Multilingual learners.

P-12 EDUCATION/PROFESSIONAL PRACTICE JOINT MEETING

Your P-12 Education and Professional Practice Committees held a joint meeting on October 16, 2017. All members were present, except for Regent Finn, who was excused.

MATTERS NOT REQUIRING BOARD ACTION

Sepsis Prevention and Access to Vision Health Care [P-12/PPC (D) 1] – the Committees were updated on the Department's efforts to raise awareness of sepsis prevention. The Department collaborated with Assemblymember Catherine Nolan, who

has introduced sepsis awareness legislation, as well as the Rory Staunton Foundation for Sepsis Awareness, to provide sample curricula and resources on a dedicated webpage for schools to use to educate students on sepsis. The Staunton's started the Foundation after their son Rory died from sepsis as a result of a cut from a fall in the gym at his school. Sepsis is preventable and treatable so it is vital that students and schools learn how it can be prevented and its symptoms so that immediate medical treatment can be sought. The Department will continue to work with the Rory Staunton Foundation for Sepsis Awareness to provide schools with appropriate materials that help students learn about ways to prevent and treat sepsis.

The Committees were also updated on the importance of providing access to vision health care. The New York State Legislature has proclaimed October as School Vision Health month. The Department has worked with eye health professional associations to provide resources and emphasize the importance of eye health and safety. The Department has also collaborated with professional associations to coordinate the provision of complete eye examinations and glasses in some schools during October. Staff will gather data from the 2017 Vision Health month initiative and continue to promote vision health throughout the year.

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on October 16, 2017. All members were present, except Regent Josephine Victoria Finn, who was excused. Chancellor Betty A. Rosa was also present, but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 3 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 35 consent order applications and 29 surrender applications be granted, with five members of the committee voting acceptance of the consent application in the case of Michael Francis Verno, a/k/a Michael Francis Verno Jr., Licensed Master Social Worker, Cal. No. 29657, and with Regent Wade S. Norwood abstaining.

In the case of Joseph Appiah-Forson, Dentist, Cal. No. 29773, we recommend that the determination rendered in this matter on September 12, 2017, the Vote and Order issued in this matter on September 12, 2017, and the Application For Consent Order submitted in this matter all be deemed corrected to show, wherever the Calendar Number for this matter is reflected, the correct calendar Number of 29773, and not 29733, and that the

determination rendered and Vote and Order issued in this matter each be ratified in all other respects and, as corrected, remain in full force and effect.

These recommendations are made following the review of 67 cases involving eighteen licensed practical nurses, sixteen registered professional nurses, six licensed practical nurses who are also registered professional nurses, four dentists, three pharmacists, two pharmacies, one architect, one architect professional corporation, one certified dietitian (nutritionist), one certified public accountant, one chiropractor, one dental hygienist, one licensed master social worker, one mental health counselor, one occupational therapist, one physical therapist assistant who is also a physical therapist, and one professional engineer.

Restorations

That, upon taking and passing the Pharmacist Assessment for Remediation Examination (PARE) and the Multistate Pharmacy Jurisprudence Examination (MPJE), the revocation of Henry Magiet's license to practice as a pharmacist in the State of New York be stayed; that he be placed on probation for a period of two years, and that, upon successful completion of probation, his license be fully restored. Regulations: Mandatory Quality Review Program in Public Accountancy [PPC (A) 1]
– Your Committee recommends the following: That paragraph (6) of subdivision (b) of section 70.10 of the Regulations of the Commissioner of Education be amended, as submitted, effective October 17, 2017, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare to ensure that the mandatory quality review program can continue to function by giving the Department the authority to approve a sponsoring organization or sponsoring organizations, located either in or outside of this State, to oversee and facilitate quality reviews performed by a reviewer as mandated by statute.
