P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on December 16, 2013. All members were present, except for Regent Cashin, who was excused.

VOTED: That the Board of Regents finds that the Evergreen Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the **Evergreen Charter School**, and that its provisional charter be extended for a term up through and including June 30, 2014.

<u>Diagnostic Tool for School and District Effectiveness (DTSDE) Panel</u> – The Committee participated in a panel discussion with educators from around the state to talk about the implementation of the Diagnostic Tool for School and District Effectiveness in their districts. Panel members included:

- Ed Forgit, Deputy Superintendent, Newburgh Enlarged City School District

Panel members shared examples of what they've learned about the strengths and areas for improvement of their schools and district as a result of participating in DTSDE. P-12 EDUCATION/HIGHER EDUCATION JOINT MEETING AND HIGHER EDUCATION

Your P-12 Education Committee and Higher Education Committee held a joint meeting on December 17, 2013

Item not requiring action:

Overview of Teacher Certification Standard Setting.

Your Committees received an update on the implementation of new, more rigorous certification assessments. Staff described the standard setting process for the Educating All Students Test, the Academic Literacy Skills Test, and the School Building Leader assessment. Staff also discussed the charge of the NYS educator panels. (See Attachment I)

Bramson Ort College – Renewal of Accreditation.

Your Committee recommends that the Board of Regents take the following accreditation action regarding Bramson ORT College: Probationary accreditation for a period of two (2) years, including distance education, with quarterly progress reports submitted to the State Education Department and a return peer review visit after one (1) year demonstrating significant steps to remedy the findings of non-compliance and ensuring that all standards for accreditation are satisfied within the two (2) year probationary period.

Other matters not requiring action:

Career and Technical Education and Transitional Regulatory Options.

During the November 2013 Board meeting, there was a joint meeting of the P-12, Higher Education and ACCES Committees during which the Department reviewed issues around the demand for certified career and technical education teachers. Department staff are proposing the following recommended changes to the pathway for CTE teachers. 1) Expand the use of a Transitional A certificate to the Technical Subjects (Mechanical Technology 7-12, Electrical-Electronic Technology 7-12 and Computer Technology 7-12,) and the Family and Consumer Science CTE subjects (Food and Nutrition, Textile and Design, Human Services and Family studies). The requirement for the Transitional A would be an associate's degree, two years of satisfactory experience in the CTE area, workshops and fingerprint clearance, and 2) Allow for two years of postsecondary satisfactory teaching experience as a professor in the CTE certificate area to be taught in place of two years of experience in the CTE area. It is anticipated that the proposed amendment will come before the full Board for adoption as a permanent rule at the March 2014 Regents meeting. If adopted at the March Regents meeting, the proposed amendment will become effective on March 26, 2014.

EdTPA.

<u>Proposed amendment of section 100.7 of the Regulations of the Commissioner, relating</u> to the transition to the new High School Equivalency Test – Your Committees recommend that paragraph (2) of subdivision (a) of section 100.7 of the Regulations of the Commissioner of Education be amended, as submitted, as an emergency action effective January 1, 2014, upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to timely provide candidates for a high school equivalency diploma with the ability to use their passing scores on up to four sub-tests on examination(s) taken in calendar years 2002 through 2013 for the English version of the examination (and 2003 through 2013 for the Spanish version) as passing scores on the corresponding sub-tests of the new examination prescribed for the program and administered on or after January 1, 2014 and before January 1, 2016.

The Regents Committee on Audits/Budget and Finance met as scheduled yesterday afternoon, December 16, 2013. The Chancellor, Regents Chapey, Dawson, Bendit, Phillips, Tallon, Tilles, and Brown were in attendance.

Items for Discussion

Completed Audits

The Committee was presented with thirteen audits this month. All of the audits were issued by the Office of the State Comptroller (OSC). Six of the audits were of school districts, three of charter schools, one was of a State Education Department function and three were of colleges.

The findings were in the areas of procurement, financial reporting, budgeting, payroll, capital assets, claims processing, cash, and tuition assistance program.

Tuition Assistance Program

The Committee was also briefed on the Tuition Assistance Program and the role of the Department in administering the program and implementing corrective actions related to OSC audits. The New York State Tuition Assistance Program (TAP) helps eligible New York residents pay tuition at approved schools in New York State. TAP is the largest of the student grant and scholarship programs administered by the Higher Education Services Corporation. Specifics on eligibility for students and programs of study are prescribed in the Regulations of the Commissioner of Education.

2013 Fiscal Report

Our Chief Financial Officer briefed the Members on the Fiscal Report for November. Extensive spending controls continue for all funds. General Fund spending reflects the amounts appropriated in the 2013-14 enacted budget. General Fund accounts are in structural balance with the exception of the Tenured Teacher Hearings (TTH) account.

The 2013-14 budget includes a \$6 million appropriation for TTH claims, an increase of \$2.2 million from the prior year. With these additional funds, the deficit at the end of 2013-14 is projected to be \$2.03 million. Special Revenue accounts are all in structural balance on a current year basis and the accumulated negative balance in the Cultural Education Account is being reduced by approximately \$2.2 million.

CULTURAL EDUCATION

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report. Your Committee on Cultural Education Committee had its scheduled meeting on December 2013. In attendance were committee members: Regents Tilles, Dawson, Bendit, Rosa Cea, Jackson Cottrell, and Brown. Absent: None.

In addition to CE Committee Members, in attendance were: Chancellor Tisch; Vice Chancellor Bottar; Regents Chapey, Tallon, and Norwood and Executive Deputy Commissioner Berlin.

ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting.

Appointments to Regents Advisory Council on Libraries

Assistant Commissioner and State Librarian Bernard Margolis stated that two members of the Regents Advisory Council on Libraries have completed their terms. He recommended that the Board of Regents approve Claudia Depkin and Colleen Sadowski as new members of the Committee.

Regent Dawson made a motion to approve the nomination of Claudia Depkin and Colleen Sadowski to the Advisory Council on Libraries.

Regent Cea seconded the motion.

The motion passed unanimously.

Update on the Public Library Construction Program

Since 2006, the enacted budget has included an appropriation of \$14 million in capital funds for public library construction. Bernard Margolis, Assistant Commissioner and State Librarian, presented to the committee a comprehensive update on the Public Library Construction Program that included current status, needs and accomplishments of this program. Mr. Margolis reported that in 2012 there were 115 million visits to public libraries in New York State. Eight million people participated in 400,000 programs offered at public libraries.

The committee recommended that the board seek a ten percent increase in the \$14 million appropriation for public library construction.

Report on Statewide Partnership Activities for OCE Programs One of OCE's strategic priorities is to strengthen partnerships with USNY organizations statewide. Deputy Commissioner Jeffrey Cannell provided a report on examples of current collaborations with organization and institutions statewide.

The committee discussed the need to develop and move forward a legislative initiative that supports the programs of cultural institutions statewide. The committee discussed briefly the Cultural and Museum Education Act as a possible initiative that will be advanced in the coming year.

ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES)

Your ACCES Committee held its scheduled meeting on December 16, 2013.

MATTERS NOT REQUIRING BOARD ACTION

Core Rehabilitation Services Contracts – The Committee was provided an update on the new ACCES vocational rehabilitation service contracts. These contracts will provide a wide array of vocational rehabilitation services to nearly 80,000 individuals with disabilities each year. These services where previously purchased through two separate contracts, one for supported employment services and another for all other specialized vocational rehabilitation services. The new Core Rehabilitation Services (CRS) contracts will combine all of these vocational rehabilitation services into one set of contracts.

Creation of an Advisory Council on Access to Higher Education for Students with Disabilities – The Committee was provided an updated on proposed steps to be taken to create an Advisory Council on Higher Education for Students with Disabilities. The advisory council will be created to provide critical thinking and feedback to SED on the issues impacting students' access to, support during, and the successful completion of a higher education degree. This is in response to the need to improve access to and improve graduation outcomes from higher education institutions for students with disabilities.

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on December 16, 2013. All Committee members were present. Regent James C. Dawson was present for Executive Session, but did not vote on any case or action. Regent James R. Tallon, Jr. was present for Public Session, but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 28 consent order applications and 5 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Jason Anthony Earley, Massage Therapist, Calendar No. 26567, we recommend that, to clarify the manner in which respondent's fine is to be paid, respondent's \$300 fine shall be paid by respondent by certified or bank cashier's check, payable to the order of the New York State Education Department, to be delivered to the Director, Office of Professional Discipline, New York State Education Department, 1411 Broadway - Tenth Floor – New York, New York 10018-3496, within six months after the effective date of the service of the order to be issued in this matter; and that the penalty recommended by the Regents Review Committee otherwise be accepted.

These recommendations are made following the review of 37 cases involving eight licensed practical nurses, six registered professional nurses, four licensed practical nurses who are also registered professional nurses, three massage therapists, one certified public accountant, one chiropractor, one dentist, one land surveyor, one licensed clinical social worker, one licensed master social worker, one pharmacist, one podiatrist, one respiratory therapist who is also a respiratory therapy technician, one veterinarian, and one veterinary medicine professional corporation.

Restorations

Your Committee recommends the following:

That the application of Thomas Butti for the restoration of his license to practice as a chiropractor in the State of New York be denied. [PPC EXS (A) 4]

That, after he has passed the North American Pharmacist Licensure Examination (NAPLEX) and the Multistate Pharmacy Jurisprudence Exam (MPJE) and has so notified the Director, Office of Professional Discipline (OPD), and said Director determines that he has satisfactorily met such conditions, the surrender of the license of William J. Rhodes to practice as a pharmacist in the State of New York be stayed; that he then be placed on probation for a period of three years under the Terms of Probation annexed to the Report of the Committee on the Professions as Exhibit A; and that, upon successful completion of probation, his license be fully restored. [PPC EXS (A) 5]

Background Information

- In 2009, the Board of Regents approved a number of initiatives to transform teaching and learning and school leadership in New York State. One of those initiatives was to strengthen the examinations for the certification of teachers and school leaders
- Certification examination changes were included in NYS's successful Race to the Top application in 2010
- These changes were communicated to schools of education in 2010
- In April 2012, the Office of Higher Education announced the creation of a set of agreements with SUNY, CUNY and the Commission on Independent Colleges and Universities ("clcu")

The Future Teacher in New York:

- Will provide instruction that reflects the shifts required by New York State's adoption of the Common Core State Standards
- Will possess the reading and writing skills necessary to promote academic literacy in all content areas
- Will use instructional data systems to measure student success and inform improved teaching practice
- Will use knowledge of the diversity of student learners to provide an effective education to all students
- Will effectively prepare students to be college and career ready (i.e. prepared for success in college and the workplace)

Cut Scores – ALST and EAS

- The committees were tasked with setting two cuts:
 - Level I- the minimum level of skills a teacher needs in order to be competent in the classroom and positively contribute to student learning.
 - Level II- mastery of the skills necessary for effective teaching.

Cut Scores – SBL

- The committees were tasked with setting two cuts for Part I & Part II of the Exam:
 - Level 1- <u>minimum level</u> of knowledge, skills, and abilities a school building leader needs in order to be a competent educational leader and positively contribute to student learning.
 - Level 2- <u>mastery of</u> the knowledge, skills, and abilities a school building leader needs in order to be an effective educational leader and positively contribute to student learning.

Overview of Process

- 1) Panelists were presented with NYS definitions of two Levels of Performance, as well as policy context and exam background information
- 2) Panelists engaged in a simulated test taking experience to familiarize themselves with the exam format and item content
- 3) Panelists made item level judgments for a Level I cut score
- 4) Panelists discussed the results of the first round of item level judgments and were presented with operational performance data to inform their decisions

Overview of Process

- 5) Panelists completed a second round of item level judgments for the Level I cut score
- 6) Panelists were presented with impact data from the operational administration
- 7) Panelists then discussed their initial recommendations in light of the potential impact
- 8) Panelists made a final test level recommendation for the Level I cut score

Overview of Process

- 9a) Panelists repeated steps 4-8 for the Level II cut score for ALST & EAS
 - b) For School Building Leader, panelists repeated the full process to recommend Level I and Level II cut scores for both Part I and Part II of the SBL exam
- 10) Cut scores recommended by panelists were presented to the Commissioner and Board of Regents for approval
- 11) Cut scores will be released to the field by NYSED and posted on the NYSTCE website and the Office of Higher Education website
