SUMMARY

Issue for Decision

Should the Regents approve the proposed renewal charters for thirteen charter schools authorized by the Chancellor of the New York City Department of Education (NYCDOE)?

Reason(s) for Consideration

Required by State Statute.

Proposed Handling

This issue will come before the Regents P-12 Education Committee and the full Board for action at the January 2015 Regents meeting.

Procedural History

The Chancellor of the NYCDOE approved these thirteen renewal charters and submitted them to the Regents for approval and issuance of the renewal charters as required by Article 56 of the Education Law, The New York State Charter School Statute.

Background Information

I am advancing the proposed renewal charters for the following charter schools as proposed by the Chancellor of the New York City Department of Education (NYCDOE) in her capacity as a charter school authorizer under Article 56 of the Education Law, and that the charters be extended for the terms indicated.

Pursuant to Education Law § 2852 the Regents have the authority to issue charters to all charter schools in NYS. The process for DOE-authorized charter schools is as follows:

- The Chancellor for the DOE recommends that the Regents issue a charter renewal or a revision of an existing charter.
- The recommendation is sent to the Department and the Regents have 90 days to act or the recommendation goes into effect by OOL.
- Once a charter is received by the Department, the Regents have four options:
 - 1. Consider the recommendation and vote on it. If the vote is affirmative, the action is effective immediately.
 - 2. If the vote is negative, the Regents send the negative recommendation back to DOE with comments. The DOE's recommendation to renew a charter or revise an existing charter school must be reconsidered by DOE and resubmitted as a new recommendation to be considered by the Regents at a later date. The 90-day clock is reset for this recommendation and will begin anew with a new recommendation.
 - 3. The Regents can defer action to a later date. The 90-day time period continues to accrue.
 - 4. The Regents can choose to not take action on a DOE recommendation and allow the charter renewal or revision to an existing charter to go into effect by operation of law (OOL) 90 days after the initial submission to the Department.

In the 2014-2015 academic year, the Schools Chancellor of the New York City Department of Education (NYCDOE) has and will consider renewal applications from 38 public charter schools authorized by the NYCDOE. The below comprises the Chancellor's recommendation for fifteen of these schools at this time for consideration at the January 2015 Board of Regents meeting.

The Chancellor recommends that the following schools be granted a short term renewal of one and one half years, with the term expiring June 30, 2016:

- 1. Imagine Me Leadership Charter School, NYC Community School District 19
 - The school currently serves 227 students in grades K-5 and is currently authorized to serve students in grades K-5. The NYCDOE recommends the school continue to serve students in grades K-5 with an authorized enrollment of 264 students.
- 2. Lefferts Gardens Charter School, NYC Community School District 31
 - The school currently serves 454 students in grades K-5 and is currently authorized to serve students in grades K-5. The NYCDOE recommends the school continue to serve students in grades K-5 with an authorized enrollment of 450 students.
- 3. Dr. Richard Izquierdo Health and Science Charter School, NYC Community School District 12
 - O The school currently serves 517 students in grades 6-10, is currently authorized to serve 500 students in grades 6-12 (at scale), and has requested to expand to continue its phase-in to serve students in grades 6-12 at scale and increase enrollment. The NYCDOE recommends the school continue to phase-in to serve authorized grades 6-12 with an increased enrollment of 721 students.

The Chancellor recommends that the following schools be granted a short term renewal of two and one half years, with the term expiring June 30, 2017:

- 4. Rochdale Early Advantage Charter School, NYC Community School District 28
 - The school currently serves 238 students in grades K-5, is currently authorized to serve 244 students in grades K-5, and has requested both to expand to serve middle school grades (6-8) and increase enrollment. The NYCDOE recommends only an increase of enrollment to 420 students in grades K-5.



The Chancellor recommends that the following schools be granted a short term renewal of three and one half years, with the term expiring June 30, 2018:

- 5. Inwood Academy for Leadership Charter School, NYC Community School District 6
 - The school currently serves 586 students in grades 5-9, is currently authorized to serve 500 students in grades 5-9, and has requested both to continue to expand to serve grades 5-12 and increase enrollment. The NYCDOE recommends the school continue to phase-in with increased enrollment serving a total of 1,020 students in grades 5-12.
- 6. Bedford Stuyvesant New Beginnings Charter School, NYC Community School District 16
 - The school currently serves 532 students in grades K-7, is currently authorized to serve 489 students in grades K-8, and has requested to continue to phase-in to serve students in grades K-8 at scale and increase enrollment. The NYCDOE recommends the school continue to phase-in to serve authorized grades K-8 with an increased enrollment of 729 students.
- 7. Hyde Leadership Charter School Brooklyn, NYC Community School District 19
 - The school currently serves 392 students in grades K-5, is currently authorized to serve students in grades K-12 (at scale), and has requested to continue to phase-in to serve students in grades K-12 at scale. The NYCDOE recommends the school continue to serve students in grades K-5 only, with an authorized enrollment of 396 students.
- 8. Renaissance Charter High School for Innovation, NYC Community School District 4
 - The school currently serves 447 students in grades 9-12 and is currently authorized to serve students in grades 9-12. The NYCDOE recommends the school continue to serve students in grades 9-12 with an authorized enrollment of 500 students
- 9. Bushwick Ascend Charter School, NYC Community School District 32
 - The school currently serves 644 students in grades K-5, is currently authorized to serve 642 students in grades K-12 (at scale), and has requested to continue to phase-in to serve students in grades K-12 at scale. The NYCDOE recommends the school continue to phase-in to serve authorized grades K-12, with an expectation the school will serve students in grades K-8 in next charter term, with an authorized enrollment of 975 students.

The Chancellor recommends that the following schools be granted a full term renewal of four and one half years, with the term expiring June 30, 2019:

- 10. Riverton Street Charter School, NYC Community School District 29
 - The school currently serves 749 students in grades K-7, is currently authorized to serve students in grades K-8, and has requested to continue to phase-in to serve students in grades K-8 at scale. The NYCDOE recommends the school continue to phase-in to serve authorized grades K-8 with an authorized enrollment of 990 students.
- 11. Hellenic Classical Charter School, NYC Community School District 15
 - The school currently serves 476 students in grades K-8 and is currently authorized to serve 450 students in grades K-8, and has requested an increase in enrollment for current grades served. The NYCDOE recommends the school continue to serve students in grades K-8 with an increase authorized enrollment of 480 students.
- 12. **Democracy Prep Harlem Charter School**, NYC Community School Districts 3 and 5
 - The school currently serves 780 students in grades K-1 and 6-10 and is authorized to serve students in grades K-12 (at scale). The NYCDOE recommends the school continue to phase-in to serve students in grades K-12 with an authorized enrollment of 1147 students.
- 13. Challenge Preparatory Charter School, NYC Community School District 27
 - The school currently serves 503 students in grades K-5, is currently authorized to serve 504 students in grades K-8 (at scale), and has requested to continue to phase-in to serve students in grades K-8 at scale. The NYCDOE recommends the school continue to phase-in to serve authorized grades K-8 with an authorized enrollment of 792 students.

Re: Charter Renewal Recommendations

Commissioner Berlin,

On behalf of the New York City Department of Education (NYC DOE) as a charter authorizing entity, I respectfully request that you consider the charter renewal recommendations submitted on January 8, 2015. For our schools to succeed, we need to hold them to high-standards. We closely track every school's progress – be they charter or district - and we will hold these schools accountable for demonstrating progress. It's critical that we do whatever it takes to ensure that all our schools are doing their duty of providing a great education to the children of New York City.

The DOE has set the expectation for the schools recommended for 1.5 year short-term renewal. The DOE has set the expectation for the schools recommended for a 1.5 year renewal by mandating goals outlined in the charter agreements. Schools that do not, at a minimum, meet the following academic goals will not be considered for further renewal at the end of the next charter term.

- For each year of the school's next charter term, the school will show academic performance with a percent of students proficient at or above Level 3 that meets or exceeds the percent proficient of the Community School District (CSD) of location and also meets or exceeds the citywide percent proficient on the New York State ELA examination.
- For each year of the school's next charter term, the school will show academic performance with a percent of students proficient at or above Level 3 that meets or exceeds the percent proficient of the Community School District (CSD) of location and also meets or exceeds the citywide percent proficient on the New York State math examination.
- Each year, at least 75 percent of students in the high school accountability cohort passing an English Regents exam will have a score of 75 or above by the end of their fourth year.
- Each year, at least 75 percent of students in the high school accountability cohort passing a math Regents exam will have a score of 75 or above by the end of their fourth year.
