ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES)

Your Adult Career and Continuing Education Services (ACCES) Committee held a meeting on November 16, 2021. All members were present, except for Regent Tilles, who was excused.

MATTERS NOT REQUIRING BOARD ACTION

Inclusive from the Start: The Universal Design for Learning Framework – The Committee was provided with a presentation by Dr. Christopher Hromalik, from Onondaga Community College, on learner variability, Universal Design, and Universal Design for Learning (UDL). Dr. Hromalik shared information about the Universal Design for Learning framework and how it can mitigate barriers to successful learning. He also shared examples of UDL in higher education and information about UDL professional development.

2022-2023 Non-State Aid Budget and Legislative Priorities – The Committee was provided with an update on the 2022-23 potential Non-State Aid budget and legislative priorities for ACCES. The proposed priorities include: Enhancing Supports and Services for Postsecondary Success of Students with Disabilities; and Funding the Expansion of the Readers Aid Program.

CULTURAL EDUCATION

Your Committee on Cultural Education had its scheduled meeting on November 15, 2021. Regent Roger Tilles and Regent Frances Wills, Co-Chairs of the Cultural Education Committee, submitted the following written report. All members were present. Chancellor Young, Regent Norwood, Regent Cashin, Regent Ouderkirk, Regent Mittler, and Regent Ferrer were also in attendance.

ITEMS FOR DISCUSSION

Co-Chairs Regent Tilles and Regent Wills welcomed everyone.

Deputy Commissioner's Report (Discussion)

Deputy Commissioner Mark Schaming provided an update on the Office of Cultural Education's programs and services including:

- "Courage: The Black New York Struggle for Quality Education" from the Schomburg Center for Research in Black Culture is now open at the New York State Museum. This exhibition was donated by the Adelaide L. Sanford Institute in honor of Vice-Chancellor Emerita of the NY State Board of Regents Dr. Adelaide L. Sanford;
- An update on the State Museum's gallery renewal project;
- State Library has opened the online portal for applications for \$5 million in ARPA funding;
- The Talking Book and Braille Library is promoting programs to allow school professionals to be able to certify students with visual disabilities to be participants in the program; and
- The New York State Archives Magazine Speaker Series virtual programs are held regularly with recording available on the Archives' YouTube channel.

Non-State Aid Budget and Legislative Initiatives (Discussion)

Phyllis Morris, Chief Financial Officer and Jennifer Trowbridge, Director of the Office of Governmental Relations discussed the Cultural Education non-state aid budget and legislative initiatives including requesting a \$11 million increase to Library Construction Aid funding for a total of \$45 million for 2022-2023 and requesting a \$2 million appropriation for the New York State Summer School of the Arts so the program continues to be available for talented New York students.

Update from New York State Historian (Discussion)

State Historian Devin Lander provided an update on the Office of State History's work to provide coordination and leadership of New York's history field including the Office of State History website, the New York History Journal, A New York Minute in History podcast, and the 250th anniversary of the American Revolution commemorations.

Proposed Amendment of Section 185.15 of the Regulations of the Commissioner of Education Relating to Records Retention and Disposition Schedule LGS-1 (Discussion)

Tom Ruller, Assistant Commissioner of Archives, presented proposed amendments to the Commissioner's regulations records retention and disposition schedule LGS-1 relating to state assessments, license plate readers, health screening, cooperative extension records, technical corrections, and restoration of items inadvertently omitted from previous schedules. It is anticipated that the proposed amendment will be presented for adoption at the March 2022 Regents meeting, after publication of the proposed amendment in the State Register and 60-day public comment period.

Your Higher Education Committee held its scheduled meeting on November 15, 2021. All members of the Committee were present.

MOTION FOR ACTION BY FULL BOARD

Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on November 15, 2021, copies of which have been distributed to each member of the Board of Regents.

MATTERS NOT REQUIRING BOARD ACTION

Non-State Aid Budget and Legislative Initiatives - Department staff presented for discussion and further refinement the Higher Education non-state aid budget and proposed legislative initiatives.

Amendment to Section 80-1.1 of the Regulations of the Commissioner of Education Relating to the Definition of a Year of Experience for Permanent or Professional Certification - Department staff presented a revised amendment to the definition of a “year of experience” that will be acceptable for the Permanent and Professional certificates to provide for greater flexibility in calculating a year of experience, permitting a variety of part-time experiences that could be equivalent to full-time experience in a 12-month period.

Consent Agenda Items:

Regents Authorization for State University of New York, Empire State College - The Board of Regents voted to authorize SUNY Empire State College to award the Bachelor of Business Administration (B.B.A.) Degree to students successfully completing the registered business program.

P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on November 15, 2021. All members were present.

ACTION ITEMS

Initial Applications Authorized by the Board of Regents [P-12 (A) 1]

Your Committee recommends that the Board of Regents find that: (1) the proposed charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the application will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues a charter and provisional charter to Innova Girls Academy Charter School, for a term of five years in accordance with §2851(2)(p) of the Education Law.

The motion passed. Regent Cashin, Regent Ouderkirk, and Regent Tilles opposed. Regent Mead was absent for the vote.

Proposed Amendment to Section 125.1(d) of the Regulations of the Commissioner of Education Relating to Annual Visits to Voluntarily Registered Nursery Schools and Kindergartens [P-12 (A) 2]

Your Committee recommends that section 125.1(d) of the Regulations of the Commissioner of Education be amended, as submitted, effective November 16, 2021 as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare and public health to continue to provide flexibility for the annual visitation of voluntarily registered nursery schools and kindergartens during the 2021-2022 school year due to the COVID-19 crisis.

The motion passed. There were no oppositions or abstentions. Regent Mead was absent for the vote.

Department staff updated the Board of Regents on the P-12 non-state aid budget and legislative initiatives.

Graduation Measures Update

Department staff discussed the updated schedule and plans for the Graduation Measures Regional Meetings taking place December 2021 through the beginning of February 2022.

2021 3-8 ELA/Math Preliminary Results Presentation

Department staff presented a high-level overview of the publicly released SY 2020-2021 3-8 ELA and Math state assessment participation and outcome data.

Substantial Equivalence Update

Department staff reviewed the history of this work and provided an overview of next steps.

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to

you, be accepted in 1 case. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 34 consent order applications and 3 surrender applications be granted.

These recommendations are made following the review of 38 cases involving six licensed practical nurses, five licensed practical nurses who are also registered professional nurses, four registered professional nurses, two dentists, two licensed clinical social workers, two massage therapists, two pharmacists, one architect, one occupational therapy assistant, one pharmacy, one registered professional nurse who is also a nurse practitioner (Adult Health) and who is also a nurse practitioner (Psychiatry), one registered professional nurse who is also a nurse practitioner (Psychiatry), one speech-language pathologist, and one veterinarian.






