# SUMMARY

# **Issue for Discussion**

Should the Board of Regents approve adding a Doctor of Acupuncture and Oriental Medicine (D.A.O.M.) degree in New York?

# Reason(s) for Consideration

Review of policy.

# Proposed Handling

This item will come before the Professional Practice Committee at its March 2013 meeting for discussion. It is anticipated that it will be presented for action by the Committee and by the Full Board in May 2013.

## Procedural History

A Notice of Proposed Rule Making will be published in the State Register on March 20, 2013. Supporting materials for the proposed amendment are available upon request from the Secretary to the Board of Regents.

### **Background Information**

The D.A.O.M. degree is recognized by the Accreditation Commission for Acupuncture and Oriental Medicine (ACAOM) and is an authorized degree in California, Washington, and Oregon. One of the institutions of higher education in New York requested permission to offer the D.A.O.M. degree. Adding this degree will benefit students in New York by affording them the opportunity to earn a doctoral level degree in acupuncture and oriental medicine. It will also provide greater opportunities for the graduates to undertake research and become more competent practitioners. Ultimately, adding the D.A.O.M. degree in New York will help the public. Because the D.A.O.M. degree is a new degree in New York, it is necessary to amend sections 3.47 and 3.50 of the Rules of the Board of Regents related to requirements for earned degrees and registered degrees.

The proposed rule has been shared with the parties who have an interest in this topic. On December 5, 2012, a memo soliciting comments on the proposal to add the D.A.O.M. degree in New York was sent to the following interested parties: the faculty and administrators of acupuncture programs in New York; professional associations representing acupuncture; and members of the State Board for Acupuncture. The State Board for Acupuncture supports the authorization of this new degree title. We received four (4) comments about the proposed amendments. See Attachment B for a summary of the comments from the interested parties.

### Timetable for Implementation

It is anticipated that the proposed amendment will be adopted at the May 2013 Regents meeting. If adopted at the May 2013 Regents meeting, the proposed amendment will become effective on June 5, 2013. A master plan amendment authorizing the offering of a D.A.O.M. degree will also be presented to the Board of Regents for approval at the May 2013 meeting.

# ATTACHMENT A: AMENDMENT TO THE RULES OF THE BOARD OF REGENTS AMENDMENT TO THE RULES OF THE BOARD OF REGENTS

Pursuant to sections 207, 210, 218, 224, and 305 of the Education Law.

1. Paragraph (2) of subdivision (d) of section 3.47 of the Rules of the Board of Regents is amended, effective June 5, 2013, as follows:

(2). Professional degrees. Graduate professional degree programs must be comprised of advanced studies in professional or vocational fields. While they may have strong theoretical underpinnings, they must have as their primary purpose knowledge for application in professional practice. Master's degree programs of this type are primarily terminal in nature. They may serve as preparation for advanced studies at the doctoral level, but they shall not be designed primarily for this purpose. The doctorate in such studies is likewise practical, insofar as it prepares the student to train or supervise others in the field, to discover new knowledge that has practical application in the field, or to prepare the student for a life of practice in the student's particular profession. Only the following degrees may be conferred upon the completion of a professionally oriented graduate program:

#### ATTACHMENT B: SUMMARY OF COMMENTS ON

#### THE PROPOSED AMENDMENT TO THE RULES OF BOARD OF REGENTS

Since distributing a memo to interested parties on December 5, 2012, the State Education Department received comments about the proposed amendments relating to adding the Doctor of Acupuncture and Oriental Medicine (D.A.O.M.) degree. The following is a summary of the comments and the responses of the Education Department.

1. COMMENT: Some supported the proposal to add the Doctor of Acupuncture and Oriental Medicine degree to the list of registered degrees. However they also stated that the Master of Science in Acupuncture and Oriental Medicine degrees should also be added to the list of registered degrees.

DEPARTMENT RESPONSE: The Master of Science in Acupuncture and Master of Science in Acupuncture and Oriental Medicine are Master of Science degrees in the fields of Acupuncture and Acupuncture and Oriental Medicine. If implemented, they would not represent distinct new degrees/degree levels like the Doctor of Acupuncture and Oriental Medicine, and, as the Master of Science degree is already on the list of registered degrees, there is no immediate need to add these two degrees. The current Master of Science degree programs are currently recognized as first professional degree programs by the nationally recognized accrediting body for acupuncture – the Accreditation Commission for Acupuncture and Oriental Medicine (ACAOM), and as licensure-qualifying programs by the New York State Education Department.

2. COMMENT: It was suggested that the State Education Department should recognize those licensed to practice acupuncture on the basis of having a Chinese Bachelor's Degree in Traditional Chinese Medicine as being master's level practitioners in order to allow these practitioners to enter the doctoral program without completing a master's degree.

DEPARTMENT RESPONSE: Admissions decisions are made at the discretion of the academic program and institution. The Department does not feel it is appropriate to require a doctoral program to consider a foreign bachelor's degree to be the equivalent of a master's degree.

3. COMMENT: There was concern expressed that a post-licensure Doctor of Acupuncture and Oriental Medicine degree could mislead the public concerning the professional qualifications of its holder compared to licensed master's level practitioners. It was proposed that the degree name be changed to a Doctor of Professional Studies in Acupuncture and Oriental Medicine.

DEPARTMENT RESPONSE: The Doctor of Acupuncture and Oriental Medicine degree is awarded in other states, and there are currently New York State licensed acupuncturists who hold the Doctor of Acupuncture and Oriental Medicine degree. The Doctor of Acupuncture and Oriental Medicine degree is a post-licensure professional credential that would not impact perception of master's level licensed practitioners. The accrediting body for acupuncture programs (ACAOM) has designated the D.A.O.M. degree as the recognized post-licensure degree and has created standards for accrediting such programs, separate and apart from the standards for the first professional Masters programs.
