STANDING COMMITTEE REPORTS

AUDITS/BUDGET AND FINANCE

The Regents Committee on Audits/Budget and Finance met as scheduled yesterday morning, April 22, 2013. Chancellor Tisch, Regents Bendit, Cea, Cottrell, Norwood, Phillips, Tallon, Tilles, and Young were in attendance.

Items for Discussion

March 2013 Fiscal Report

Our Chief Financial Officer briefed the Members. General Fund accounts are in structural balance with the exception of the Tenured Teacher Hearings (TTH) account. Although fiscal and programmatic TTH reforms were included in the enacted state budget, there continues to be a deficit of an estimated \$9 million in unpaid bills due to chronic under funding of this program. Revenue accounts are all in structural balance on a current year basis and the accumulated negative balance in the Cultural Education

Account is being reduced by approximately \$2,800,000, due primarily to an increase in revenue this year.

The members were also briefed on the impact of the 2013-14 Executive Budget on SED operations. The budget contains continued funding to support the baseline Regents exam program, and provides some additional funding for the High School Equivalency program, Teacher Tenured Hearings, and certain Library programs. All other State Operations and Special Revenue Account support is at last years level. In addition, the approved FTE staffing level remains at 2,765.

Completed Audits

The Committee was presented with eleven audits this month. Ten of the audits were issued by the Office of the State Comptroller (OSC) and one by the New York City Comptroller. Seven of the audits were of school districts, one was of a charter school, one was a provider of special education services, one examined a reporting process within the New York City Department of Education, and one was of Credit Recovery Program throughout the State. The Board of Regents requested OSC in October 2011 to conduct this particular audit.

The findings were in the areas of financial reporting, information technology, segregation of duties, budgeting, student transportation, credit recovery and accuracy of certain student data. The Committee was briefed in more detail on the audit of the Credit Recovery Program in school districts.

CULTURAL EDUCATION

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report. Your Committee on Cultural Education Committee had its scheduled meeting on April 22, 2013.

In attendance were committee members: Regents Tilles, Dawson, Rosa Cea, Jackson, and Cottrell. Absent: Regents Bendit and Brown.

In addition to CE Committee Members, in attendance were: Chancellor Tisch, Regents Tallon, Phillips, Chapey, Norwood and Cashin as well as Commissioner King, Executive Deputy Commissioner Berlin and Deputy Commissioners Smith and Slentz.

ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting.

Libraries and the Common Core

Deputy Commissioner Jeffrey Cannell introduced Liz Hood, Director of Educational Television/Public Broadcasting. Ms. Hood announced the two day conference,

Uncommon Approaches to the Common Core, — a conference for librarians, museum administrators and educators, public media managers, and archives professionals scheduled for August 13–14, 2013 at the Cultural Educational Center in Albany. The two-day conference is hosted by P-12 and OCE and will provide professionals from cultural institutions an introduction to the Common Core Learning Standards and how the new standards will bring changes to instructional practice. The goal of the conference is to provide professionals from cultural institutions with guidance about how they can support teachers, students and families in this environment; and discover how participants and their institutions are vital partners in Common Core implementation. To illustrate the benefits of the partnerships, a school librarian and eighth-grade teacher from Voorheesville Middle School addressed the committee and provided an example of how they work collaboratively to implement aspects of the Common Core Learning Standards. The presenters were:

- J'aime Pfeiffer, School Library System Director, Capital Region BOCES
- Christina Menetti, Librarian, Voorheesville Middle School
- Jacqueline Rapant, ELA teacher, Voorheesville Middle School

Statewide Summer Reading Program

Bernard Margolis, State Librarian and Assistant Commissioner for Libraries presented on the Summer Reading program offered each year by the New York State Library – launching the annual statewide program at New York Libraries. This year there will be "virtual" launches which will be primarily on-line announcements based at several sites across the state. Margolis invited members of the Board of Regents to participate in launches at library locations in their districts. He distributed a list of venues and dates of the launches and encouraged members to contact him if they wished to participate in the launch events. The Statewide Summer Reading Program is the second most heavily used program of the State Library with nearly 1.8 million students participating.

Additional Update on NOVELny

Mr. Margolis gave a brief update on NOVELny, which had nearly 56 million searches on it last year. The CE Committee received a report about this program at the March 2013 meeting. The process of selection and procurement of the actual databases for next year (beginning July 1, 2013) is moving to completion. Margolis distributed the list of the types of databases that will be included in NOVELny this year.

Update on OCE financial status

Tom Ruller, Director of Operations for the Office of Cultural Education, presented to the committee a brief report on additional sources of revenue for OCE programs, focusing revenue raised from rentals of the CEC facility.

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on April 22, 2013. All Committee Members were present, except for Vice-Chancellor Anthony S. Bottar, who

was excused. Chancellor Merryl H. Tisch and Regent James C. Dawson were also present, but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 5 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 32 consent order applications and 13 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Martin Nissenbaum, Certified Public Accountant, Calendar No. 26671, we recommend that, to clarify the caption in the report of the Regents Review Committee in this matter upon reconsideration, the word "is" be deemed deleted and the word "was" be deemed added and substituted therefor. [PPC EXS (A) 1 – Supplemental]

These recommendations are made following the review of 50 cases involving twelve licensed practical nurses, eleven registered professional nurses, seven licensed practical nurses who are also registered professional nurses, two architects, two certified public accountants, one acupuncturist, one licensed mental health counselor, one licensed psychoanalyst, one massage therapist, one occupational therapy assistant, one pharmacist, one physical therapist assistant, one professional engineer, and one veterinarian.

ACTION ITEMS

New York State Career Development and Occupational Studies Commencement Credential

Your Committees recommend that subparagraph (i) of paragraph (7) of subdivision (b) of section 100.5; section 100.6; and subparagraph (iii) of paragraph (5) of subdivision (a) of section 200.5 of the Regulations of the Commissioner be amended as submitted, effective April 23, 2013, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to immediately establish criteria for the issuance of a New York State Career Development and Occupational Studies Commencement Credential to ensure that programs leading to such Credential are timely implemented for the 2013-2014 school year pursuant to the regulation's requirements, and thereby ensure that students with disabilities have an exiting credential available to them when the IEP diploma sunsets as of June 30, 2013. MATTERS NOT REQUIRING BOARD ACTION

Transition Planning: Career Development and Occupational Studies (CDOS) and Vocational Rehabilitation (VR) – The Committees discussed proposed amendments to regulations on how the implementation of the CDOS standards can provide critical information in student preparation for transition to postsecondary programs and employment. The implementation of the Career Development and Occupational Studies Standards would ensure school districts are providing students with disabilities planned opportunities to explore, evaluate and be exposed to work-based learning and instruction that would effectively increase students' knowledge and understanding of their skills and interests. Career Development and Occupational Studies (CDOS) Learning Standards —The Career Development and Occupational Studies (CDOS) Learning Standards which provide the foundation for college and career readiness for all students, were the focus of this month's Committee discussion. The NYS CDOS Learning Standards work in concert with the Common Core State Standards and are a foundation for college and career readiness for all students. Additionally the CDOS Learning Standards, together with specific industry standards, are the recognized educational base for career and technical education programs that lead to a technical endorsement on the Regents diploma. Department staff will continue to provide guidance and technical assistance to school districts and BOCES to implement the Common Core State Standards as well as the CDOS Learning Standards. As schools align their courses and programs to the Common Core State Standards, CTE programs will be available as a valuable resource to improve student achievement and identify career pathways that will prepare students to be college and career ready. P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on April 22, 2013. All members were present, except for Vice Chancellor Anthony Bottar who was excused.

ACTION ITEMS

COMMUNITY Charter School

Your Committee recommends that the Board of Regents denies the renewal application for the COMMUNITY Charter School, that the board of trustees of the COMMUNITY Charter School be provided notice of this action and that its charter will terminate upon the expiration of its current charter term on June 30, 2013, and that the board of trustees of the COMMUNITY Charter School is directed to take all steps necessary to close the School in accordance with its charter and the School closure procedures of the Department and cease instruction as of June 30, 2013; including but not limited to the immediate provision of notice of this nonrenewal action to the parents of existing students of the Charter School, the parents of any students in the Charter School's most recent lottery and the parents of students on the Charter School's waiting list, provision for the orderly transfer of student records to the Buffalo City School District and disposition of the Charter School's assets. [P-12 (A) 1-Revised]

Believe Northside Charter High School

Your Committee recommends that the Board of Regents finds that the proposed revised charter: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for Northside Charter High School and amends the provisional charter accordingly. [P-12 (A) 2]

Enterprise Charter School

Your Committee recommends that, pursuant to §2852(5-a) of the Education Law, the Board of Regents returns the proposed third renewal charter of the Enterprise Charter School to the Board of Education of the City School District of the City of Buffalo for reconsideration with the following comments and recommendations: based upon the consistently weak student performance data for Enterprise Charter School, it is recommended that the Board of Education of the City School District of the City of Buffalo, abandon its request for a three-year renewal of the school's charter and submit a proposed renewal charter which, at most, spans one year (expiring on June 30, 2014), at which time the Buffalo BOE as the chartering entity for Enterprise, will assess the School's progress at meeting performance benchmarks established for the School by the Buffalo BOE and make a determination concerning renewal of the School's charter. NYCDOE Charter School Renewal: Mott Haven Academy Charter School

The NYCDOE Charter School Renewal for Mott Haven Academy Charter School was not acted on at the P-12 Education Committee meeting on April 22, 2013. NYCDOE will

send a revised recommendation to be presented to the Board of Regents at their full Board meeting on April 23, 2013.

NYCDOE Charter School Renewals

Your Committee recommends that the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the Bronx Global Learning Institute for Girls Charter School as proposed by the Chancellor of the New York City Department of Education, and that its provisional charter be extended for a term up through and including June 30, 2018.

Your Committee recommends that the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the South Bronx Charter School for International Cultures and the Arts as proposed by the Chancellor of the New York City Department of Education, and that its provisional charter be extended for a term up through and including June 30, 2018.

MATTERS NOT REQUIRING BOARD ACTION

Revised NYSESLAT and Aligned Identification Test for English Language Learners — The Committee was updated on the development and implementation of Bilingual Common Core State Standards. In March 2012, staff presented a comprehensive plan for revising the English Language Proficiency Standards including aligning the New York State English as a Second Language Achievement Test (NYSESLAT). Revisions were made to the NYSESLAT that will be administered in the 2012-13 and 2013-14

school years to begin the alignment of this test with the Common Core Learning Standards and to reflect feedback from the field on how to improve the assessment. In addition to changing the NYSESLAT, the Department is planning to administer a new identification test, titled the New York State Identification Test for English Language Learners (NYSITELL), to replace the Language Assessment Battery-Revised (LAB-R) as the approved means of initially identifying ELLs in New York State. Aligning the NYSESLAT and the NYSITELL provides educators with an initial identification test examination that will better enable educators to determine a student's level of English proficiency and subsequently provide the appropriate instruction. The Department expects to sunset the LAB-R and implement the NYSITELL exam during the 2013-14 school year. In order to complete the transition, the Department will later this year present a regulatory revision for consideration by the Board that formally changes in regulation the name of this test. [P-12 (D) 1]

Prior Written Notice and Parental Consent for the Use of Public or Private Benefits or Insurance – Effective March 18, 2013, an amendment to the federal regulations implementing Part B of the Individuals with Disabilities Education Act (IDEA) was enacted relating to parental consent to access public benefits or insurance (e.g., Medicaid). The Committee discussed proposed amendments that will conform the Regulations of the Commissioner of Education to be consistent with federal regulations Following a 45-day period of public comment and public hearings as required by IDEA, the proposed amendment will be submitted for action at the June 2013 meeting. [P-12 (D) 2]

Next Generation Science Standards - The Committee discussed the potential adoption of the Next Generation Science Standards (NGSS). The NGSS are based on the Framework for K-12 Science Education developed by the National Research Council. The Framework is an important research-based document that provides a foundation for 21st century K-12 science education. Through a multi-state collaborative process, the NGSS was developed to address science and engineering practices, concepts that cross multiple disciplines, and disciplinary core ideas. Department staff developed an evaluation tool to compare current New York State science learning standards and the NGSS to a set of rigorous, research-based criteria. The tool has been used in the ongoing feedback process by members of the Science Content Advisory Panel (SCAP), the New York State Science Education Consortium, and the Statewide Leadership Team (SLT) to analyze and compare both sets of standards against the criteria. In addition, a survey to gather public feedback has been devised based on this evaluation tool. The survey will be released upon publication of the full set of documentation for the NGSS expected near the end of April. Department staff will analyze feedback from the three select groups of stakeholders and the public survey and form a recommendation regarding the future of science education for the Board of Regents to consider in September. [P-12 (D) 3]

<u>Protection of People with Special Needs Act</u> – The Committee discussed the establishment of the new Justice Center for the Protection of People with Special Needs which becomes effective on June 30, 2013 and creates uniform safeguards for

vulnerable persons in facilities or provider agencies that are operated, certified, or licensed by State agencies to protect them against abuse, neglect and other conduct that may jeopardize their health, safety and welfare. Discussion focused on the implications for the Department and residential schools under the Department's oversight. At the June 2013 meeting of the Board of Regents, staff will recommend emergency action on regulations that will include incident management procedures that comply with the requirements of the Chapter 501 and guidelines and standards developed by the Justice Center. [P-12 (D) 5]

P-12 EDUCATION/HIGHER EDUCATION JOINT MEETING

Your P-12 Education Committee and Higher Education Committee held a joint meeting on April 22, 2013. All members were present, except for Vice Chancellor Bottar who was excused.

MATTERS NOT REQUIRING BOARD ACTION

State-Provided Growth Measures in APPR - The Committee discussed a progress report developed by the Department relating to its continuing work to implement Stateprovided measures of student growth for use in Annual Professional Performance Reviews (APPRs) in 2012-13. This report will include a proposed value-added model for use in APPRs for the 2012-13 school year and thereafter for classroom teachers in grades 4-8 ELA and math and their principals, and high school principals. Discussion focused on proposed changes to the student growth measures for 2012-13 which include modifying how students are attributed to teachers in grades 4-8 ELA/Math; adoption of two High School Principal student growth measures; and adoption of "valueadded" measures which will count for 25 points, instead of 20 points, for 4-8 ELA and Math and High School Principals. Department staff will seek comment and input from the field and will respond to implementation questions and concerns raised by Committee members. Staff will present a proposal to the Board of Regents at the June Regents meeting for approval of the use of a value-added model for evaluations conducted for the 2012-13 school year and thereafter for classroom teachers in 4-8 ELA and math and their principals and high school principals.

HIGHER EDUCATION

Your Higher Education Committee held its scheduled meeting on April 23, 2013.

ACTION ITEMS

Legislative Proposal Relating to the Fingerprinting Process for Education Certification and Employment and Emergency Adoption of Proposed Amendment to Section 83.4 of the Regulations of the Commissioner of Education Relating to Moral Character. It is recommended that the Board of Regents approve development of the proposed legislation related to fingerprinting in accordance with this item to be transmitted to the Legislature for this legislative session. Also the Board approved that a new paragraph (4) of subdivision (d) of section 83.4 be added to the Regulations of the Commissioner of Education, as submitted, as an emergency action effective April 23, 2013, upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to immediately expedite the procedures in good moral character proceedings for revocation or other action against the teaching certificates of teachers and school administrators who commit a crime involving the submission of false information or fraud related to their criminal history record checks in order to ensure the protection and safety of the children and faculty of the schools in this State. The proposed amendment will become effective on April 23, 2013 and will be presented to the Board of Regents at the July Regents meeting for adoption as a permanent rule.

Your Committee discussed program requirements for candidates wishing to become school building leaders and whether or not to consider a change in the requirements. Your Committee also heard a presentation which provided an update on the new certification examinations for SBL candidates. The exam was revised to include practice based skills such as data driven instruction, and to include more performance tasks, including a teacher observation task.




