

## SUMMARY

### Issue for Decision

Should the Regents approve the proposed revisions to the charters of the following schools authorized by the Board of Regents?

1. Young Women's Collegiate Preparatory Charter School of Rochester
2. Newburgh Preparatory Charter High School

### Reason(s) for Consideration

Required by New York State law.

### Proposed Handling

This issue will be before the Board of Regents P-12 Education Committee and the Full Board for action at the May 2016 Regents meeting.

### Background Information

The Commissioner recommends that the Board of Regents amend the charters of the above listed charter schools. Information about the revision requests is provided below.

**YOUNG WOMEN’S COLLEGIATE PREPARATORY CHARTER SCHOOL OF ROCHESTER**

Proposed Revision	<b>The Board seeks to relocate from their current location in Rochester City School District to the Greece School District beginning with the 2016-2017 school year to lease sufficient classroom space to provide full enrollment through 11<sup>th</sup> grade.</b>

On September 13, 2011, the Board of Regents approved the Young Women’s Collegiate Preparatory Charter School of Rochester (or the “School”), to be located at 311 Flower City Park, Rochester, NY 14615. The School opened for instruction on August 27, 2012. The School is approved to operate grades 7-11, and intends to add a grade every year of the charter until the school is fully expanded. The charter authorizes 75 students per grade with a full enrollment 375 students.

The School's Trustees request that the Board of Regents approve a material revision to its charter to allow the School to change the district of location for the School to the Greece Central School District; specifically to lease space at the Summer Sands Campus, 133 Hoover Drive, Rochester, NY 14615. The proposed lease space is approximately 59,149 square feet and will be part of a co-location with another Board of Regents authorized charter school, Discovery Charter School. The location is made available through a lease agreement with 133 Hoover Drive LLC. By initiating this move, the School intends to gain sufficient classroom space to provide for full enrollment through 11<sup>th</sup> grade. The facilities offer a full-size gym, cafeteria, science labs, and green space including sports fields.

**Summary of Public Comment**

As required by the Charter School Act, both the Greece Central School District and the Rochester City School District held public hearings about the proposed relocation.

The Greece Central School District held their hearing on Tuesday, April 12, 2016. Two speakers asked questions of the charter school, both about charter schools as a whole and to this one specifically. A charter school representative responded. One comment supported the School's decision to join NYS Teacher's Retirement System. Another speaker expressed concern about the effect of a charter school on a suburban school district.

The Rochester City School District held their hearing on Thursday, April 28, 2016. No members of the public were present. A member of the Rochester City School District Board of Education posed questions to the principal of the School regarding the reasoning behind incubation in the current space and plans for relocation to the new space.

Proposed Revision	<b>The Board of Trustees of the Newburgh Preparatory Charter High School has submitted a request to amend the School’s charter, proposing a decrease in the School’s authorized enrollment from an approved maximum of 255 students in 2016-2017 (year 4) and 305 students in 2017-2018 (Year 5), to an approved maximum of 88 students in both years.</b>

On December 11, 2012, the Board of Regents approved and chartered the Newburgh Preparatory Charter School (“NPCS” or the “School”) in the Newburgh Enlarged City School District. The School is designed to serve students who are over-aged and under-credited students between the ages of 16 and 21, lag far behind their four-year 9th grade cohort, and have already dropped out of high school, are in-school truants, or are behind grade level and struggling to remain in school. The founders estimate that the population of students who drop out of school in the city of Newburgh ranges between 1200 and 1800. The majority of these students are African-American and Latino, eligible for free or reduced-price lunch, are English language learners, and have special learning needs.

The School has been unable to attract and retain sufficient numbers of students to allow the School to be within the eighty-five percent (85%) of the Projected Enrollment for a given academic year as per §2.2 of the Charter Agreement. Pursuant to New York Education Law §2853(3)(e), the School submitted a written request dated December 15, 2015 to amend the School’s charter, proposing to decrease the School’s authorized enrollment.

**Summary of Public Comment**

As required by the Charter School Act, the Newburgh Enlarged City School District held a public hearing about the proposed revision on March 8, 2016. Approximately twenty-five individuals attended the hearing. Five attendees made comments. One was in favor of the revision request and four were opposed. Opposition to the request focused on the school’s accountability, attendance, graduation rate, qualification of teachers, fiscal impact on the district, and the district’s plan to open a similar school in the upcoming academic year.

## **Recommendation**

VOTED: That the Board of Regents finds that: (1) the charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the charter school can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to amend the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to amend the charter will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for **Young Women's Collegiate Preparatory Charter School of Rochester** and amends the provisional charter accordingly.

VOTED: That the Board of Regents finds that: (1) the charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the charter school can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for the **Newburgh Preparatory Charter High School** and amends the provisional charter accordingly.

## **Timetable for Implementation**

The Regents action for Young Women's Collegiate Preparatory Charter School of Rochester will become effective immediately.

The Regents action for Newburgh Preparatory Charter High School will become effective immediately.
