#### **AECI Charter Schools Network**

It is recommended that the Board of Regents take the following action:

**MOVED**, that the Board of Regents finds that: (1) the charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the charter school can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to amend the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to amend the charter will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for the **New York City Charter High School for Architecture, Engineering & Construction Industries** and amends the provisional charter accordingly.

**MOVED**, that pursuant to the authority contained in Education Law §§223 and 2853(1)(b-1):

1. New York City Charter High School for Architecture, Engineering & Construction Industries be and hereby is merged with AECI II: NYC Charter High School for Computer Engineering and Innovation, with AECI II: NYC Charter High School for Computer Engineering and Innovation as the surviving education corporation under the amended name AECI Charter Schools Network.

2. AECI II: NYC Charter High School for Computer Engineering and Innovation, the surviving corporation, shall continue to administer the educational operations and purposes of the constituent corporations in the same manner as they presently exist.

3. The separate existence of New York City Charter High School for Architecture, Engineering & Construction Industries and AECI II: NYC Charter High School for Computer Engineering and Innovation hereby ceases, and AECI II: NYC Charter High School for Computer Engineering and Innovation, the surviving corporation under the amended name AECI Charter Schools Network, is hereby vested with all the rights, privileges, immunities, powers and authority possessed by or granted by law to each of the constituent corporations. All assets and liabilities of the respective constituent corporations are hereby assets and liabilities of such surviving corporation. All property, real, personal, and mixed and all debts to each of the corporations on whatever account are hereby attached to AECI II: NYC Charter High School for Computer Engineering and Innovation, the surviving corporation under the amended name AECI Charter Schools Network, and may be enforced against it to the same extent as if the debts, liabilities and duties had been incurred or contracted by it.

4. The merged corporation shall operate under the provisional charter granted to AECI II: NYC Charter High School for Computer Engineering and Innovation under the amended name AECI Charter Schools Network, which is hereby amended to authorize the operation of two public charter schools as follows:

i. New York City Charter High School for Architecture, Engineering & Construction Industries; and

ii. AECI II: NYC Charter High School for Computer Engineering and Innovation

5. The merger and revision herein shall take effect on July 1, 2020; and it is further

**MOVED**, that the Board of Regents finds that: (1) **AECI Charter Schools Network** meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) **AECI Charter Schools Network** can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by **AECI Charter Schools Network**, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

#### Hellenic Classical Charter Schools

**MOVED**, that pursuant to the authority contained in Education Law §§223 and 2853(1)(b-1):

The separate existence of Hellenic Classical Charter School and Hellenic Classical Charter School - Staten Island hereby ceases, and Hellenic Classical Charter School - Staten Island, the surviving corporation under the amended name Hellenic Classical Charter Schools, is hereby vested with all the rights, privileges, immunities, powers and authority possessed by or granted by law to each of the constituent corporations. All assets and liabilities of the respective constituent corporations are hereby assets and liabilities of such surviving corporation. All property, real, personal,

and mixed and all debts to each of the corporations on whatever account are hereby attached to Hellenic Classical Charter School - Staten Island, the surviving corporation under the amended name Hellenic Classical Charter Schools, and may be enforced against it to the same extent as if the debts, liabilities and duties had been incurred or contracted by it.

4. The merged corporation shall operate under the provisional charter granted to Hellenic Classical Charter School - Staten Island under the amended name Hellenic Classical Charter Schools, which is hereby amended to authorize the operation of two public charter schools as follows:

- iii. Hellenic Classical Charter School; and
- iv. Hellenic Classical Charter School Staten Island
- 5. The merger herein shall take effect on July 1, 2020; and it is further

**MOVED**, that the Board of Regents finds that: (1) **Hellenic Classical Charter Schools** meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) **Hellenic Classical Charter Schools** can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by Hellenic Classical Charter Schools, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

#### Proposed Addition of Part 122 to the Regulations of the Commissioner of Education Relating to Military Ballots for School District and School District Public Library Elections, Budget, and Referenda BR (CA) 1

**MOVED**, that Part 122 of the Regulations of the Commissioner of Education be added, as submitted, effective June 1, 2020, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to immediately conform the Regulations of the Commissioner of Education to the requirements of Chapter 489 of the Laws of 2019, which requires military ballots for school district and school district public library elections, budget, and referenda and to ensure that the emergency action taken at the March meeting remains in effect until the proposed rule can be permanently adopted.

#### Amendment to Subparts 30-2 and 30-3 of the Rules of the Board of Regents Relating to Annual Professional Performance Reviews (APPR) of Classroom Teachers and Building Principals to Implement Chapter 59 of the Laws of 2019 BR (CA) 3

**MOVED**, that the existing Subpart 30-2 is repealed, that the existing Subpart 30-3 be renumbered to Subpart 30-2, that the title of the new Subpart 30-2 and Section 30-2.1 are amended, and addition of a new Subpart 30-3 of the Rules of the Board of Regents be added, as submitted, effective May 20, 2020.

#### Hilbert College: Master Plan Amendment to Offer a Bachelor of Arts (B.A.) Degree Program in the Biological Sciences Discipline BR (CA) 4

# COVID-19 Emergency Regulations Part II

May 4, 2020



### **COVID-19 PANDEMIC**

- As a result of the Governor's numerous Executive Orders, the Department adopted emergency regulations at the April 2020 Board of Regents meeting to address the issues resulting from the interruptions caused by the COVID-19 crisis.
- To address additional issues resulting from the continued interruptions caused by the COVID-19 crisis, the Department is proposing further emergency regulatory amendments to provide flexibility to the field and students during this crisis.

### Receivership

#### • The Department will not use 2019-20 results in receivership determinations. Specifically:

- The Commissioner shall not use 2019-20 school year results to newly identify any schools as struggling, place any schools under independent receivership, or remove the designation of any schools as struggling or persistently struggling;
- All schools identified as persistently struggling or struggling schools for the 2019-20 school year shall remain so identified for the 2020-21 school year and all schools that operated under a school district superintendent receiver in the 2019-20 school year shall continue to operate under a school district superintendent receiver in the 2020-21 school year; and
- The Commissioner may, upon a finding of good cause, modify for the 2019-20 through 2021-22 school years any timelines pertaining to notifications, plans, reports, or implementation of activities, except for any timelines prescribed by law.

### **Curriculum and Instruction**

• Earning units of credit through coursework. The Department proposes to provide that a unit of credit may be earned where a student has not completed a unit of study due to the COVID-19 crisis but has otherwise achieved the standards assessed in the provided coursework.

### **Curriculum and Instruction Continued**

- Cancelation of Regents Exams. The June 2020 and August 2020 Regent examinations have been canceled.
- Exempt students from State assessments.

The Department proposes to provide an exemption to the Regents examination, pathway assessment, alternative assessment, technical assessment, and locally developed test requirements during the COVID-19 crisis so that students are still able to meet their diploma requirements.

### **Curriculum and Instruction Continued**

• Earning NYS Career development and occupational studies commencement credential.

The Department proposes to exempt students from the requirements for the career development and occupational studies commencement credential ("CDOS") provided that the student is otherwise eligible to exit from high school and has otherwise demonstrated knowledge and skills relating to the CDOS learning standards.

### **Curriculum and Instruction Continued**

• Allow for flexibility in general comprehensive examination requirements for a high school equivalency diploma.

The Department proposes to exempt candidates from the sub-tests of the general comprehensive examination requirements for a high school equivalency diploma where:

- Such candidate has been exempted from or passed the corresponding Regents examination or other approved examination; or
- Such candidate is enrolled in either an AHSEP program or an adult education program during the COVID-19 crisis when the general comprehensive exam is not available; and
  - Has previously taken and passed a combination of at least 3 Regents exams and/or sub-tests of any general comprehensive examination; and
  - For the remaining 2 sub-tests, the student achieves a passing grade in the corresponding approved high school equivalency classes with standards based curriculum and applicable assessments

### Alternative High School Equivalency Program

Extension of AHSEP application deadline
 The Department proposes to provide an
 extension to the June 30<sup>th</sup> application deadline for
 alternative high school equivalency preparation
 programs to be operated during the 2020-2021
 school year.

## **Higher Education**

#### • Certification through the Individual Evaluation Pathway

- The Department proposes to allow any undergraduate or graduate level course completed during the Spring, Summer, of Fall 2020 terms with a passing grade, or its equivalent, to count toward the content course or pedagogical core semester hour requirements for certification through the Individual Evaluation pathway.
- The passing grade, or its equivalent, must be in accordance with the pass/fail grading policy or its equivalent at the institution of higher education (e.g., credit/no credit, pass/fail, satisfactory/unsatisfactory policy).

• Extend the expiration date of the Initial certificate, Initial Reissuance, Provisional certificate, and Provisional Renewal

The Department proposes to extend the expiration date of the Initial certificate, Initial Reissuance, Provisional certificate, and Provisional Renewal from August 31, 2020 to January 31, 2021 to provide candidates with the time needed to work in schools and complete the requirements for the Professional or Permanent certificate.

- Extend the expiration date of the Conditional Initial certificate
- The Department proposes to extend the expiration date of the Conditional Initial certificate from August 31, 2020 to August 31, 2021 to provide candidates with the time needed to complete the edTPA, which requires working with students. An additional year gives candidates the time to establish a relationship with students, teach lessons and assess student learning, and prepare the edTPA submission once classroom routines are more consistent after the COVID-19 crisis.

#### Create an Emergency COVID-19 certificate.

- The Department proposes to create an Emergency COVID-19 certificate for candidates seeking certain certificates and extensions because there is limited test center availability and schools have been closed pursuant to Executive Order(s) of the Governor due the COVID-19 crisis. This certificate would be valid for one year and could be renewed one time for an additional year with letter(s) of recommendation from school, district, and/or BOCES administrators.
- To earn the Emergency COVID-19 certificate candidates must, on or before September 1, 2020:
  - Apply for the certificate or extension;
  - Apply for the Emergency COVID-19 certificate, in the same certificate title as the certificate or extension applied for; and
  - Complete all requirements for the certificate or extension applied for, other than the examination requirement(s).

- Exempt school district leader (SDL) and school district business leader (SDBL) candidates from taking and passing the SDL and SDBL assessment, respectively, for program completion and institutional recommendation for Professional certification, however, candidates would need to take and pass these assessments for Professional certification.
  - The Department proposes to exempt SDL and SBDL candidates from taking and passing the SDL and SDBL assessment, respectively, for program completion and for the institutional recommendation for the Professional certificate, if they completed all program requirements except the assessment requirement during the Fall 2019, Winter 2020, Spring, 2020, or Summer 2020 terms.
  - The exemption enables these candidates to complete their program while there is limited test center availability due to the COVID-19 crisis and to receive institutional recommendation for Professional certification, which would be needed to pursue the proposed Emergency COVID-19 certificate.
  - The candidates would need to take and pass the SDL and SDBL assessment to earn certification.

- Exempt candidates admitted to Transitional D programs leading to SDL certification from taking and passing the SDL assessment for institutional recommendation for Transitional D certification, however, candidates would need to take and pass such assessment to earn Transitional D certification.
  - The Department proposes to exempt candidates admitted to Transitional D programs leading to SDL certification from taking and passing the SDL assessment for the institutional recommendation for the Transitional D certificate, if they completed all requirements for admitted candidates except the assessment requirement on or before September 1, 2020.
  - The exemption enables Transitional D candidates to receive institutional recommendation for Transitional D certification while there is limited test center availability due to the COVID-19 crisis, which would be needed to pursue the proposed Emergency COVID-19 certificate.
  - The candidates would need to take and pass the SDL assessment to earn Transitional D certification.

### Professions

- Permit one additional 24-month renewal of limited permits in medicine. Current regulations provide that limited permits in medicine shall not be renewed for more than one 24 month period. The Department proposes to permit, at the Department's discretion, the renewal of limited permits in medicine for one additional 24 month period during the COVID-19 crisis.
- Waive the in-person CPR course requirement for Dentists and Dental Hygienists.

Current regulations require dentists and dental hygienists to become certified in CPR through an in-person course. The Department proposes to accept alternative means to be used by dentists and dental hygienists to obtain and/or maintain the required CPR certification for their respective professional practice during the COVID-19 crisis.

## Early Learning

# • Waive the annual monitoring and tracking of pre-K program effectiveness

The Department proposes to waive the requirement that school districts must annually monitor and track prekindergarten program effectiveness for the 2019-2020 school year.

### • Waive the annual Pre-K report

The Department also proposes to waive the annual report of the percentage of prekindergarten children making significant gains for the 2019-2020 school year.

### 2020-21 State Aid

- Overall year to year increase of \$107 million in aid for school districts, of which:
  - \$96 million is based on updated data for the statutory reimbursement aids;
  - \$10 million is for the Office of Mental Health (OMH) to administer school mental health grants; and
  - \$1 million is for SED to develop a statewide curriculum on Civic Education and Values, Shared History of Diversity and the Role of Religious Freedom in Our Country.
- Each school district's total state aid amount is reduced dollar for dollar by the projected amount each district is estimated to receive in one-time federal funds through the CARES Act, for a total reduction of \$1.13 billion



### **2020-21 State Aid**

The Enacted Budget does not include the Executive Budget's proposals to:

- consolidate ten existing aid formulas (including BOCES and Special Services Aid) into Foundation Aid;
- establish a new reimbursement rate for Building Aid beginning with projects approved after July 2020;
- close the building aid "incidental cost loophole;" and
- cap growth in aidable transportation expenses.



# Regents Funding Priorities Included in the Enacted Budget

- \$18 million for My Brother's Keeper
- \$25.4 million in capital spending authority for the Office of Professions' Systems Modernization
- Funding for the following access and opportunity programs at 2019-20 enacted budget levels:
  - Liberty Partnerships: \$18.36 million
  - Higher Education Opportunity Program (HEOP): \$35.5 million
  - Science and Technology Entry Program (STEP): \$15.8 million
  - Collegiate Science and Technology Entry Program (CSTEP): \$11.98 million



### New Appropriations in the Enacted Budget

- \$1 million for the development of a statewide curriculum on Civic Education and Values, Shared History of Diversity and the Role of Religious Freedom in Our Country
- \$10 million for Student Mental Health Support Grants (to be administered by the Office of Mental Health)
- Funding for Hempstead, Wyandanch and Rochester to reimburse these school districts for a portion of the cost of their monitors - no staffing or resources were provided to SED to do this work



### Funding for Cultural Education in the Enacted Budget

- Aid to Public Libraries: \$94.1 million
- Aid to Educational Television and Radio: \$14
   million
- Public Library Construction: \$14 million



### Funding for ACCES in the Enacted Budget

- Adult Literacy Aid: \$7.8 million
- Independent Living Centers (ILCs): \$13.9 million



- Requires the appointment of a monitor by the Commissioner for both academic and fiscal issues for the Rochester School District and provides for accelerated (spin-up) aid payments of \$35 million to assist in addressing their current deficit.
- Establishes the Syracuse Comprehensive Education and Workforce Training Center which includes a Regional STEAM high school.



- Includes the Executive Budget's proposal to increase the share of maintenance costs for special education students placed in residential schools for local school districts outside of NYC.
- Allows foster youth funding to be used for supplemental housing and meals during intersession and summer breaks and for certain medical expenses.



- Establishes a DOH led E-Cigarette and Vaping Prevention, Awareness and Control Program to educate students, parents and school personnel about the health risks associated with vapor product use and control measures to reduce the prevalence of vaping.
- Bans the sale, use, or distribution of disposable food service containers made of expanded polystyrene beginning on January 1, 2022.
   Elementary and secondary schools, colleges, and universities are included in this ban.



The Enacted Budget includes the following new provisions not contained in the Executive Budget proposal:

- Extending East Ramapo monitors through June 30, 2021;
- Amending the Wyandanch UFSD date of issuance of deficit financing serial bonds from June 30<sup>th</sup> to October 31, 2020 (pursuant to the request of the school district) and increasing the total amount available from \$3.1 million to \$4.5 million; and
- Final Cost Report (FCR) forgiveness for Mahopac
   Central School District.



#### Proposed Professions Related Statutory Changes in the Executive Budget

The Enacted Budget does not include the Executive Budget proposals to:

- Authorize public accounting firms to incorporate in NYS with minority ownership by individuals who are not Certified Public Accountants;
- Expand the provisions of registered pharmacy technicians in registered pharmacy outside of Article 28 facilities;
- Expand the list of adult immunizations that pharmacists can administer;
- Expand the current law Collaborative Drug Therapy Management (CDTM) program between pharmacists and physicians; and
- Increase DOH oversight of physicians, physician assistants and specialist assistants, including requiring a fingerprintbased criminal history background check prior to licensure.



### **Enacted Budget Financial Plan**

- The 2020-21 enacted budget provided the Director of the Budget with the authority to reduce aid-tolocalities appropriations and disbursements by any amount needed to achieve a balanced budget, as estimated by the Division of the Budget (DOB).
- On April 25, 2020, DOB released the Enacted Budget Financial Plan. In this Financial Plan, DOB has reduced the FY 2021 estimate for General Fund receipts by \$13.3 billion in comparison to the Executive plan.



### **Enacted Budget Financial Plan**

- DOB is preparing a detailed plan itemizing the specific appropriations and disbursements that will be reduced or withheld to achieve \$8.2 billion in recurring reductions in aid-to-localities spending, and expects to transmit the plan to both houses of the Legislature in May.
- State funding for school aid remains at the 2020-21 enacted budget level for now, which could change pending DOB's issuance of the plan to the Legislature for the \$8.2B in aid to localities reductions.



### **Enacted Budget Financial Plan**

- State agency operations budgets will be reduced by 10 percent from budgeted levels. SED will develop a plan to implement these reductions after we receive additional guidance from DOB.
- Spending controls include a strict freeze on hiring, including revocation of existing waivers. Current and planned capital projects will be reviewed and prioritized. New contracts and purchase orders will be limited to those necessary for health and safety or high priority operations.
