Annual State Aid Budget Cycle

- November 15th Database: Provides first estimates for aid in the upcoming year
- December: Regents State Aid Proposal
- January: Executive Budget
- February 15th Database: Updated aid estimates; typically used for Enacted Budget
- Early March: One-House Bills
- April 1st: Enacted Budget, release of aid runs



State Aid Subcommittee Discussions

Summer/Fall 2018: Co-chairs met with stakeholder groups

September 2018: Subcommittee reviewed 2018-2019 Proposal and Enacted Budget

October 2018: Subcommittee discussed Foundation Aid formula history and impact of the remaining phase-in

November 2018: Subcommittee reviewed conceptual proposal



2019-2020 Regents Priorities

"The 5 E's"

- 1. Equity
- 2. Every Student Succeeds Act Implementation
- 3. Early Learning
- 4. English Language Learners
- **5. Efficiency** (Initiatives and investments that will enhance and/or streamline Department and school district functions)



Foundation Aid Phase-in

- 2018-2019 Foundation Aid: \$17.8 billion
 An increase of \$5.3 billion since creation in 2007
- As of the November Database, without any further inflationary adjustments, the remaining phase-in amount was \$4.1 billion
- Assuming a three-year phase-in schedule, adjusting for inflation increases the phase-in amount to \$4.9 billion



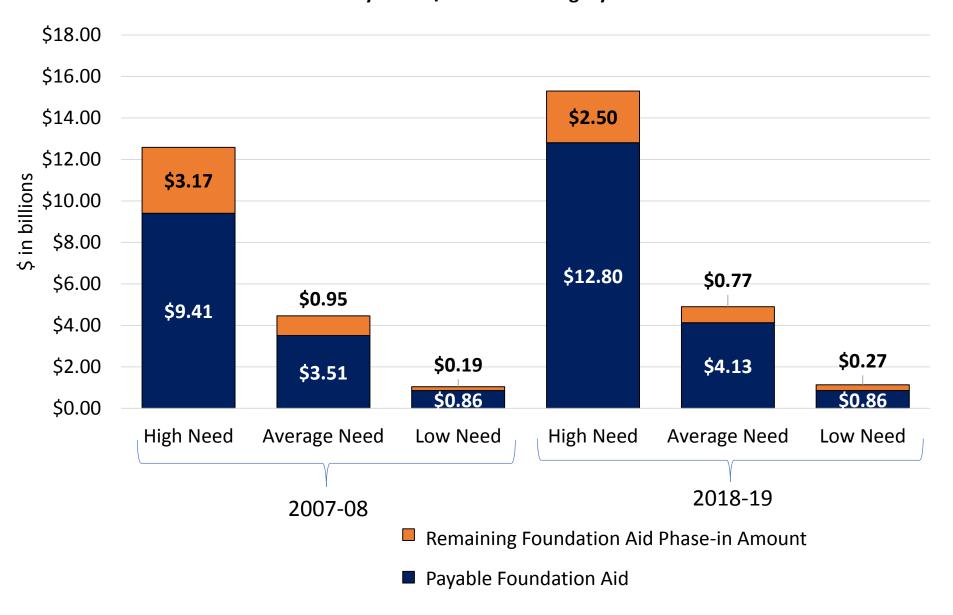
Actual Foundation Aid Paid to Districts vs. Formula Generated Phase-in Amount

Prekindergarten Consolidation

- In 2017, the Governor and Legislature passed a law, at the recommendation of the Board of Regents, that would consolidate the multiple prekindergarten programs into two over a number of years.
- The first consolidation occurred in the 2017-18 school year.
- The 2019-20 school year further consolidates five programs.
- Included within this consolidation is the continuation of a federal grant program using state funds, an increase in state support of \$25 million.



2019-2020 Regents State Aid Proposal

Aid Category	Increase Amount (\$ millions)
Foundation Aid Phase-in	\$1,575
ELL Acceleration/Setaside	\$85
Total Foundation Aid	\$1,660
Expense-based Aids	\$410
Universal Prekindergarten	\$26
Career and Technical Education	\$25
Grand Total	\$2,121



Foundation Aid Increase (\$1.58 billion)

- Provides for a three-year phase-in of the remaining Foundation Aid amount, adjusted for inflation, of \$4.9 billion.
- Provides a minimum increase for all school districts of one percent.
- Increases of roughly the same amount in 2020-2021 and 2021-2022 would fully complete the phase-in.



ELL Acceleration/Setaside (\$85 million)

- Within the 2019-2020 Foundation Aid phase-in, accelerate funding that is provided for weighted ELL students to ensure that those funds are prioritized in the first year of the phase-in cycle.
- If enacted, similar to the community schools setaside, the department will issue guidance to school districts on how funds must be spent on ELL educational services.



Reimbursement-based Aids (\$410 million)

Based on the most recent district claims and consistent with entitlement provisions in law:

- Building Aid: \$272 million
- Transportation Aid: \$77 million
- BOCES Aid: \$22 million
- Special Education: \$13 million
- Federal Prekindergarten Consolidation: \$25 million
- Other: \$1 million



Universal Prekindergarten (\$26 million)

- In addition to the consolidation of Federal grant funds (\$25 million), the Regents Proposal would also further expand prekindergarten by \$26 million:
 - \$20 million for the addition of 2,000 slots for fouryear olds statewide.
 - \$6 million for pilot programs to create a single reimbursement structure for prekindergarten inclusion programs by blending existing prekindergarten and preschool special education funding mechanisms.



Career and Technical Education (\$25 million)

- For BOCES component districts, the aid salary ceiling will be increased to \$60,000 over five years, with inflationary adjustments after that point.
- For non-component districts, 2019-20 CTE expenses will be made reimbursable in the following year, consistent with BOCES Aid.
- As a transition, Special Services Aid will increase
 \$25 million in 2018-2019 to provide "seed" money.
