


**SUMMARY**

**Issue for Consent Agenda**

Should the Regents approve the recommendations of the Committee on the Professions pertaining to licensing petitions as listed on the attachment?

**Reason(s) for Consideration**

Required by State Statute.

**Proposed Handling**

This question will come before the full board at its October 18, 2016 meeting where it will be voted on and action taken.

**Procedural History**

Section 6506(5) of the Education Law and Section 24.7 of the Rules of the Board of Regents authorize the Regents to waive education, experience and examination requirements for a professional license as well as to confer the degree Doctor of Medicine.

**Background Information**

There are 5 licensing petitions and there are 15 requests for the conferral of the degree Doctor of Medicine for review and approval.

### **Recommendation**

It is recommended that the Regents approve the recommendations of the Committee on the Professions regarding the licensing petition and the degree conferrals.

### **Timetable for Implementation**

Approval of the Committee on the Professions' recommendations will be effective October 18, 2016.

Petition for: Acceptance of passing grades on the Uniform Certified Public Accountancy Examination.

Statement of Problem:

Ms. Shchudlak is an applicant for licensure as a CPA and passed all four parts of the Uniform CPA examination. However, she exceeded the 18-month conditioning requirement by two months.

Ms. Shchudlak passed the Regulation (REG) section of the Examination in November 2012 and needed to pass the remaining three sections of the Examination by June 30, 2014. On her second attempt, she passed Auditing and Attestation (AUD) in October 2013. Ms. Shchudlak passed Business Environment and Concepts (BEC) in May 2012 on her second attempt; however, she lost credit for this section of the Examination. Ms. Shchudlak re-sat the BEC section of the Examination twice more and passed in February 2014 within her 18-month conditioning period. Ms. Shchudlak sat the Financial Accounting and Reporting (FAR) section of the Examination five times during her conditioning period, but did not pass until her sixth attempt during the next available testing window, which was one testing window or two months outside her conditioning period.

Ms. Shchudlak's ability to properly prepare and sit for the Examination was impeded by her medical condition that occurred during her conditioning period. Ms. Shchudlak was a Pennsylvania jurisdiction candidate for the CPA Examination and that Board has provided a letter to the NYS Board for Public Accountancy indicating they approved her extension of one testing window to September 30, 2014. Currently, Ms. Shchudlak is working in New York and is seeking a New York State CPA license. Ms. Shchudlak is not licensed in Pennsylvania.

Based on documentation provided by her physician who attended to Ms. Shchudlak and her perseverance on the various sections of the Examination, despite her medical condition, the Executive Secretary of the State Board for Public Accountancy supports her petition to waive the 18-month requirement to pass all four parts of the Uniform CPA Examination.

Petition for: Acceptance of education.

Statement of Problem: Regulations of the Commissioner require an applicant for licensure in dentistry to complete an acceptable preprofessional education program of at least two years in length (including courses in general chemistry, organic chemistry, biology or zoology, and physics) and an acceptable professional dental education program of at least four years in length, for a total of six years of preprofessional and professional education.

Dr. Arany completed a five-year combined preprofessional and professional dental education program at Semmelweis University in Budapest, Hungary. Therefore, she lacks one year of education which is in the preprofessional area.

However, Dr. Arany also completed two years of advanced study leading to a Doctor of Medicine degree from April 2000 to March 2002 at Akita University in Akita, Japan. The Executive Secretary for the State Board for Dentistry recommends that these studies be considered to fulfill the one year of required preprofessional education.

Additionally, an applicant who completed a program of dental education in an unregistered or unaccredited dental school must complete the required two academic years of study in an accredited dental school program, culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school. Dr. Arany enrolled in a three-year Advanced Education in General Dentistry program at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2016. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Petition for: Acceptance of education.

Statement of Problem: Regulations of the Commissioner require an applicant for licensure in dentistry to complete an acceptable preprofessional education program of at least two years in length (including courses in general chemistry, organic chemistry, biology or zoology, and physics) and an acceptable professional dental education program of at least four years in length, for a total of six years of preprofessional and professional education.

Dr. Calero completed a five-year combined preprofessional and professional dental education program at Universidade del Valle in Cali, Colombia. Therefore, he lacks one year of education which is in the preprofessional area.

However, Dr. Calero also completed one year of advanced study in Temporomandibular Joint Dysfunction July 2009 through June 2010 at University of Rochester Eastman Institute for Oral Health in Rochester, New York. The Executive Secretary for the State Board for Dentistry recommends that these studies be considered to fulfill the one year of required preprofessional education.

Additionally, an applicant who completed a program of dental education in an unregistered or unaccredited dental school must complete the required two academic years of study in an accredited dental school program, culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school. Dr. Calero enrolled in the two-year Advanced Education in General Dentistry at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2013. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Statement of Problem: Regulations of the Commissioner require an applicant for licensure in dentistry to complete an acceptable preprofessional education program of at least two years in length (including courses in general chemistry, organic chemistry, biology or zoology, and physics) and an acceptable professional dental education program of at least four years in length, for a total of six years of preprofessional and professional education.

Dr. Farag completed a five-year combined preprofessional and professional dental education program at Alexandria University in Alexandria, Egypt. Therefore, he lacks one year of education which is in the preprofessional area.

However, Dr. Farag also completed three years of postgraduate study in Maxillofacial and Plastic Surgery from January 2001 to December 2013 at Alexandria University in Alexandria, Egypt. The Executive Secretary for the State Board for Dentistry recommends that these studies be considered to fulfill the one year of required preprofessional education.

Additionally, an applicant who completed a program of dental education in an unregistered or unaccredited dental school must complete the required two academic years of study in an accredited dental school program, culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school. Dr. Farag enrolled in a two-year Advanced Education in General Dentistry program at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2016. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Statement of Problem: An applicant for licensure in dentistry who has completed a program of dental education in an unregistered or unaccredited dental school is required to complete two academic years of study in an accredited dental school program culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school.

Dr. Tofighi enrolled in the two-year Advanced Education in General Dentistry at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2016. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Summary Statement: The petitioners listed below are all graduates of foreign medical schools who have been licensed in New York.

The applicable requirements of Section 3.57 of the Rules of the Board of Regents require completion of a medical education program in a foreign medical school satisfactory to the Department which does not grant the degree Doctor of Medicine (M.D.), and in which the philosophy and curriculum were equivalent, as determined by the Department in accordance with the policy of the Board of Regents, to those in programs leading to the degree Doctor of Medicine (M.D.) at medical schools in the United States satisfactory to, or registered by, the Board of Regents and the Department. Secondly, petitioners must have licensure to practice medicine in New York State in accordance with provisions of Section 6524 or 6528 of the Education Law or their equivalent as determined by the Board of Regents pursuant to their authority under Section 6506 of the Education Law.
