**SUMMARY**

**Issue for Decision (Consent)**

Should the Regents approve the recommendations of the Committee on the Professions pertaining to licensing petitions and degree conferrals as listed on the attachment?

This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Petition for: Acceptance of education.

Statement of Problem: Regulations of the Commissioner require an applicant for licensure in dentistry to complete an acceptable preprofessional education program of at least two years in length (including courses in general chemistry, organic chemistry, biology or zoology, and physics) and an acceptable professional dental education program of at least four years in length, for a total of six years of preprofessional and professional education.

Part 24.3(a)(1) of the Rules of the Board of Regents allows the Committee on the Professions the authority to waive up to six semester hours of preprofessional education, and §24.3(a)(2) of the Rules of the Board of Regents gives the Committee on the Professions the authority to accept postsecondary study after completion of professional study in lieu of up to 30 semester hours of preprofessional study.

Dr. Madruga Cavalcanti completed a five-year professional dental education program at Universidade de Fortaleza in Fortaleza, Brazil. Therefore, she lacks one year of education which is in the preprofessional area, including courses in General Chemistry and Physics.

However, Dr. Madruga Cavalcanti also completed graduate coursework from February 2005 until November 2007, culminating in a Master of Clinical Pharmacology at Universidade Federal do Ceara in Fortaleza, Brazil. In addition, she completed graduate coursework from March 2006 until March 2008, culminating in a specialist certificate in Periodontology at Universidade de Fortaleza in Fortaleza, Brazil. Finally, she completed graduate coursework from January 2010 until June 2012, culminating in a specialist certificate in Implantology at Centro Universitario Inga in Fortaleza, Brazil. The Executive Secretary for the State Board for Dentistry recommends that these studies be considered to fulfill the one year of required preprofessional education.

Additionally, an applicant who completed a program of dental education in an unregistered or unaccredited dental school must complete the required two academic years of study in an accredited dental school program, culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school. Dr. Madruga Cavalcanti enrolled in the two-year Advanced Education in General Dentistry at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2021. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Fassbender's application. He recommends that Dr. Fassbender's German Residency and Fellowship be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the licensure, proficiency, and clinical competency requirements for licensure by endorsement. Dr. Fassbender obtained his medical license in Germany in 2008. His German license is active and in good standing. Additionally, Dr. Fassbender holds Board Certification in Anesthesiology and Intensive Care Medicine and holds a European Diploma in Anesthesiology and Intensive Care issued by European Society of Anesthesiology and Intensive Care.

The Executive Secretary of the State Board for Medicine recommends that Dr. Fassbender's German license be endorsed, and his Certifications and Diploma be accepted to fulfill the proficiency examination and the clinical competency requirements for endorsement.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Gebauer's application. He recommends that Dr. Gebauer's German Residencies be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Additionally, Dr. Gebauer holds Specialist Certification in Orthopaedics, Trauma Surgery and Hand Surgery and holds a Doctor of Medicine Diploma issued by University of Lubeck.

The Executive Secretary of the State Board for Medicine recommends that Dr. Gebauer's German license be endorsed, and her Certifications and Diploma be accepted to fulfill the proficiency examination and the clinical competency requirements for endorsement.

A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Koenigstein's application. He recommends that Dr. Koenigstein's Israeli Residency and Canadian Fellowship be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the licensure, proficiency, and clinical competency requirements for licensure by endorsement. Dr. Koenigstein obtained his medical license in Israel in 2013. His Israeli license is active and in good standing. Additionally, Dr. Koenigstein holds ECFMG Certification as of January 2015 and is a specialist in Ophthalmology issued by Israel Medical Association as of January 2019.

The Executive Secretary of the State Board for Medicine recommends that Dr. Koenigstein's Israeli license be endorsed, and his Certifications be accepted to fulfill the proficiency examination and the clinical competency requirements for endorsement.
