Summer Food
Service program



Child Nutrition Programs

Lunch

- 1.5 Million Students *per Day*
- 268.7 Million Lunches *Annually*

Breakfast

- 713,000 Students *per Day*
- 128.7 Million Breakfasts *Annually*

Summer Food

- 20 million meals
- 3100 locations

Prohibition Against Meal Shaming

What	<ul style="list-style-type: none">➤ MEAL SHAMING IS PROHIBITED➤ Schools must develop a written anti-shaming plan that meets all required criteria<ul style="list-style-type: none">➤ Note: Schools/Districts will no longer be able to refuse a meal or limit students to an alternate meal
Who	<ul style="list-style-type: none">➤ All schools/districts that participate in the National School Lunch Program or School Breakfast Program➤ Except schools/districts serving meals at no charge (e.g., Community Eligibility Provision)
When	<ul style="list-style-type: none">➤ Plans were required to be submitted to the NYS Education Department (NYSED) by July 1, 2018
How	<p>CHILD NUTRITION PROGRAM OFFICE:</p> <ul style="list-style-type: none">➤ Provided professional development, technical assistance and a prototype plan➤ Reviewed school/district plans and provided feedback

Breakfast After the Bell (BAB)

What	<ul style="list-style-type: none">➤ OFFER ALL STUDENTS SCHOOL BREAKFAST AFTER THE INSTRUCTIONAL DAY HAS BEGUN<ul style="list-style-type: none">➤ Breakfast in the classroom may count toward instructional time➤ Consult with teachers, parents, students, community to determine best model➤ http://bestpractices.nokidhungry.org/programs/school-breakfast/implement-breakfast-after-the-bell➤ District can apply annually for a waiver (lack of need or economic hardship)
Who	<ul style="list-style-type: none">➤ Public schools with at least 70% or more students eligible for free and reduced price meals in prior year➤ 1,456 public school buildings identified➤ Does not apply to charter schools & nonpublic schools
When	<ul style="list-style-type: none">➤ Begins in the 2018-19 SY and continues every year thereafter
How	<p>CHILD NUTRITION PROGRAM OFFICE:</p> <ul style="list-style-type: none">➤ Has developed and distributed implementation guidelines, and has provided training and technical assistance to the field➤ Has issued Equipment Grants in accordance with the 2018-19 enacted State budget➤ Is required to post on the NYSED website all schools that meet the 70% requirement and provide notice to those schools each December starting in 2019➤ Must post on NYSED website participation information for schools required to implement and all others implementing Breakfast After the Bell, on or before May 1st each year

Next Steps

- If adopted at the September 2018 Board meeting, the emergency rule will become effective September 18, 2018.
- The proposed amendment will be posted in the State Register for a 60-day public comment period.
- The Department anticipates presenting the proposed rule to the Board for permanent adoption at the January 2019 meeting.
- Because the emergency regulation will expire before the January 2019 Board meeting, it is anticipated that an additional emergency action will be presented for adoption at the December 2018 Board meeting.
