# Charter Schools Education Law

## Education Law §2850(2):

The purpose of this article is to authorize a system of charter schools to provide opportunities for teachers, parents, and community members to establish and maintain schools that operate independently of existing schools and school districts in order to accomplish the following objectives:

- a. Improve student learning and achievement;
- b. Increase learning opportunities for all students, with special emphasis on expanded learning experiences for students who are at-risk of academic failure;
- c. Encourage the use of different and innovative teaching methods;
- d. Create new professional opportunities for teachers, school administrators, and other school personnel;
- e. Provide parents and students with expanded choices in the types of educational opportunities that are available within the public school system; and
- f. Provide schools with a method to change from rule-based to performance based accountability systems by holding the schools established under this article accountable for meeting measurable student achievement results.

# Guiding Principles of the Charter School Performance Framework

- Engage in continual reflection and improvement;
- Facilitate transparent feedback to charter schools through clear standards that schools are expected to meet; and
- Alignment to the ongoing accountability and effectiveness work for all public schools.

# Actions to Date

- In 2012, the Board of Regents endorsed the Charter School Performance Framework.
- In 2015, the Performance Framework was updated.
- Since 2015, the Department has responded to Regents requests to include additional indicators in all documents presented to the Board.
