Higher Education

Your Higher Education Committee held its scheduled meeting on December 13, 2010. All members were present except Vice Chancellor Cofield and Chancellor Emeritus Bennett.

Emergency Adoption of Proposed Regulations to Allow Individuals with Advanced Degrees in Science, Technology, Engineering, and Mathematics and Related Teaching Experience at the Postsecondary Level to Obtain a Teaching Certificate in Earth Science, Biology, Chemistry, Physics, Mathematics or in a Closely Related Field. Your Committee discussed the proposed regulations and decided to postpone the vote until February 2011 to allow staff additional time to review and revise the criteria to allow individuals with advanced degrees in the STEM related fields to obtain certification in science, mathematics and related certification areas in grades 5-9 and 7-12. HE (A) 1

The Regents 2012-2020 Statewide Plan for Higher Education. Your Committee began a discussion on the issues and priority concerns for emphasis in the next Statewide Plan. HE (D) 2

Recommendations from the State Professional Standards and Practices Board for Teaching on NYS Mentoring Standards. Your Committee discussed the proposed NYS

Mentoring Standards presented by the State Professional Standards and Practices Board for Teaching. HE (D) 1

Proposed Amendment to Sections 80-1.6 relating to Time Extensions to Initial and Provisional Teacher Certification for Individuals Awaiting Permanent Residence. Your Committee discussed the proposed amendment relating to time extensions to initial and provisional certificates for individuals awaiting United States permanent residence as the last uncompleted requirement for professional and permanent certification. Joint P-12 Education and Cultural Education

Your P-12 Education and Cultural Education Committees held a joint meeting on December 13, 2010. All members were present, except for Vice Chancellor Cofield, who was excused.

Panel Discussion

The panel presented overviews of their programs and answered questions relating to Arts integration programs and their connection to school improvement and school turnaround. Discussion focused on how these schools integrate arts education into core courses so that students can benefit from a quality arts education while still meeting the standards. The arts programs discussed at the meeting demonstrate success through their connection to the community, increased attendance, cultural diversity, and quality programs that prepare students to be successful in college and careers. The panel was provided the following discussion questions to help guide the conversation:

- Would a graduation credential in the Arts be helpful in motivating students and signaling students' skills to post-secondary options?
- What courses, teacher skills, performance opportunities, etc. are required to build high school programs that effectively prepare students to pursue post-secondary opportunities in the arts?
- How might academic courses be effectively integrated with arts courses at the middle and high school level?
- What unique preparation do secondary-level arts teachers need?

- If students were to be awarded credit for an arts internship, what assessments could be used to ensure rigor?
- What are the keys to a successful middle school arts program? A successful high school arts program?

Art Commencement Certificate by NYC

Paul King, Executive Director, Office of Arts and Special Projects, New York City Department of Education presented information to the Board of Regents on the Chancellor's Arts Endorsed Diploma. To receive this designation on their diploma, graduating seniors must complete a five unit sequence in dance, music, theater or visual arts. They must also pass a rigorous Commencement Assessment in their arts discipline, which includes 50 multiple choice questions, a 250-300 word essay, live performances, and an exit project-portfolio of work. The Committee discussed the benefits of offering the arts endorsement at school districts and BOCES outside of New York City, including validation of student commitment and the added endorsement on college transcripts.

Adult Education and Workforce Development

Your AEWD Committee held its scheduled meeting on December 13, 2010. All members were present, with the exception of Regent Tilles, who was excused. Additional members of the Board attending were: Chancellor Tisch and Regent Bottar.

Matters Not Requiring Board Action

The Committee was informed about the Vocational Rehabilitation Postsecondary Initiatives and how they play a significant role in supporting individuals with disabilities in New York State. Deputy Commissioner Smith provided background on the Vocational Rehabilitation Program and discussed how postsecondary training is a key vocational rehabilitation service that will enable individuals with disabilities to compete in the job market and earn competitive wages. Staff provided an update to the Committee on the financial challenges for both vocational rehabilitation programs and colleges as the number of students with disabilities participating in postsecondary education continues to increase. Staff also updated the Committee on how initiatives, such as CUNY LEADS, significantly increased the number of individuals served by the VR Program and yielded higher employment rates for these individuals. Staff recommended to the Committee that the Board continue to promote policy which will reinforce its commitment to services that support students with disabilities in higher education so that they engage in careers leading to economic independence. (AEWD (D) 1)

Audits/Budget and Finance

Your Regents Subcommittee on Audits/Budget and Finance met as scheduled on December 13, 2010. Chancellor Tisch, Vice Chair Bendit, Regents Brooks Hopkins, Phillips, Tallon, and Tilles were in attendance.

Chair's Remarks: Regent Chapey welcomed everyone and noted that the Department is experiencing many changes and challenges. The goal of the Subcommittee in the times such as these is to assist in moving change in a positive direction toward reform.

Items for Discussion

Presentation – Office of the State Comptroller

The Deputy Comptroller from the Office of Local Government and School Accountability spoke the members on the role of his office is conducting school district audits. He provided an overview of the results of past audits and current initiatives. He also described the risk assessment process used to identify the scope of audits.

Other Items

Your Subcommittee reviewed the October fiscal report and also discussed a number of updates to the Regents Budget priorities list.

Completed Audits

The Subcommittee was presented with 21 audits this month. The Office of Audit Services will continue to monitor trends requiring the attention of the Subcommittee.

Proposed Amendment to Establish Committee on Audits/Budget and Finance

The Subcommittee was briefed on a proposed amendment to the Regulation of the Commissioner which would establish a Committee on Audits/Budget and Finance. The Subcommittee voted approval to bring to the full Board of Regents for emergency adoption. The Motion to approve was made by Regent Phillips, seconded by Regent Tilles and passed without objection.

College and Career Readiness Working Group

Your College and Career Readiness Working Group held its scheduled meeting on December 13, 2010. All members were present.

Matters Not Requiring Board Action

Potential Revisions of High School Graduation Requirements – the Committee continued its discussion of the possible policy directions for the Regents to consider as they continue their discussions on how to prepare students for college and careers. Senior Deputy Commissioner John King presented information on the rationale for the proposed changes, policy directions for consideration - including increased flexibility to improve student outcomes, and possible enhanced strategies to increase graduation requirements. Department staff will begin to engage stakeholders on the development of these ideas through regional forums being held around the State to provide comment and feedback on impact, sustainability, capacity and timelines related to these possible policy directions. The regional forums will begin in early January and run through February. [CCR (D) 1]

Joint P-12 Education and Standards Work Group

Your P-12 Education Committee and Standards Work Group held a joint meeting on December 14, 2010. All members were present.

Matters Not Requiring Board Action

Update on the Common Core State Standards – The Committee discussed recommended additions to the Common Core State Standards for ELA and Math. The recommendations come following a five-week period of statewide public feedback responded to by over 800 teachers, parents, school administrators, and other stakeholders. A survey is currently underway seeking comments on the PreK standards. Survey results will be analyzed and necessary edits made based on public input. The Committee discussed an online Request for Information due at the end of the month, the results of which will shape the Request for Proposal for development of Curriculum Models. Also discussed was the timeline for development and implementation of the curriculum models for PreK-12 ELA and Math and the timeline for integrating the Common Core into our State assessments. In January, staff will present two sets of new PreK-12 standards (ELA and Math), which include the Common Core and NYS standards, and a summary of the public survey data. [P-12/SW (D) 1]

Your P-12 Education Committee held its scheduled meeting on December 14, 2010. All members were present.

Action Items

Charter School Actions

Your Committee recommends that the Board of Regents issue charter renewals for the following Charter Schools authorized by the Board of Regents:

- Brighter Choice Charter School for Boys that a second renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2015. The Regents action for the Brighter Choice Charter School for Boys will become effective on January 11, 2011.
- Brighter Choice Charter School for Girls that a second renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2015. The Regents action for the Brighter Choice Charter School for Girls will become effective on January 11, 2011.
- Bronx Charter School for Children that a second renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2016. The Regents action for the Bronx Charter School for Children will become effective on July 1, 2011.
- Elmwood Village Charter School that a first renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2015. The Regents action for the Elmwood Village Charter School will become effective on January 11, 2011.
- Harlem Success Academy Charter School that a first renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2015. The Regents action for the Harlem Success Academy Charter School will become effective on January 11, 2011.
- Harriet Tubman Charter School that a fifth renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2016. The Regents action for the Brighter Choice Charter School for Boys will become effective on July 1, 2011.
- Charter School for Applied Technologies that a second renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2015. Pursuant to Education Law Section 2851(4)(d), the Board of Regents waives the deadline for submission of a charter renewal application for the Charter School for Applied Technologies and accepts the renewal application submitted by the school on September 17, 2010. The Regents action for the Charter School for Applied Technologies will become effective on January 11, 2011. [P-12 (A) 1]

Your Committee recommends that the Board of Regents issue the initial charters and provisional charters for the following Charter Schools for a term of five years in accordance with §2851(2)(p) of the Education Law:

- Amani Public Charter School
- Democracy Prep III Charter School
- Discovery Charter School
- Launch Expeditionary Learning Charter School
- Mott Hall Charter School
- New York City Montessori Charter School
- Urban Dove Charter School

The Regents action for these charter schools is effective immediately.

Regent James Tallon abstained from the vote for the Amani Public Charter School not on the merits of the application, but because of the methodology used to forecast potential fiscal impact on the school district of location.

The application for the Lamad Charter School referenced in the Regents item was withdrawn by the applicant on December 10, 2010, which was subsequent to the written item being finalized, sent to the Regents and posted on the web. [P-12 (A) 2]

Your Committee recommends that the Board of Regents approves and issues the proposed charters for the following Charter Schools as proposed by the Trustees of the State University of New York (SUNY) and issues a provisional charter to them for a term of five years, up through and including December 13, 2015:

- Boys Preparatory Charter School of New York
- East Harlem Scholars Academy Charter School (originally approved by SUNY Board of Trustees as EHTP Pact Charter School)
- Explore Excel Charter School

- Heketi Community Charter School
- The New Visions Charter High School for the Humanities
- The New Visions Charter High School for Advanced Math and Science
- Our World Neighborhood Charter School II
- Innovate Manhattan Charter School

The Regents action for these charter schools is effective immediately.

Age Eligibility and Four-Year Limitations for Senior Athletic Competition – Your Committee recommends that subclause (1) of clause (b) of subparagraph (ii) of paragraph (7) of subdivision (c) of section 135.4 of the Regulations of the Commissioner of Education be amended, and that clause (d) of subparagraph (ii) of paragraph (7) of subdivision (c) of section 135.4 of the Commissioner's Regulations be added, as submitted, effective January 5, 2011, as a permanent rule. Your Committee further recommends that subclause (1) of clause (b) of subparagraph (ii) of paragraph (7) of

subdivision (c) of section 135.4 of the Regulations of the Commissioner of Education be amended, and that clause (d) of subparagraph (ii) of paragraph (7) of subdivision (c) of section 135.4 of the Commissioner's Regulations be added, as submitted, effective December 26, 2010, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to ensure that the emergency rule adopted at the October 2010 Regents meeting remains continuously in effect until the effective date of its adoption as a permanent rule, and thereby avoid disruption to the administration of the waiver process for participation in senior athletic competition by students with disabilities during the 2010-2011 school year. Motion for Action by Full Board

Madam Chancellor and Colleagues: Your P-12 Education Committee recommends, and I move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on December 14, 2010, copies of which have been distributed to each Regent.

Matters Not Requiring Board Action

Revised Comprehensive English Regents Exam: Standards Revisitation Update – The Committee discussed steps taken by the Department to maintain the rigor of the Comprehensive English Regents Examination. The discussion focused on the changes made to the format and composition of the test and how the development of the new exam concentrated on maintaining the validity and consistency around the content being assessed. A memo providing an overview of the changes made and the steps taken to maintain rigor on the newly revised English Regents exam has been widely distributed to field to inform school officials, teachers, parents and students. [P-12 (D) 1]

PLA Update – The Committee was given an update on the Department's efforts to support districts to intervene in their persistently lowest-achieving (PLA) schools. Discussion focused on the transformation models that PLA schools are required to implement and the impact that School Improvement Grant and RTTT funding have had on that implementation. The Committee also discussed the Commissioner's December 9 release of SURR/PLA schools identified for the 2010-11 school year. [P-12 (D) 2]

Students with Disabilities Regulations – The Committee discussed proposed amendments to regulations that would change the term "mental retardation" to "intellectual disability." Following a multiple-state survey of disability classifications and seeking input from members of the Commissioner's Advisory Panel for Special Education Services, it was determined that replacing the term "mental retardation" with "intellectual disability" ensures the Commissioner's regulations are consistent with the terminology used in federal law and addresses issues of respect and dignity for individuals with disabilities. The amendment would also make other technical revisions.

The proposed amendment will come back to the Committee in March for approval. [P-12 (D) 3]

Online Learning – The Committee discussed proposed amendments to regulations that would award units of credit for online and blended courses by allowing school districts to provide students with opportunities to earn course credit through alternative pathways. The proposed policy is intended to provide guidance to public school districts and BOCES interested in offering new learning opportunities for students through online instruction. The discussion focused on a statewide survey conducted last spring directed at district level leaders and high school-based staff in New York State's public schools. The survey revealed that 59 percent of respondents stated that online learning options are currently used as a strategy for academic improvement initiatives. The Committee also discussed steps that school districts and BOCES must take to ensure readiness and evidence they must demonstrate to show that online course preparations are well underway. Staff will develop proposed amendments to regulations for the Committee to discuss at the March 2011 meeting. [P-12 (D) 4]

Consent Agenda Items – Senior Deputy Commissioner King discussed the following item on the full Board consent agenda.

Elimination of Certain State Assessments - The proposed amendment implements recent decisions made by the Board of Regents to eliminate certain State assessments as a cost-saving measure in the administration of State assessments and ensures that students have continued opportunity to earn diploma credit in Languages other than English prior to grade 9 and meet State learning standards despite the elimination of these examinations.

Cultural Education

Your Committee on Cultural Education Committee had its scheduled meeting on December 14, 2010

In attendance were: Regents Tilles, Brooks-Hopkins and Dawson. Absent: Regents Rosa and Bendit. In addition to CE Committee Members, in attendance were: Commissioner Steiner, Senior Deputy King and Chief of Staff James Baldwin

Items For Discussion

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting with an update on the newly established Board of Regents Ad hoc Advisory Committee on Deaccessioning.

A list of committee members was distributed to CE Committee members. The first meeting is scheduled for December 15, 2010 and will be held in the Regents Room, EB from 10:00 a.m. to 3:00 p.m.

Regent Tilles also described a project on Long Island that seeks to involve arts institutions, teachers of art and higher education professionals involved in the training of

art teachers. The project will host a conference in the Spring of 2011 to discuss approaches to improving arts in education and arts education.

Deputy's Report: Deputy Commissioner Jeffrey Cannell greeted everyone and briefly spoke about the Deputy's OCE Monthly Report that was distributed prior to the meeting.

CE (D) 2 - 2020 Vision - Developing New York's Ten Year Plan for Library Services

The Deputy Commissioner introduced Mary Muller, Regents Advisory Council (RAC) member, who provided a brief update on the recent New York Library Association (NYLA) conference and a detailed report on the current project of the RAC to develop a new ten-year plan for library services in New York. Ms. Muller remarked that libraries are and will continue to be collaborative, cooperative and inclusive. After her presentation, Regent Tilles asked Ms. Muller whether there were opportunities for more formal collaboration between public libraries and the P-12 community and urged continued focus on establishing stronger collaboration and ties between the communities.

CE (D) 1 - Report from the Local Government Records Advisory Council (LGRAC).

The Deputy Commissioner introduced Chris Ward, State Archivist. Ms. Ward provided an overview of LGRAC, which provides advice and guidance to the State Archives, the Board of Regents and Commissioner of Education on records programs and issues in New York's local governments. She also described the Local Government Records Management Improvement Fund, which provides funding for grants and advisory services to local governments to help establish records management programs.

Ms. Ward introduced Geoff Williams, University Archivist at SUNY at Albany and a member of LGRAC. Mr. Williams reported on his work as a member of the program evaluation of LGRAC. He highlighted current considerations and directions for advisory services as well as grants to local governments for records management. Changes are necessary as advances in technology change the way in which local governments conduct business and make information available. In addition the program is challenged as budgets diminish and fewer dollars are available for the competitive grants program. Mr. Williams highlighted four areas recommended by LGRAC for future focus of the local government records program:

- Managing records in electronic form
- Storage and access to archival records
- Disaster recovery and preparedness
- Shared services

Professional Practice

Your Professional Practice Committee held its scheduled meeting on December 14, 2010. All Committee Members were present. Chancellor Merryl H. Tisch was also present, but did not vote on any case or action.


- Costs (e.g., substitutes, stipends) associated with participation in NYS-sponsored professional development activities to implement optional statewide curricula and curriculum-embedded formative assessments based on enhanced New York State Standards (including the Common Core Standards), including professional development in using information systems that track assessment outcomes.
- Costs (e.g., substitutes, stipends) associated with participation in NYS-sponsored professional development activities to implement Response to Intervention (Rtl).
- Development of local and formative assessments across all grade levels and subject areas to meet student instructional needs (consistent with New York State Standards) and the provisions of Education Law § 3012-c, consistent with Commissioner's regulations
- Costs associated with implementing school-based Inquiry Teams.
- Develop, implement or enhance a local instructional improvement system or best practice sharing system that is aligned with the State's instructional reporting and improvement system, including costs associated with training and professional development.

Delivering the tools to increase college and career readiness

- The delivery mechanism for professional development and technical assistance for the state-sponsored initiatives
- Teams of expert support in Curriculum, Instruction and Data
 - SED recommended levels, but regionally determined
- Coordinate with school-based Inquiry Teams
- Participate in NYSED-sponsored professional development
 - Annual training of senior facilitators in content and measurement
 - Quarterly trainings based on feedback and metrics
 - Specific interventions as needed
- Implemented by July 1, 2011
 - First training in July, 2011



Network Team Equivalents (NTEs)

- Option for BOCES and LEAs focusing on capacity to deliver
- Must certify:
 - (1) services of comparable scope and quality;
 - (2) report regularly on performance and outcomes; and
 - (3) participate in NYSED-sponsored professional development
- If approved, LEAs may use up to 75% of allocations for other Allowable Activities

The Urgency of the Work

Performance of the United States in the Program for International Student Assessment (PISA)

- Background
 - •PISA assesses the ability of 15-year-old students to extrapolate and apply their knowledge to novel situations
- Outcomes for United States compared to 65 other countries
 - Average performance
 - •reading (14th)*
 - •science (17th)
 - Below average performance
 - mathematics (25th) *
- The Notable Gap
 - •A notable gap exists between the top 10% and the bottom 10% of 15-year olds in the U.S
 - •Fifteen-year-olds in the United States tend to rate themselves comparatively highly in academic performance in PISA, even if they did not do well comparatively

^{*}Student performance in reading and mathematics has remained broadly unchanged since 2000 and 2003



The Urgency of the Work

PISA's conclusions from *Strong Performers and Successful Reformers**

- •A strong performer is a country that has made education a priority
- •High performing education systems do not refrain from setting out clear and ambitious standards. They are focused on the acquisition of complex, higher order thinking skills, which they align across the system
- •Teachers' quality pays. Strong education systems pay careful attention to the profile of their teachers. Much like corporations, they make sure that their teaching force is the best.
- •High performing systems allow schools discretion in tailoring daily instructional content to their specific student populations.
 - •PISA shows that autonomy is closely related to school performance, provided that this is achieved under conditions of effective accountability.
- •Equity is key. World class education systems:
 - •Deliver high quality learning consistently across the entire education system
 - •Invest educational resources where they can make the most difference:
 - by attracting the most talented teachers into the most challenging classrooms
 - •by making effective spending choices that prioritize the quality of teachers.
