**SUMMARY**

**Issue for Consent Agenda**

**Procedural History**

Section 6506(5) of the Education Law and Section 24.7 of the Rules of the Board of Regents authorize the Regents to waive education, experience and examination requirements for a professional license as well as to confer the degree Doctor of Medicine.

**Background Information**

There are nine licensing petitions and 26 requests for the conferral of the degree Doctor of Medicine for review and approval.

It is recommended that the Regents approve the recommendations of the Committee on the Professions regarding licensing petitions and degree conferrals.

**CERTIFIED PUBLIC ACCOUNTANCY**

Petition for: Acceptance of passing grades on the Uniform Certified Public Accountancy Examination as required by Section 7404 of Education Law and Part 70 of the Commissioner's Regulations.

Statement of Problem: The candidates listed below were impacted from the closure of the testing site due to the weather event in the Northeast on March 7, 2018. Both applicants scheduled and attempted to sit for their final part on that day, which was within their 18-month testing window, but could not because the testing site had to close due to the weather. The applicants rescheduled their final section of the Examination in the next available testing window and both passed their final section.

The Executive Secretary of the State Board for Public Accountancy recommends that petition to waive the 18-month requirement to pass all four parts of the Uniform CPA Examination be approved, given that these candidates were prevented by this extenuating circumstance that was not within their control.

Statement of Problem: Regulations of the Commissioner require an applicant for licensure in dentistry to complete an acceptable preprofessional education program of at least two years in length (including courses in general chemistry, organic chemistry, biology or zoology, and physics) and an acceptable professional dental education program of at least four years in length, for a total of six years of preprofessional and professional education.

Dr. Tonakanyan completed a five-year professional dental education program at I.M. Sechenov First Moscow State Medical University in Moscow, Russia. Therefore, she lacks one year of education which is in the preprofessional area.

However, Dr. Tonakanyan also completed a two-year residency in Maxillofacial Surgery from September 2012 until September 2014 at Central Research Institute of Dentistry and Maxillofacial Surgery in Moscow, Russia. Part §24.3(a)(2) of the Rules of the Board of Regents states that the Committee on the Professions may accept completion of a professional program which is deemed acceptable by the department.

Additionally, an applicant who completed a program of dental education in an unregistered or unaccredited dental school must complete the required two academic years of study in an accredited dental school program, culminating in certification that the applicant has achieved the level of knowledge and clinical proficiency expected of a graduate of that school. Dr. Tonakanyan enrolled in the two-year advanced Education in General Dentistry at the Eastman Institute for Oral Health of the University of Rochester and completed the program in June 2018. This program is acknowledged by the State Board for Dentistry as the substantial equivalent of the two-year program required in Regulation.

Petition for: Endorsement of his medical license from Italy.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Representatives from the State Board for Medicine have reviewed the documentation submitted in support of Dr. Bernardo's application. The Executive Secretary of the State Board for Medicine recommends that Dr. Bernardo's Italian residency between 1991 and 1994 and Scottish Fellowship between 1994 and 1996 be accepted as the substantial equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the licensure, proficiency, and clinical competency requirements for licensure by endorsement. Dr. Bernardo obtained his medical license in Italy in July 1990. His Italian license is active and in good standing. Dr. Bernardo is ECFMG certified and became a Diplomate of the Italian Board of Neurosurgery in December 1996.

The Executive Secretary of the State Board for Medicine recommends that Dr. Bernardo's Italian license be endorsed, and his ECFMG certification and Diplomate certifications be accepted to fulfill the proficiency examination and the clinical competency requirements for endorsement.

Petition for: Endorsement of his medical license from Italy.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Representatives from the State Board for Medicine have reviewed the documentation submitted in support of Dr. Latib's application. The Executive Secretary of the State Board for Medicine recommends that Dr. Latib's South African postgraduate training between 1997 and 2005 be accepted as the substantial equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the licensure, proficiency, and clinical competency requirements for licensure by endorsement. Dr. Latib obtained his medical license in Italy in September 2009. His Italian license is active and in good standing. Dr. Latib has a Masters in Interventional Cardiology, is a Fellow of the College of Physicians of South Africa as of May 2002 and received a Certificate in Cardiology from the College of Physicians of South Africa on October 2005.

The Executive Secretary of the State Board for Medicine recommends that Dr. Latib's Italian license be endorsed, and his Masters, Certificate and Fellowship certification be accepted to fulfill the proficiency examination and the clinical competency requirements for endorsement.
