Announcement of the 2021 Teacher of the Year

Vice Chancellor Brown and Interim Commissioner Rosa opened the Teacher of the Year Awards (Attachment I and II.)

Regent Elizabeth S. Hakanson introduced finalist Sara Bambino, who teaches English in the North Syracuse Central School District in 1990. She also teaches an elective course titled *Team Building and Emotional Intelligence*, which she developed herself.

Regent Josephine Victoria Finn introduced finalists James Brown and Chelsea Dyer. Mr. Brown is a teacher in the South Colonie Central School District and began teaching in 1993. He currently teaches renewable energy to 5th graders and robotics and programming to 6th graders.

Ms. Dyer teaches in the East Greenbush Central School District. Since 2008, she has shared her enthusiasm for reading, writing, and creative expression with all her students. Her work with the Capital District Writing Project has encouraged her students to value writing in and out of the classroom setting.

Regent Roger Tilles introduced finalist Victoria Gentile. Since 2002, Ms. Gentile has served as a special educator and behavior specialist in the Kings Park Central School District. She is a certified special education teacher and licensed behavior analyst.

STANDING COMMITTEE REPORT

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on September 14, 2020. All members participated in the meeting by video conference call. Vice Chancellor T. Andrew Brown also participated but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 55 consent order applications and 19 surrender applications be granted, with Regent Catherine Collins abstaining in one of those consent application cases (Cal. No. 31742).

These recommendations are made following the review of 78 cases involving twenty-five registered professional nurses, nine licensed practical nurses, six licensed practical nurses who are also registered professional nurses, four certified public accountants, three pharmacists, two chiropractors, two licensed master social workers, two licensed master social workers who are also licensed clinical social workers, two registered professional nurses who are also nurse practitioners (Psychiatry), one architect, one dentist, one land surveyor, one licensed clinical social worker, one massage therapist, one midwife, one physical therapist assistant who is also a physical therapist, one podiatrist, one registered dental assistant, one registered professional nurse who is also a nurse practitioner (Family Health), and one respiratory therapist.

RESOLUTION

Professional Practice Committee Co-Chairs Regent Wade S. Norwood and Regent James E. Cottrell provided remarks on the passing of Seymour I. Schwartz, M.D. Dr. Schwartz was a longtime University of Rochester physician, surgeon, teacher and author. He was appointed in 2011 as one of the original members of the Regents' Advisory Committee on Long-Term Clinical Clerkships, a position he held until his death (Attachment VIII). The Co-Chairs directed that the Resolution be sent to Dr. David C. Linehan, Chair of Surgery at the University of Rochester Medical Center.

The members of the Board of Regents commemorate and celebrate the life of Seymour I. Schwartz, MD, longtime University of Rochester physician, surgeon, teacher and author, who died August 28, 2020.

Dr. Schwartz was a surgeon of true international renown. He authored the textbook, Schwartz's Principles of Surgery, now in its 11th edition, known around the globe as the preeminent guide to surgical practice. Additionally, he is credited with hundreds of other publications including books and scientific publications. Dr. Schwartz served as president of three surgical societies: The Society of Clinical Surgery, the American Surgical Association, and the American College of Surgeons. He was editor-in-chief of

Contemporary Surgery for 28 years, the Yearbook of Surgery for 22 years, and the Journal of the American College of Surgeons for 10 years. He had honorary membership in many foreign societies, including the Royal College of Surgeons of Edinburgh, Brazilian College of Surgeons, Mexican Association of General Surgery, Colombian Society of Surgery and Ecuadorian Surgical Society, among others.

Dr. Schwartz began his long and distinguished career in 1950 as a resident at the University of Rochester, an affiliation which lasted 70 years. He served as Professor of Surgery, Chair of Surgery, Director of Surgical Research, and, upon retirement, Distinguished Alumni Professor. He attended medical school at Syracuse University and New York University. In 2005, he was appointed provost of American University of Antigua College of Medicine.

Dr. Schwartz was appointed in 2011 as one of the original members of the Regents' Advisory Committee on Long-Term Clinical Clerkships, a position he held until his death. Designated as a physician who is experienced in the evaluation of medical education programs, he was an invaluable contributor to the Regents efforts to develop and carry out regulations regarding the review and approval of medical schools that wish to send students into New York State to complete more than 12 weeks of clinical clerkship.

Later in his career, Dr. Schwartz developed an interest in cartography, eventually resulting in publication of several prominent books on the subject. Additionally, according to the University of Rochester, Dr. Schwartz was deeply interested in the humanities and was committed to capturing the best about the practice of medicine, resulting in a book called "From Medicine to Manuscript," published in 2018, profiling leaders in the practice of medicine.

The life Dr. Seymour I. Schwartz represents among the best of the New York State professions. His contributions stand as a testament to a life of service, healing and education.

BE IT THEREFORE RESOLVED, on this fourteenth day of September, 2020, that the Board of Regents publicly acknowledges the lifelong contributions of Dr. Seymour L. Schwartz to the State of New York and mourn his passing while also celebrating a life dedicated to the profession of medicine and service to society.

MOVED, that the Resolution in honor of Seymour I. Schwartz, M.D. be approved.

Appendix II

REGENTS ACTIONS IN 79 PROFESSIONAL DISCIPLINE CASES AND 2 RESTORATION PETITIONS

September 14, 2020

The Board of Regents announced disciplinary actions resulting in the revocation of 1 license, surrender of 18 licenses and 1 license that was originally issued as a certificate, and 58 other disciplinary actions. The penalty indicated for each case relates solely to the misconduct set forth in that particular case. In addition, the Board acted upon 2 restoration petitions.

I. REVOCATION AND SURRENDERS

Massage Therapy






James Brown South Colonie Central School District



- In July, NYSED collaborated with the Governor's Office to issue two FAQs to clarify health and safety issues.
- The P12 Program Areas have developed additional FAQs that will be posted on NYSED's Reopening Guidance website.

Reopening Plans: In-person, Remote, or Hybrid?

- On September 9th,NYSED issued the 2*020-21 School Reopening Instructional Models* survey through the SED Monitoring and Vendor Reporting System ("the Portal") to collect information about the reopening models that will be deployed at each school/site.
- The survey was published to all BOCES, School Districts, Charter Schools, Special Act Districts, 853 schools, 4201 schools, 4410 programs, and State Operated Schools – more than 1300 entities.
- This short survey will collect the following school/site information:
 - the first calendar day of school for 2020-21;
 - the instructional model (in-person, hybrid, or remote)
 reflected in the most recent reopening plan that was communicated to parents and other stakeholders; and
 - the planned end date for using a fully remote instructional model, if applicable.

Higher Education Guidance Developed and Released



Informed by four virtual regional meetings in early July, attended by almost 900 faculty, administrators, students, staff, and stakeholders, representing more than 170 institutions.



Region 2 Comprehensive Center, led by WestEd, synthesized information gathered at the 4 regional meetings. Additional input was gathered on ThoughtExchange platform.



Higher Ed program offices worked with Office of Professions to develop guidance to best support students and institutions.



Equity and flexibility are at the heart of the guidance, which was issued in early August on the Office of Higher Ed website.



Guidance Issued

"Guidance for New York State Colleges and Universities on Reopening for the 2020-21 Academic Year" was released in August 2020.

This document will be updated periodically.

Guidance Highlights

- **Health & Safety:** Colleges were required to file health & safety plans before re-opening. Plans required protocols related to: Re-opening, Monitoring, Containment, Shutdown Contingencies.
- Academics: Institutions have flexibility to offer online courses for Fall 2020 semester.
- Financial Aid: Institutions may shorten Fall 2020 and Spring 2021 semesters from a minimum of 15 weeks to no less than 12 weeks without impacting student eligibility for NYS financial aid.
- Educator Preparation Program Clinical Experiences: Programs may use alternative models
 which include clinical simulations, analyzing videos of best practice, and assisting cooperating
 teachers with remote or virtual learning.
- **Professions Clinical Experiences:** Programs may request consideration of flexibilities related to professional licensure clinical experiences, such as extended timelines for completing clinical hour requirements or alternative methods appropriate to the profession (simulation, tele-practice/tele-supervision, etc.). In order to ensure public safety, clinical experiences must be consistent with regulatory standards.

Recent Executive Order ~ Reporting COVID-19 Cases to NYSDOH

Every higher education institution, including but not limited to community and junior colleges, universities, graduate and professional schools, medical schools, and technical schools, shall report to the Department of Health, on a daily basis, in a form and manner to be determined by the Department, all COVID-19 testing and diagnoses among any on-campus students, teaching staff, and any other employees or volunteers. Such daily report shall include any other data elements as the Commissioner of Health determines to be appropriate to track outbreaks of COVID-19 within such higher education institutions, and provided further, that additional notification to the Department of Health is required once an institution reaches 100 positive cases.



COVID-19 Emergency Regulations Part V & Further Regulatory Flexibility for the Reopening of Schools

September 14, 2020



COVID-19 PANDEMIC

- As a result of the pandemic and the Governor's numerous Executive Orders, the Department adopted emergency regulations at the April, May, June, and July 2020 Board of Regents meetings to address the issues resulting from the interruptions caused by the COVID-19 crisis and to plan for the reopening of schools.
- The Department is proposing further regulatory changes to provide additional flexibility to the field and students during this crisis, to address anticipated issues resulting from the continued interruptions caused by the COVID-19 crisis and to prepare for the reopening of schools.

Professions

• Renewal of Limited Permits for Medical Physics

Commissioner's regulations are amended to permit the Department, in its discretion, to renew limited permits for medical physics for additional two-year periods beyond the current limit of no more than six years total, for good cause shown, as determined by the Department.

Higher Education

Accreditation of Educator Preparation Programs

- The Commissioner's regulations are amended to provide additional time for institutions of higher education to complete the process for accreditation of their educator preparation programs from the time they notify the Department that they are seeking accreditation from a professional education accrediting association acceptable to the Department that is seeking recognition from the Council for Higher Education Accreditation or the United States Department of Education.
- Such institutions would now have six years, instead of five, to complete the accreditation process

Bilingual Education: Seal of Biliteracy

Seal of Biliteracy

• The Commissioner's regulations are amended to provide that students who were unable to take Regents exams due to COVID-19 related cancellations will satisfy criteria for the New York State Seal of Biliteracy (NYSSB) that would have been met by the required June 2020 or August 2020 Regents exam(s), provided that such students have been exempted from the applicable Regents exam(s).

Bilingual Education (Seal of Biliteracy Continued)

Seal of Biliteracy

- Additionally, the Commissioner's regulations are amended to provide that English Language Learners (ELLs) will satisfy criteria for the NYSSB that would have been met by a 2020 NYS English as a Second Language Achievement Test (NYSESLAT) score through a combination of having achieved an English language proficiency level of Transitioning or Expanding on the 2019 NYSESLAT or NYS Identification Test for ELLs (NYSITELL) and who earned credit in a course of study for English as a New Language or Bilingual Education in the 2019-2020 school year.
- This change provides parity for students who would otherwise be disadvantaged to earn the NYSSB due to cancelation of the 2020 NYSESLAT.

Bilingual Education (Seal of Biliteracy Continued)

Seal of Biliteracy

• Finally, the Commissioner's regulations are amended to update the NYSSB's NYSESLAT score requirement. Prior to the 2015-2016 school year, the method of determining a student's English language proficiency level was based on separate proficiency levels for each of the four language modalities. Beginning with the 2016 administration of the NYSESLAT, the method for determining a student's English language proficiency level was changed to be based on a single scale score reflecting English language proficiency overall. The proposed new language will reflect this updated score reporting by allowing students to apply a NYSESLAT scale score of 290 towards the NYSSB. The Department has determined this score to be equivalent to the previous requirement of achieving the commanding proficiencylevel in two separate modalities.

Bilingual Education: ELL Identification

ELL Identification

• Commissioner's regulations are amended to provide that for the 2020-2021 school year, any parent of a student who attends a school which is operating fully remotely or have opted to have their child receive instruction fully remotely in accordance with the district's reopening plan, and whose child has been provisionally identified as an English Language Learner, may submit a waiver of the administration of the English language proficiency identification assessment.

Bilingual Education (ELL Identification Continued)

ELL Identification

- If a parent submits such waiver, their child will remain initially identified as an ELL for the 2020-2021 school year, unless the school such child attends changes to in-person or hybrid instruction during the school year, or the parent has opted to no longer have their child receive instruction entirely remotely.
- If either situation occurs, the student must be administered the English language proficiency identification assessment within 10 days of such occurrence.

AP and IB Reporting

- Although the greatest care has been taken to ensure that our data are up to date and accurate, the Department is providing these data as is, as the data are believed to be the best available data submitted to the Department by schools and districts in the Student Information and Repository System.
- The Office of Information and Reporting Services (IRS) works with statewide Level 1 regional centers, districts, College Board, and the International Baccalaureate (IB) to facilitate the collection of better data.
- IB course data is based on the number of approved schools by IB. There are fewer IB students than the AP as all IB schools must complete a rigorous approval process.





Summary of Findings

- Regardless of district community type (e.g. large city, small city) or school district wealth (Needs Resource), more females than males were enrolled in AP courses.
- There were more differences among race and ethnicity groups participation in AP courses, with more Asian students enrolled in AP courses as compared to all race and ethnicity subgroups. The differences in race and ethnicity were not as evident in IB course participation.
- There were fewer economically disadvantaged students in AP and IB courses regardless of district type when compared to the overall population.
- There were fewer Students with Disabilities and ELL students in AP course enrollment when compared to the overall population.





2020-21 Approach

- Department-wide
- Initiatives would have provided critical resources for:

 - Libraries, museums and the professions
- However, only a few of these initiatives were included in the enacted 2020-21 budget.



2021-22 Approach

In light of the enormity of the state's budget deficit due to the COVID pandemic:

Should the Regents consider developing a more streamlined, targeted set of proposals for 2021-22 that focuses primarily on addressing district and student needs related to the pandemic?



2021-22 Approach

Potential initiatives under this approach could include to:

- Expand flexibility for school district reserve funds;
- Support district fiscal viability through improvements to the district merger process;
- Provide aid to school districts to educate students at or over the age of 21 as a result of educational disruptions due to the pandemic;
- Change reimbursement rules for transportation and building aids to reflect the unforeseen impact of the pandemic and to assist districts in safely reopening schools;
- Provide resources to districts to increase their ability to provide remote education; and
- Relieve districts of unfunded, unproductive mandates.



Next Steps

- The Board decides whether to advance a more targeted set of proposals for 2021-22 or advance a comprehensive package as in prior years.
- Each Board committee begins discussions on proposals to be considered.

DOB Revised Projected Budget Gaps

NYS Division of the Budget (DOB) FY 2021 First Quarterly State Budget Financial Plan August Update projects:

- \$14.5 billion General Fund revenue decline from February forecast
 - \$1.2 decline from April revenue estimate
- A total loss of \$62 billion through FY 2024 as a direct consequence of the COVID-19 pandemic



DOB 20% Withholdings

In the absence of Federal action since enactment of the FY 2021 budget:

- DOB began withholding 20 percent of most local aid payments in June.
- All or a portion of these withholdings may be converted to permanent reductions, depending on the size and timing of new Federal aid, if any.



DOB Aid-to-Localities Reduction Plan

The Updated Financial Plan:

- Continues to include \$8.2 billion in recurring local aid reductions;
- States the earliest DOB expects to transmit a detailed aidto-localities reduction plan to the Legislature is late in the second quarter of the State's FY 2021; and
- States, in the absence of unrestricted Federal aid, DOB will continue to withhold a range of payments through the second quarter of FY 2021.



Payment Approval Process

- Pursuant to DOB direction, on a weekly basis, the Department submits to DOB lists of critical payments requesting approval to pay.
 - Includes statutorily required state aid payments to districts
- To date, DOB has approved paying:
 - 80% of some pending state-funded and special-revenue funded claims
 - 100% of all pending federally funded claims
- Some pending state-funded and special-revenue funded payments remain on hold.



Payment Approval Process

- Pursuant to DOB direction, the Department must request DOB approval prior to obligating appropriated funds.
- DOB required the Department to notify funding recipients that payment of funds could be reduced by a minimum of 20%.

RESOLUTION IN RECOGNITION OF THE PASSING OF SEYMOUR I. SCHWARTZ, M.D

The members of the Board of Regents commemorate and celebrate the life of Seymour I. Schwartz, MD, longtime University of Rochester physician, surgeon, teacher and author, who died August 28, 2020.

Dr. Schwartz was a surgeon of true international renown. He authored the textbook, Schwartz's Principles of Surgery, now in its 11th edition, known around the globe as the preeminent guide to surgical practice. Additionally, he is credited with hundreds of other publications including books and scientific publications. Dr. Schwartz served as president of three surgical societies: The Society of Clinical Surgery, the American Surgical Association, and the American College of Surgeons. He was editor-in-chief of Contemporary Surgery for 28 years, the Yearbook of Surgery for 22 years, and the Journal of the American College of Surgeons for 10 years. He had honorary membership in many foreign societies, including the Royal College of Surgeons of Edinburgh, Brazilian College of Surgeons, Mexican Association of General Surgery, Colombian Society of Surgery and Ecuadorian Surgical Society, among others.

Dr. Schwartz began his long and distinguished career in 1950 as a resident at the University of Rochester, an affiliation which lasted 70 years. He served as Professor of Surgery, Chair of Surgery, Director of Surgical Research, and, upon retirement, Distinguished Alumni Professor. He attended medical school at Syracuse University and New York University. In 2005, he was appointed provost of American University of Antigua College of Medicine.

Dr. Schwartz was appointed in 2011 as one of the original members of the Regents' Advisory Committee on Long-Term Clinical Clerkships, a position he held until his death. Designated as a physician who is experienced in the evaluation of medical education programs, he was an invaluable contributor to the Regents efforts to develop and carry out regulations regarding the review and approval of medical schools that wish to send students into New York State to complete more than 12 weeks of clinical clerkship.

Later in his career, Dr. Schwartz developed an interest in cartography, eventually resulting in publication of several prominent books on the subject. Additionally, according to the University of Rochester, Dr. Schwartz was deeply interested in the humanities and was committed to capturing the best about the practice of medicine, resulting in a book called "From Medicine to Manuscript," published in 2018, profiling leaders in the practice of medicine.

The life Dr. Seymour I. Schwartz represents among the best of the New York State professions. His contributions stand as a testament to a life of service, healing and education.

BE IT THEREFORE RESOLVED, on this fourteenth day of September, 2020, that the Board of Regents publicly acknowledges the lifelong contributions of Dr. Seymour L. Schwartz to the State of New York and mourn his passing while also celebrating a life dedicated to the profession of medicine and service to society.
