# DOH's COVID School Report Card

Issues raised by the field include:


Multiple data sources (e.g., student/staff reports vs. Local Department of Health);

School, Laboratory and LDH reported data results may inadvertently duplicate a

case;

 Increased anxiety in community when LDH report does not match school report card due to time lag in school receiving information; and

 Requirement that schools attest COVID-19 positive cases are verified with the LDH.





# STUDENT ATTENDANCE AND EDUCATIONAL NEGLECT

- Schools must take daily attendance and report it in SIRS.
- Schools should take proactive steps to engage students and families at the first indication of attendance issues.
- SED is working on new codes to accurately reflect attendance instruction modality.
- SED/OCFS will hold a joint webinar on educational neglect and child abuse in a remote setting.



# **Unit of Study Requirements**



#### Grades 7-12

- Revised definition of "unit of study"
  - at least 180 minutes of instruction per week throughout the school year, or the equivalent. Equivalent shall mean at least 180 minutes of instructional time for instruction delivered in a traditional face to face model or through alternative instructional experiences, including but not limited to through digital technology or blended learning, that represents standards-based learning under the guidance and direction of an appropriately certified teacher. Instructional experiences shall include, but not be limited to meaningful and frequent interaction with an appropriately certified teacher; academic and other supports designed to meet the needs of the individual student and instructional content that reflects consistent academic expectations as in-person instruction. Any alternative instructional experience must include meaningful feedback on student assignments and methods of tracking student engagement.

### **Key Question**



Are the instructional experiences, when considered as a whole, comparable in rigor, scope and magnitude to a traditionally delivered (180 minutes/week) unit of study?

# **Instructional Experiences**





- meaningful and frequent interaction with an appropriately certified teacher;
- academic and other supports designed to meet the needs of the individual student; and
- instructional content that reflects academic expectations consistent with those which would be required for inperson instruction.



# Instructional experiences *may* include, **but are not limited to**:

- completing online modules or tasks;
- viewing instructional videos;
- responding to posts or instructor questions;
- engaging with other class participants in an online or phone discussion;
- conducting research;
- doing projects; or
- meeting with an instructor face to face, via an online platform, or by phone.



### Instructional Models for Remote Instruction

### **Synchronous Instruction:**

Teaching and learning that happens in real time with direct simultaneous interaction between teachers and students through video and/or audio.



### **Asynchronous Instruction:**

Teaching and learning that does not happen in real time. Teachers plan activities and lessons that students access at flexible times throughout the day.



### **Student Engagement:**

All models of Instruction must attend to creating experiences that will engage and stimulate student learning and include substantive interaction with teachers.

### **New York State Assessments**

- Uncertainty abounds this school year. Interim Commissioner Rosa and the Department are closely monitoring the situation throughout the State.
- It is early in the school year. Decisions about NYS assessment programs will be informed by data and put the health and safety of students and teachers first.
- Assessments must be given in a fair, equitable and safe manner for all students and teachers. If this cannot be accomplished, NYSED will apply for federal waivers.
- It will not be possible to administer any of this year's State assessments remotely. Therefore, if any tests are administered this school year, they must be in person in school buildings.
- In September, U.S. Secretary of Education Betsy DeVos notified all 50 states that we should not expect
  to receive waivers as was allowed in 2020. However, the political context and public health
  considerations may well change as the school year advances.
- In addition to the State assessments, the National Assessment of Educational Progress (NAEP) has selected approximately 90 schools for the 2021 reading and math assessments.



### **APPR**

LEAs should review their currently approved APPR plans to ensure they are consistent with their plans under an in-person, remote, or hybrid instructional model.

### **Implementation Concerns:**

- LEAs face an ever-shifting public health landscape and fully implementing evaluation requirements may be a challenge this year.
- There is uncertainty regarding the administration of State exams in a remote or hybrid model and could impact an LEA's ability to complete the student performance category of evaluations.

### **Opportunities for Innovation and Adaptation:**

- In May, the Board of Regents permanently adopted new APPR regulations that allow LEAs who desire greater flexibility.
- The plans can be adapted to meet local needs and various instructional models and, likely, would not require a material change to an approved APPR plan.



# **2020-2021 Snow Day Pilot**

- The Department established a one-year pilot to enable school districts to pivot to remote instruction on what would otherwise be a day of school closure due to a snow emergency.
  - Provides flexibility for districts
  - Must be consistent with each district's re-opening educational plan
- This pilot is in effect for the 2020-21 school year, after which the Department will review the outcome of the pilot.
- Districts may participate at their local discretion—snow days may still be held.
- Instruction must be provided for the same length of time as an in-person day.



# **ATTACHMENT II**

COVID-19 Emergency Regulations Part VI & Further Regulatory Flexibility for the Reopening of Schools

October 19, 2020



## COVID-19 PANDEMIC

- As a result of the pandemic and the Governor's numerous Executive Orders, the Department adopted emergency regulations at the April, May, June, July, and September 2020 Board of Regents meetings to address the issues resulting from the interruptions caused by the COVID-19 crisis and to plan for the reopening of schools.
- The Department is proposing further regulatory changes to provide additional flexibility to the field and students during this crisis, to address anticipated issues resulting from the continued interruptions caused by the COVID-19 crisis and to prepare for the reopening of schools.

# Early Learning

• Registration extension for voluntarily registered schools
Commissioner's regulations are amended to provide that any
voluntarily registered nursery school or prekindergarten whose
registration expires in the 2019-2020 or 2020-2021 school year, and
does not receive a required on-site visit from Department staff due to
the COVID-19 crisis will have their registration extended, subject to
revocation for cause and their registration will be up for renewal in
the 2021-2022 school year.

# **Higher Education**

#### Coaching Evaluations

- Commissioner's regulations are amended to provide additional flexibility for temporary coaching candidates of extracurricular interscholastic sports.
- These candidates are required to receive a satisfactory evaluation by the principal or athletic director for each of the preceding three years that they coached in the sport for which a professional coaching certificate is sought.
- The Department permanently adopted amendments at the September 2020 Regents meeting which provided that candidates who held a temporary coaching certificate for the winter 2019-2020 and/or spring 2020 sports season did not have to have receive an evaluation by the principal or athletic director for such sports seasons for professional coaching certification due to the COVID-19 crisis.
- The Department is now proposing to expand the time period during which candidates are not required to receive an evaluation for this certification to include the fall 2020, winter 2020-2021, and spring 2021 sports seasons.

# **Higher Education**

### School Building Leader (SBL) Programs

- At its December 2017 meeting, the Board of Regents approved requiring school building leader (SBL) programs, that are registered or seek registration on or after December 1, 2020, to be aligned with the Professional Standards for Educational Leaders (PSELs), with some modifications.
- Programs have been aligned with the Interstate School Leaders Licensure Consortium (ISLLC) Standards.
- The Department is proposing to amend the Commissioner's regulations to extend the date by which SBL programs must be aligned with the new PSELs until September 1, 2022 to provide SBL programs additional time to conform with the new standards due to the COVID-19 crisis.

# **Higher Education**

## Annual Professional Performance Reviews (APPR)

- The Department is proposing to make a corresponding amendment to the Commissioner's regulations to provide that the definition of "Leadership standards" for purposes of APPR reviews will mean the new PSEL standards for reviews conducted on and after the 2024-2025 school year.
- This amendment aligns the date by which SBL programs must adopt the new PSEL standards with the date the PSEL standards will be used in conducting APPR reviews

#### 2020-21 State Aid Levels

 Final 2020-21 state aid amounts remain uncertain.

 Receipt of additional Federal revenues to offset potential state aid reductions or supplement current school district funding levels are possible.



## **Pandemic Adjustment**

- The 2020-21 enacted budget reduced each major school district's 2020-21 state aid level by the amount of Federal CARES Act funds each school district received (the "Pandemic Adjustment").
- The Federal CARES Act funds were required to be allocated to school districts based on the distribution of Federal Title I dollars. The Title I formula is very progressive, which means the highest need districts in the state receive the most aid. Similarly, the highest need districts experienced the greatest impact from the
   Pandemic Adjustment.

### **Pandemic Adjustment**

- The Federal CARES Act requires school districts to use a portion of their CARES Act allocation to provide equitable services to students and teachers in non-public schools, which prevents districts from being able to fully backfill the reduction in state aid with Federal funds.
- The impact on an individual school district depends on the proportion of the district's students attending non-public schools.



## Repeal of the Pandemic Adjustment

- To address these issues, the Regents could consider advancing a proposal to repeal the Pandemic Adjustment and restore each district's state aid levels to ensure no district experiences an aid loss in 2020-21.
- This would also enable districts to use their Federal CARES Act funds for their intended purpose – to prevent, prepare for, and respond to coronavirus.



### **Transportation**

- In the spring, school districts were required, by Executive Order, to close by March 18, 2020. Executive Orders subsequently extended such closures in two week increments until the Governor announced on May 1, 2020 that schools would be closed for the remainder of the 2019-20 school year.
- As a result, between March 18 and May 1, there was the potential for schools to reopen and school districts needed to keep transportation employees and vendors on standby to be in a position to resume transportation services if schools were directed to reopen pursuant to Executive Order.

### **Transportation**

- In addition, districts were required by Executive Order to provide remote instruction and meals for students during periods of school closure in the spring. Several schools implemented these requirements by using school buses to deliver school meals, homework packets and wi-fi access.
- However, Education Law does not currently permit districts to be reimbursed through transportation aid for transportation that was not provided, or for use of school buses to provide meals, homework and wi-fi.

### **Transportation**

To address these issues, the Regents could consider advancing a proposal to:

- allow districts to be reimbursed for actual costs incurred to keep transportation vendors and employees on standby between March 18, 2020 and May 1, 2020, and
- allow districts to be reimbursed for costs incurred in using school buses to deliver school meals, homework packets and wi-fi access.



#### Potential 2020-21 State Aid Reductions

- An across-the-board state aid reduction would disproportionately impact high-need, low-wealth school districts, as high need districts receive over 69 percent of all formula-based state aid.
- High need districts are heavily reliant on state aid as an overall proportion of their local budget.
- If reductions to 2020-21 state aid levels become necessary, the Regents could consider messaging reductions be made on a progressive basis approach. The Regents could also consider communicating an equitable way in which any reductions are imposed on school districts and on charter schools.

## **Promoting School District Efficiencies**

- Some of the fiscal challenges school districts are facing due to the pandemic have the potential to be addressed through school district mergers or service consolidation.
- The Regents could consider incentivizing such efficiencies through approaches such as indexing the Reorganization Incentive Aid formula to inflation.



#### **Financial Technical Assistance**

- The Department needs additional resources to provide technical assistance to those districts with the greatest fiscal challenges, which have been exacerbated by the pandemic.
- The Regents could consider re-advancing the 2020-21 Regents proposal to provide the Department with additional state operations funds to increase our capacity to provide school districts with technical support on financial and management matters.


