STANDING COMMITTEE REPORTS

CULTURAL EDUCATION

The Cultural Education Committee held its scheduled meeting on October 3, 2022. All members were present except Regent Tilles, Regent Hakanson, and Regent Tanikawa, who were excused. Chancellor Lester W. Young, Regent Wade S. Norwood, and Regent Kathleen M. Cashin also attended the meeting but did not vote on any action.

ACTION ITEMS

New York State Bd. of Regents v. Oscar Davis, et al. [as Trustees of the Mount Vernon Public Library] [CE (A) 1] - The Counsel presented the question of whether the Cultural Education Committee should recommend that the Board of Regents hold a hearing, pursuant to Education Law § 226 (4) and § 3.31 of the Rules of the Board of Regents, for the removal of Oscar Davis Jr., Cathlin Gleason-Boncardo, Hope Marable, Vivien Salmon, and Judy Williams-Davis, as Trustees of the Mount Vernon Public Library.

The Committee recommends that the Board of Regents determine that a hearing in this matter is required, and that the Chancellor convene a hearing panel and designate a chair pursuant, to Education Law §226 and §3.31(u) of the Rules of the Board of Regents forthwith.

The motion passed unanimously.

MOTION FOR ACTION BY FULL BOARD

The Cultural Education Committee recommends, and we move, that the Board of Regents act affirmatively upon the recommendation in the written report of the Committee's deliberations at its meeting on October 4, 2022, copies of which have been distributed to each Regent.

HIGHER EDUCATION

The Higher Education Committee held its scheduled meeting on October 3, 2022. All members were present except Regent Shino Tanikawa, who was excused.

MATTERS NOT REQUIRING BOARD ACTION

Proposed Amendment of Sections 52.21 and 80-3.7 of the Regulations of the Commissioner of Education Relating to the Student Teaching Requirements for Registered Teacher Preparation Programs and Through the Individual Evaluation Pathway to Certification [HE (D) 3] - Department staff presented proposed regulatory amendments to revise the new student teaching requirements for candidates who enroll in a registered teacher preparation program in Fall 2023 or later, including requirements related to the length of student teaching, multiple certificates, full-time status, and library media specialist programs; and extend the timeline to implement the new student teaching requirements for programs, and the corresponding new teaching experience requirements for the individual evaluation pathway to certification, by one year.

Proposed Amendment of Section 87.2(k) of the Regulations of the Commissioner of Education Relating to the Definition of "Prospective School Employee" [HE (D) 1] - Department staff presented proposed amendments to Part 87 of the Commissioner's regulations related to the definition of a "prospective school employee" who must be fingerprinted and cleared for employment by the Department. The proposed revision clarifies that a "prospective school employee" includes an individual who will reasonably be expected by a covered school to provide services which involve communication or interaction directly with students under the age of 21 via digital or audio-based technology.

Proposed Amendment of Section 145-2.4 of the Regulations of the Commissioner of Education Relating to the Deferment of the Declaration of a Major by Matriculated Students for State Financial Air Purposes [HE (D) 2 - REVISED] - Department staff presented a proposed amendment to Commissioner's regulation to extend the time within which a student who enters a 2-year or 4-year college program with a significant number of college credits must declare a major so a not to prematurely disqualify him or her from state financial aid.

Deputy Commissioner William Murphy reviewed the items on the Consent Agenda.

P-12 EDUCATION

The P-12 Education Committee held its scheduled meeting on October 3, 2022. All members were present except for Regent Tilles and Regent Tanikawa who were both excused. Chancellor Young, Regent Collins, Regent Reyes, and Regent Mittler also attended the meeting but did not vote on any action.

ACTION ITEMS

Proposed Amendment of Section 100.5(d)(7) of the Regulations of the Commissioner of Education Relating to Requirements for Members of the Standing Committee for the Regents Examination Appeals Process [P-12 (A) 1] – Revised -Department staff presented, for emergency adoption, proposed amendments to the Commissioner's regulations to address instances where schools do not have the requisite numbers of administrators to serve on the standing committee for Regents Examination appeals.

The Committee recommends that section 100.5(d)(7) of the Regulations of the Commissioner of Education be amended, as submitted, effective October 4, 2022, as an emergency action upon a finding of the Board of Regents that such action is necessary for the preservation of the general welfare to immediately provide regulatory flexibility so that all schools and districts can complete the special appeal process.

The motion passed unanimously. Regent Norwood was absent for the vote.

Proposed Addition of Section 100.22 and Amendment of Section 200.6 of the Regulations of the Commissioner of Education Relating to Instruction Provided to Students in a Home, Hospital, or Institutional Setting Other Than a School (Homebound Instruction) [P-12 (A) 2] - Department staff presented, for emergency adoption, revisions to the proposed addition of section 100.22 and amendment of section 200.6 of the Commissioner's regulations relating to instruction provided to students in a home, hospital, or institutional setting other than a school.

The Committee recommends that section 200.6 of the Commissioner's regulations be amended, and section 100.22 of the Regulations of the Commissioner of Education be added, as submitted, effective October 4, 2022, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to ensure that districts and parents or guardians receive clarity as to the circumstances under which "homebound" instruction may be requested and delivered for the upcoming school year and to ensure the emergency action taken at the September 2022 meeting, remains continuously in effect.

The motion passed. Regent Catania voted no.

Proposed Amendment of Sections 100.19 and 100.21 of the Regulations of the Commissioner of Education Related to Restarting the Accountability System using 2021-2022 School Year Results [P-12 (A) 3] - Department staff presented proposed amendments to the Commissioner's regulations relating to the planned adjustments to the ESSA Accountability system that will be implemented in the 2022-2023 school year following two years of USDE provided waivers that allowed the Department to suspend accountability determinations due to COVID-19 disruptions.

The Committee recommends that sections 100.19 and 100.21 of the Regulations of the Commissioner of Education be amended, as submitted, as an emergency measure, effective October 4, 2022, upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to immediately align the Regulations of the Commissioner of Education with the Department's ESSA Accountability State Plan Addendum.

The motion passed unanimously.

Deputy Commissioner Jason Harmon reviewed the items on the Consent Agenda.

MOTION FOR ACTION BY FULL BOARD

The P-12 Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on October 4, 2022, copies of which have been distributed to each Regent.

PROFESSIONAL PRACTICE

The Professional Practice Committee held its scheduled meeting on October 4, 2022. All members were present except Regent Elizabeth S. Hakanson. Chancellor Lester W. Young, Jr., Regent Kathleen M. Cashin, Regent Judith Chin, Regent Susan W. Mittler, and Regent Roger P. Catania also attended the meeting, but did not vote on any action.

ACTION ITEMS

Professional Discipline Cases [PCC EXS (A) 1-3]

The Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 5 cases. In addition, the Committee recommends, upon the recommendation of the Committee on the Professions, that 19 consent order applications and 5 surrender applications be granted.

These recommendations are made following the review of 29 cases involving eight licensed practical nurses, eight registered professional nurses, one certified public accountant, one dentist, one licensed clinical social worker, one licensed master social worker who is also a licensed clinical social worker, one licensed mental health counselor, one massage therapist, one ophthalmic dispenser, one physical therapist, one physical therapy professional service corporation, one professional engineer, and one veterinarian.

Proposed Amendment to the Title of Part 61 and Section 61.13 of the Regulations of the Commissioner of Education Relating to the Practice Registered Dental Assisting [PPC (A) 1 - REVISED] - Department staff presented for emergency adoption proposed amendments to the Commissioner's regulations to conform them to Chapter 512 of the Laws of 2022, which effective August 17, 2022, amended the Education Law to allow registered dental assistants to place and remove temporary restorations. The proposed amendments will also conform the Title of Part 61 of the Commissioner's regulations to Chapter 390 of the Laws of 2019, which amended the Education Law, effective October 23, 2019, by creating the new legally protected title of "registered dental assistant" and eliminating the prior protected title of "certified dental assistant".

The Committee recommends that the title of Part 61 and section 61.13 of the Regulations of the Commissioner of Education be amended, as submitted, effective October 4, 2022, as an emergency action, upon a finding of the Board of Regents that such action is necessary for the preservation of the public health and general welfare in order to timely implement the requirements of Chapter 512 of the Laws of 2022 and Chapter 390 of the Laws of 2019, which became effective August 17, 2022 and October 23, 2019, respectively.

The motion passed unanimously.

Proposed Amendment to Sections 72.6 and 74.10 and Subparts 79-9.8, 79-10.8, 79-11.8 and 79-12.8 of the Regulations of the Commissioner of Education Relating to Continuing Education Requirements for Psychologists, Social Workers and Mental Health Practitioners [PPC (A) 2 - REVISED] - Department staff presented for adoption proposed amendments to the Commissioner's regulations to require psychologists, social workers and mental health practitioners to complete three continuing education credits on issues related to maintaining appropriate professional boundaries with patients/clients each triennial registration period in order to further the interest of public health and protection. These professional boundary continuing education credits must be taken from Department approved providers.

The Committee recommends that sections 72.6, 74.10, 79-9.8, 79-10.8, 79-11.8, and 79-12.8 of the Regulations of the Commissioner of Education be amended, as submitted, effective October 19, 2022.

The motion passed unanimously.

MATTERS NOT REQUIRING BOARD ACTION

Assistant Commissioner David Hamilton reviewed the items on the Consent Agenda.
