P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on November 18, 2013. All members were present.

ACTION ITEMS

Committee on Preschool Special Education

Your Committee recommends that subparagraph (v) of paragraph (2) of subdivision (a) of section 200.3 and subparagraphs (iv) and (v) of paragraph (2) of subdivision (c) of section 200.5 of the Regulations of the Commissioner of Education relating to the Additional Parent Member of a Committee on Preschool Special Education, be amended as submitted, effective December 4, 2013. [P-12 (A) 1]

Tuition Rate Setting Methodology

Your Committee recommends that the Board of Regents adopt the proposed legislative amendments to the current rate setting methodology as a 2014 state legislative priority and approve the proposed administrative amendments to the current rate setting methodology for the Special Act School Districts and 853 Schools for the 2014-15 school year. A follow-up report on the status on these recommendations would be provided to the Board at the April 2014 meeting. [P-12 (A) 2]

Common Core Transition Regulations

Your Committee recommends that subdivision (g) of section 100.5 and subdivision (b) of section 100.18 of Commissioner's Regulations be amended as submitted, effective November 19, 2013, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to ensure that school districts and students are given sufficient notice to prepare for and

timely implement in the 2013-2014 school year the requirements for transitioning to the Common Core English Language Arts and in mathematics examinations in the following areas: (1) students with disabilities local diplomas; (2) Regents diploma with advanced designation; (3) credit by examination; and (4) transfer credit; and to provide at the local school district's discretion an additional opportunity, at the January 2014 examination administration, for students enrolled in Common Core English Language Arts courses to meet diploma requirements by passing either the Regents Comprehensive Examination in English or the Regents Examination in English Language Arts (Common Core); and to reflect the change in name of the 3-8 performance level descriptors. This item provides technical changes to update the regulations and does not result in any policy changes. It is anticipated that the proposed amendment will be presented for permanent adoption at the February 2014 Regents meeting. [P-12 (A) 3]

MATTERS NOT REQUIRING BOARD ACTION

Safe Schools Update – The Committee was provided with a brief summary of the Safe Schools Task Force meeting held on November 14, 2013. At the November 14 meeting, representatives of the New York City School-Justice Partnership Task Force presented recommendations from a report entitled *Keeping Kids in School and Out of Courts* released in May 2013. Four workgroups were formed and at the end of the day provided recommendations. The four workgroups are: School Culture and Student Engagement; Building Security and Infrastructure; School Safety Reporting and Data Use; and Legislation and Regulations. P-12 Education Committee members made a recommendation that students be invited to be a part of the next Safe Schools Task Force Meeting and that data from the NYC School-Justice Partnership Task Force be provided. The next meeting of the Safe Schools Task Force will be held in mid-winter. [P-12 (D) 1]

Performance Levels on Common Core Regents Exams – At the request of the Board of Regents and the P-12 Education Committee, a detailed description and discussion relating to Common Core Regents Exam Performance Levels was provided. Discussion focused on the Department's recommendations for five performance levels for Common Core Regents Exams – rather than the four performance levels used for the Grades 3-8 ELA and Math assessments. The Committee also discussed the importance of recognizing the socio-emotional issues of students as they relate to college and career readiness.

<u>Common Core Implementation Update</u> – The Committee discussed module development and use, and professional development for teachers as they move to

implement the Common Core standards. The Committee watched a video from the latest Network Team Institute held November 12-15, 2013. Information was provided on the PD kits, which are available on Engageny.org along with other curriculum and instructional materials. The Committee also discussed the importance of parent involvement.

<u>2014 State and Federal Legislative Priorities and Budget Proposals</u> – The Committee discussed the following state and federal legislative priorities and budget proposals for P-12 Education for the upcoming legislative session:

<u>Child Nutrition Initiatives</u> – The Committee was updated on New York State's Child Nutrition Programs. Discussion focused on the Healthy Hunger-Free Kids Act of 2010 which authorizes funding and sets policy for SED's National School Lunch Program (NSLP), the School Breakfast Program (SBP), and the Summer Food Service Program (SFSP). Staff discussed initiatives that are in process or proposed for the near future that support the Act as well as some of the challenges districts are experiencing.

P-12 EDUCATION /HIGHER EDUCATION/ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES) JOINT MEETING

Your P-12 Education Committee, Higher Education Committee and ACCES Committee held a joint meeting on November 18, 2013

Items not requiring action:

<u>Career and Technical Education Teacher Pipeline</u>

Your Committees discussed the expansion of options for individuals seeking secondary Career and Technical Education (CTE) or special subject Arts areas certification. Periodically the Board of Regents reviews certification regulations to determine whether adjustments or enhancements need to be made. Given the priority that the Board has placed on Career and Technical Education, a review is timely.

AUDITS/BUDGET AND FINANCE

The Regents Committee on Audits/Budget and Finance met as scheduled yesterday afternoon, November 18, 2013. Regents Chapey, Dawson, Bendit, Phillips, Tallon, Young, Rosa, Tilles, Brown and Norwood were in attendance.

Items for Discussion

Completed Audits

The Committee was presented with four audits this month. One of the audits was issued by the Office of Audit Services and the remaining three were issued by the Office of the State Comptroller (OSC). Three of the audits were of school districts and one was of a grant contract.

The findings were in the areas of financial reporting, budgeting, payroll, and expenditure documentation.

Audit Follow-up

The Committee was also provided an overview of the efforts the Department makes to ensure that audit findings are addressed and submitted corrective action plans are adhered to. The Office of Audit Services (OAS) maintains a database dedicated to the review of corrective action plans (CAPs) submitted by school districts, BOCES, charter schools and other organizations in response to completed audits. OAS reviews the CAPs and identifies potential audits for follow-up based on the following criteria:

- The audit disallowance is more than \$10M.
- Data reliability audit shows significant inaccuracy (i.e., more than 50% of the data reported is unsupported by district records).
- Significant control deficiencies related to financial practices (i.e., lack of segregation of duties and board oversight resulting in the misuse of funds).
- Final audit reports and CAPs are shared with applicable Department program areas for future action as needed, including request for follow-up.

OAS prepares and submits an annual Audit Plan for Audits/Budget and Finance Committee review. Based on the number of planned audits, availability of staff resources, and identified audits necessitating a follow-up review, OAS conducts follow-up audits accordingly. In 2012, OAS conducted two follow-up audits.

Race to the Top Monitoring Update

Our Chief Financial Officer provided the Members with a draft report from one of the RTTT grant recipients. The report highlights the type of information collected through

the survey tool the Department uses to monitor the RTTT programs. The responses obtained through the survey will provide feedback to the Department as to the progress in implementing the programs by grant recipients as well as the basis for reporting to the Federal government. Further, the responses will be shared with program offices and could be used as a gauge for the need for technical assistance.

2013 Fiscal Report

Our Chief Financial Officer briefed the Members on the Fiscal Report for October. Extensive spending controls continue for all funds. General Fund spending reflects the amounts appropriated in the 2013-14 enacted budget. General Fund accounts are in structural balance with the exception of the Tenured Teacher Hearings (TTH) account. The 2013-14 budget includes a \$6 million appropriation for TTH claims, an increase of \$2.2 million from the prior year. With these additional funds, the deficit at the end of 2013-14 is projected to be \$2.03 million. Special Revenue accounts are all in structural balance on a current year basis and the accumulated negative balance in the Cultural Education Account is being reduced by approximately \$2.2 million.

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on November 19, 2013. All Committee members were present, except for Regent James E. Cottrell who was excused. Regent James C. Dawson was also present but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 5 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 42 consent order applications and 6 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Doreen M. Varrichio-Prine, Registered Professional Nurse, Calendar No. 26269, we recommend that the caption, header, and body in the report of the Regents Review Committee as well as the caption on the blue back to the report all be deemed corrected to read respondent's correct Calendar No. "26641", and not "26441".

These recommendations are made following the review of 53 cases involving thirteen licensed practical nurses, thirteen registered professional nurses, seven certified public accountants, five licensed practical nurses who are also registered professional nurses, three dentists, one chiropractor, one licensed clinical social worker, one nurse

practitioner, one pharmacist, one pharmacy, one respiratory therapist, and one respiratory therapy technician.

Restorations

Your Committee recommends the following:

That the application of Thomas J. Byrne for the restoration of his license to practice as a physician in the State of New York be granted. [PPC EXS (A) 4]

That the execution of the surrender of the registered professional nurse license of Jeanne Marie Eberle be stayed; that she be placed on probation under the Terms of Probation attached to the Report of the Committee on the Professions as Exhibit A; that the period of probation end three years following successful completion of the nursing refresher course required by the Terms of Probation; and that, upon successful completion of the probationary period, her license be fully restored. That the execution of the surrender of Daniel L. Drucker's license to practice as a certified public accountant in New York State be stayed; that he be placed on probation for a period of three years under the Terms of Probation attached to the Report of the Committee on the Professions as Exhibit A; and that, upon successful completion of probation, his license be fully restored. ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting. Regent Tilles remarked

<u>Update on National Core Arts Standards</u> (Discussion)

Deputy Commissioner Jeffrey Cannell, Assistant Commissioner Candace Shyer and staff member Leslie Yolen briefed the Joint P-12/CE Committee members on the current status of the development of core arts standards. The standards are being developed in partnership with the National Coalition for Core Arts Standards (NCCAS). The standards will describe what students should know and be able to do as a result of a quality curricular arts education program. The committee held a discussion about the types of assessments that would be used to measure student performance and were informed that the standards will likely result in a variety of assessment methods which will include performance, portfolio review as well as some traditional assessments. The current timeline anticipates a release of the complete standards in March 2014, which will then be reviewed by the Board for possible adoption.

Report on New York State Public Broadcasters support for the Corporation for Public Broadcasting Initiative, American Graduate

American Graduate is a public media commitment, supported by the Corporation for Public Broadcasting (CPB), to help communities implement solutions to the high school dropout crisis. Public media plays a significant role building individual activity, community capacity, and national awareness. Elizabeth Hood, Director of Educational Television and Public Broadcasting reminded the committee that 20 percent of all state aid to public broadcasters must be used to support educational activities. Katherine Jetter of the Albany-Based public television and radio station WMHT briefed the committee on activities by New York State's public broadcasters to support this initiative. Regent Tilles commented on the direct support to P-12 initiatives that this activity provides.

History Month Activities

Arts and Cultural Affairs Law, Section 57.02, establishes November as New York State History Month. State Historian Robert Weible briefed the committee on the role of the office of State History in supporting and coordinating history programs and supporting the work of the network of officially appointed local government historians. He briefly described programs provided by the Office of Cultural Education and at other institutions statewide celebrating New York State History Month.

The committee agreed to postpone the discussion of public library construction to a future meeting in the interest of time.

Elementary and Secondary Education Act (ESEA) Waiver Renewal Application



History

- **September 2011**: President Obama announced an ESEA regulatory flexibility initiative. In exchange for flexibility, states must:
 - Set College and Career Ready Standards for all students and develop and administer annual, statewide, aligned, high quality assessments that measure student growth.
 - Develop systems of differentiated recognition, accountability and support
 - Support effective teaching and leadership, including implementing a teacher and principal evaluation in which student growth is a significant factor
 - Reduce duplication and unnecessary burden
- October 2011: the Board of Regents directed the Commissioner to submit an ESEA Flexibility Request to the United States Department of Education (USDE) during the second round of submissions.

History (con't)

- February 2012: New York State's ESEA Flexibility Request was submitted.
- May 2012: the USDE approved New York State's Flexibility Waiver Request.
- **September 2013**: USDE offered states with approved ESEA Flexibility Waivers the opportunity to renew the waivers for the 2014-15 and 2015-16 school years.
- **November 2013**: USDE rescinds its September 2013 renewal application process and replaces it with a one year streamlined renewal process for the 2014-15 school year only.

Revised USED Flexibility Waiver Renewal Process

- Submit a letter to USDE requesting an extension for 2014-15 and describe how the waiver has helped the SEA to be more effective and has contributed to improved student achievement.
- Resolve any State-specific "next step" issues as a result of USDE monitoring.

Amending an Approved ESEA Waiver Plan

- States that wish to make amendments to their approved plan to take effect in 2014-15 may do so as part of their renewal process.
- States must consult with stakeholders before submitting a flexibility renewal request that includes amendments.

USDE Flexibility WaixexcRenewal Amendment Recommendations

Strategies to consider adding as amendments to approved waiver:

- Seek permission from USDE to assess students with severe disabilities who are ineligible for the alternate assessment based on their instructional level, rather than chronological age.
- Explore greater flexibility in the testing requirements for English language learners.
- Use data on chronic absenteeism as a factor in accountability designations and report these statistics publicly.
- Have students that pass the advisory panel-recommended CTE exam in addition to ELA or mathematics Regents be included in the Performance Index for ELA or mathematics at Level 3.

USDE Flexibility Waiver Renewal Recommendations

Strategies to consider adding as amendments to approved waiver, continued:

- Require Priority and Focus Schools that are not making progress to use Title I set aside funds to implement Extended Learning Time and Community School Programs.
- Ensure that districts comply with current art, music, and physical education requirements.
- Incorporate into the high school accountability system the growth metrics used for high school principals for evaluation purposes to ensure strong alignment between institutional and school leader evaluation at the high school level.
- Move toward public reporting of college success metrics.

Assessing Students with Disabilities

Strategies to consider adding as amendments to approved waiver:

- Allow districts to administer the State assessments at the students' instructional grade levels as opposed to their chronological grade levels.
- Issue criteria and guidance for the identification of the population of students for whom this flexibility would apply and criteria to identify the instructional levels for ELA and Math for these students.
- Limit the number of grade levels below the student's chronological grade level at which the student could be assessed (e.g., two years).
- Require that the students be assessed at a higher grade level for each subsequent year.
- For ESEA accountability purposes, limit the percent of proficient and advanced scores of those students assessed in accordance with their instructional grade levels.

Assessing English Language Learners

Strategies to consider adding as amendments to approved waiver:

- Seek funding to create Native Language Arts Assessments that will provide districts the opportunity to offer this assessment as a local option when it would best measure the progress of Spanish speaking ELLs.
- Allow Spanish speaking ELLs who have attended school in the US for less than three consecutive years to be tested in Spanish in lieu of the ELA assessment, and on a case by case basis for an additional two years in Spanish if such an assessment would better allow the student to demonstrate their knowledge of language arts.
- Incorporate the NYSESLAT exam into NY's accountability system in order to capture the growth of ELLs in the acquisition of English and give credit accordingly to schools and districts, rather than relying solely on ELA assessment performance for ELLs.

Elimination of Double Testing

A waiver has been submitted to USDE that requests that NYS be permitted to:

- Eliminate the requirement that students in grade 7 and 8 who are enrolled in high school courses and take Regents Examinations also take the Common Core Mathematics Test for the grade in which they are enrolled.
- Use the students' results on the Regents Examination to meet participation rate requirements and include the results in the Performance Index for the school and district in which the students are enrolled.
- Revise the high school Performance Index so that schools and districts only get credit for the performance of students on Regents examinations that are taken after students first enter ninth grade.
- Note: Elimination of "Double Testing" has no effect on the courses or Regents examinations that a student must take in order to graduate from high school.

ESEA Renewal Think Tank

- Think Tank members will be thought partners with the Department as it drafts its renewal application and prepares for future renewals of the waiver.
- Most members of the ESEA Renewal Think Tank also participated in the original ESEA Waiver Think Tank.
- The Think Tank will be divided further into four smaller workgroups:
 - Curriculum and Assessment (focused on Principle 1 of the waiver);
 - Metrics (Principle 2);
 - Supports and Interventions (Principle 2); and
 - Teacher and Leader Effectiveness (Principle 3).
- The workgroups will report back to the Think Tank on their progress at additional meetings scheduled for late November, December, and January.
