# **Issue for Decision (Consent)**

# New York State Independent Living Council, Inc. (New Appointment for term January 1, 2024, to December 31, 2024)

ACCES is recommending one new appointment, resulting from one vacancy on the council.

## Mariah Sepulveda

- Worked with clients, families, social workers, and service providers to manage resource management for Social Security, SNAP benefits, Housing Subsidy Programs, and Home Health Aid.

# New York State Independent Living Council, Inc. (New Appointment for term January 1, 2024, to December 31, 2026)

ACCES is recommending five new appointments, resulting from five members terming off the council, as well as nine reappointments of existing members.

- As the Executive Director of Parent to Parent of NYS, implemented and assisted in the development of the strategic goals and objectives of the statewide organization.
- As the Director of Parent to Parent of NYS, coordinated feedback to OPWDD on implementation of the Front Door Initiative.

- As Employment Counselor for Seneca Nation Employment and Training, assisted Native Americans with training and guidance to achieve gainful employment.
- Facilitated classes and instructed students within house trainings as well as sent them to outside agencies to gain certificates or diplomas, entered them into trade school.
