SUMMARY

Issue for Decision (Consent)

(Kyoto University Faculty of Medicine, Kyoto, Japan, Bachelor of Medicine, March 2007)

<u>Petition for</u>: Endorsement of applicant's medical license from Japan.

<u>Statement of Problem</u>: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Goto lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Goto's application. He recommends that Dr. Goto's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Goto obtained his medical license in Japan in 2007. His Japanese license is active and in good standing. Additionally, Dr. Goto has Board Certification in Internal Medicine issued in December 2010. He has Japanese Society of Internal Medicine certification issued in December 2017 and has a Japan Gastroenterological Endoscopy Board Certified Fellow certification issued in December 2014 and is Board Certified in Gastroenterology issued in January 2014.

The Executive Secretary of the State Board for Medicine recommends that Dr. Goto's Japanese license be endorsed, and his Board Certifications be accepted to fulfill the proficiency and clinical competency examination requirements for endorsement.

<u>Petition for</u>: Endorsement of applicant's medical license from the United Kingdom.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Kulshrestha lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Kulshrestha's application. He recommends that Dr. Kulshrestha's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Kulshrestha obtained his medical license in the United Kingdom in 1998. His British license is active and in good standing. Additionally, Dr. Kulshrestha has Fellowship of the Royal College of Radiologists (FRCR) Certification in Clinical Radiology issued in 2007 after passing the FRCR part 1,2, and 2B examination sequence. He also completed his USLME step one in 2013.

The Executive Secretary of the State Board for Medicine recommends that Dr. Kulshrestha's British license be endorsed, and his FRRCR Certification be accepted to fulfill the proficiency and clinical competency examination requirements for endorsement.

Petition for: Endorsement of applicant's medical license from Taiwan.

<u>Statement of Problem</u>: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Lu lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Lu's application. He recommends that Dr. Lu's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Lu obtained his medical license in Taiwan in 2006. His Taiwanese license is active and in good standing. Additionally, Dr. Lu has ECFMG certification. He has board certification in general surgery since December 2011 with the Taiwan Surgical Association. He is also a board-certified hand surgeon with the Taiwan Society for Surgery of the Hand since May 2013 and is board certified in plastic surgery with the Taiwan Society of Plastic Surgery since November 2013.

The Executive Secretary of the State Board for Medicine recommends that Dr. Lu's license from Taiwan be endorsed, and his Board certifications be accepted to fulfill the clinical competency examination requirements for endorsement.

<u>Summary Statement</u>: The petitioners listed below are all graduates of foreign medical schools who have been licensed in New York.

The applicable requirements of Section 3.57 of the Rules of the Board of Regents require completion of a medical education program in a foreign medical school satisfactory to the Department which does not grant the degree Doctor of Medicine (M.D.), and in which the philosophy and curriculum were equivalent, as determined by the Department in accordance with the policy of the Board of Regents, to those in programs leading to the degree Doctor of Medicine (M.D.) at medical schools in the United States satisfactory to, or registered by, the Board of Regents and the Department. Secondly, petitioners must have licensure to practice medicine in New York State in accordance with provisions of Section 6524 or 6528 of the Education Law or their equivalent as determined by the Board of Regents pursuant to their authority under Section 6506 of the Education Law.
