SUMMARY

Issue for Decisions (Consent Agenda)

Should the Board of Regents approve the proposed appointments and reappointment of members to the New York State Independent Living Council, Inc. (NYSILC).

Reason(s) for Consideration

The 1992 Amendments to the Rehabilitation Act require the Board of Regents to appoint members to the New York State Independent Living Council, Inc.
