SUMMARY

Issue for Decision (Consent)

Should the Board of Regents approve the updates to the attached list of Regents Physician Shortage Areas (Attachment A), as recommended by the New York State Department of Health (DOH), for the 2024 Regents Physician Loan Forgiveness Award Program application cycle?

Reason(s) for Consideration

Required by State statute.

Proposed Handling

The issue will come before the Full Board for action at its January 2024 meeting.

Procedural History

Not applicable.

Background Information

The Regents Physician Loan Forgiveness Award Program offers physicians up to \$10,000 in student loan repayment assistance per year in exchange for serving in an underserved community, as designated by the Board of Regents. The minimum service commitment is two years. Contingent on State funding, the Department will make up to 80 awards to eligible applicants. Award amounts are based on undergraduate and medical school student loan amounts, loan interest expenses, and income.

In 1987, the Board of Regents approved a system for identifying and designating areas of physician shortage for purposes of the Regents Physician Loan Forgiveness Award Program. In September 1995, the Board decided to update this shortage area list annually.

Each year, DOH recommends updates to the list of Regents Physician Shortage Areas. These updates include any modifications to Health Professions Shortage Areas. This year there were only minor updates to the booklet. These changes include updating the names of organizations that had changed their names and/or a few regional changes, where a facility no longer operates in a specific county and/or has expanded service to another county. The text and links have been verified and modified as needed for accuracy.

GENERAL INFORMATION REGARDING REGENTS-DESIGNATED PHYSICIAN SHORTAGE AREAS (RPSAs) IN NEW YORK STATE

Overview

Regents-Designated Physician Shortage Areas (RPSAs) consist of both Health Professional Shortage Areas (HPSAs) as approved by the federal Health Resources and Services Administration (HRSA) and designated healthcare facilities within New York State. Regents Physician Loan Forgiveness Award Program (Regents Program) placements must be located within these defined areas and/or at these designated healthcare facilities.

Primary Care, Emergency Medicine, and Mental Health Regents Physician Shortage Areas

For primary care or emergency medicine physicians not practicing at a designated health care facility, proposed practice sites must be in primary care HPSAs. For psychiatrists not practicing at a designated health care facility, proposed practice sites must be in mental health HPSAs. To be eligible for Regents Program placements, HPSAs cannot be listed as withdrawn or proposed for withdrawal.

HPSAs are defined by whole counties, one or more townships within rural areas, or one or more census tracts within urban areas. In order to determine if an address is in a primary care or mental health HPSA, applicants can use the search tool found at: <https://data.hrsa.gov/tools/shortage-area/by-address>. In order to search a HPSA by County, HPSA name, and/or a HPSA Identification number, applicants can use the search tool found at: <https://data.hrsa.gov/tools/shortage-area/hpsa-find>. If the proposed practice site is in a HPSA, the name and status (among other things) will be listed under the appropriate facility type.

Facilities Designated as Regents Physician Shortage Areas for Primary Care Physicians and Psychiatrists by County

Facilities Designated as Regents Physician Shortage Areas for Primary Care Physicians and Psychiatrists include federally qualified health centers (FQHCs), FQHC lookalikes, and rural health clinics. In this section, applicants can use the search tool found at: <https://data.hrsa.gov/tools/shortage-area/hpsa-find> to find individual facilities by County, Facility name, and/or a Facility Designation Identification number for Regents Program placements for either primary care physicians or psychiatrists. Please note that a small number of these facilities do not directly provide behavioral health services and do not qualify for placements of psychiatrists.

Other Facilities Designated as Regents Physician Shortage Areas for Primary Care Physicians and Psychiatrists

Other types of facilities designated by HRSA are also eligible for Regents Program placements for primary care physicians and psychiatrists. These designated facilities include “Native American/Tribal Facility/Population,” “Other Facility,” (eligibility depends on the type of designation), and “State (and County) Mental Hospital” (psychiatrists only) and can be found at: <https://data.hrsa.gov/tools/shortage-area/hpsa-find>.

Treatment programs funded by the New York State Office of Addiction Services and Supports (OASAS) are also eligible for Regents Program placements and include crisis services, inpatient treatment services, opioid treatment programs, outpatient services, and residential services when those residential services have treatment components. Applicants can identify OASAS treatment programs for potential placement sites at <https://webapps.oasas.ny.gov/providerDirectory/>.

New York State Operated Facilities Designated as Regents Physician Shortage Areas for Primary Care Physicians and Psychiatrists

This section lists New York State facilities operated by the Office of People with Developmental Disabilities (OPWDD), the Office of Mental Health (OMH), and the Department of Corrections and Community Supervision (DOCCS). These facilities are eligible for Regents Program placements for either primary care physicians or psychiatrists.

Hospitals Designated as Regents Physician Shortage Areas for Primary Care Physicians, Emergency Medicine Physicians, and Psychiatrists by County

This section lists hospitals by county with at least 1,000 annual discharges, of which 25% are from self-pay patients, who are Medicaid beneficiaries, or who are supported through the DOCCS and are eligible for Regents Program placements. These hospitals are eligible for primary care, emergency medicine, and psychiatric physician placements.

Critical Access Hospitals Designated as Regents Physician Shortage Areas for Primary Care Physicians, Emergency Medicine Physicians, and Psychiatrists

This section lists critical access hospitals by county that are categorically eligible for the Regents Program for primary care, emergency medicine, and psychiatric physicians’ placements. Applicants can also use the search tool found at: <https://www.flexmonitoring.org/critical-access-hospital-locations-list> to find critical access hospitals by county.

Providers Not Eligible

Physicians who are fulfilling obligations through HRSA’s National Health Service Corps (NHSC) loan repayment or scholarship programs, through New York State Doctors Across New York (DANY), or DANY OMH Psychiatrist Loan Repayment program are not eligible for Regents Program placements.
