Issue for Decision

Should the Regents approve the proposed charter revision for Future Leaders Institute Charter School which is authorized by the Chancellor of the New York City Department of Education (NYCDOE)?

Reason(s) for Consideration

Required by State Statute.

Proposed Handling

This issue will come before the P-12 Education Committee and the Full Board for action at the February 2015 meeting of the Board of Regents.

Background Information

Future Leaders Institute Charter School (or "the School") was first authorized by the Chancellor of the NYCDOE as a charter school to open for the 2005-2006 school year. The School is in the third charter term and was issued a three-year short term renewal in June 2013. The School is currently serving 394 students in Grades K-8 for the 2014-2015 school year. The School is operating at authorized scale.

The Chancellor of the NYCDOE recommends the following actions:

• Create an Assistant Principal position that will have responsibility for the School's upper and lower school grades. The Assistant Principal position will replace the Head of Upper School and Head of Lower School positions.

Recommendation

VOTED: That the Board of Regents finds that the proposed revised charter: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will permit the charter school to operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the above listed charter revision as proposed by Chancellor of the NYCDOE and the provisional charter for the Future Leaders Institute Charter School is amended accordingly.

<u>Timetable for Implementation</u>

The Regents action for the School would take effect immediately.

Revision Background

• The School received a short term renewal in June 2013. At the time of renewal, the School partially demonstrated academic achievement and progress.

- For the past two years of Common Core aligned NYS assessments, the School
 has not performed above the absolute aggregate proficiency of the CSD of
 location in English Language Arts (ELA) and math. Further, the School has not
 performed above its peer group in ELA and math.
- In 2013-2014, 20.1% of Future Leaders Institute Charter School's students were proficient in ELA on the NYS assessments; this placed the School at the 40th percentile citywide as well as of its peer schools. Also in 2013-2014, 29.2% of Future Leaders Institute Charter School's students were proficient in math on the NYS assessments; this placed the School at the 47th percentile citywide and 43rd percentile amongst peer schools.
- The School is co-located in DOE-operated space at 134 West 122nd street, New York, NY 10027. The school is co-located with P.S. 242 The Young Diplomats Magnet School in building M144.
- The school is seeking an enrollment expansion to meet rising demand from future FLI students. In 2014, the School received 2,804 applications total. The school received more than 1,400 applications for 133 open seats in kindergarten alone. The School has 596 students on its waitlist as self-reported by the School in September 2014.
- New students will be added from the lottery in grades K-7, however not grade 8
 as it is a terminal grade. If the lottery does not generate enough students for
 those grades, students will be added from the waitlist.
- Based on self-reported information, the School's primary entry grades are K-1 and 6; however, the school enrolls students in all grades served except grade 8. The School also enrolls students mid-year.
- The School is seeking to increase class size from 24 students per section to 30 students per section
 - This would increase student to teacher ratio from 1:12 to 1:15
 - The school operates under a collective bargaining agreement as a result of being a conversion charter school and has a large number of adults employed by the school.
 - Increasing class size would maximize the use of adults employed by the school but more importantly allow for students to have extensive tutoring and enrichment opportunities.
- In addition to the requested enrollment expansion, the School is seeking to add an Assistant Principal position. The primary reason for this organizational change:
 - The Board would like to return to a traditional vertical school management model that has a Principal overseeing the academic and operational

- programs and a newly appointed Assistant Principal supporting the Principal. This new leadership structure will help ensure clearer lines of accountability and communication.
- The School has already aligned staff in these roles, informally, until the material revision is approved.
