# **ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES)**

Your Adult Career and Continuing Education Services (ACCES) Committee held a meeting on January 13, 2020. All members were present, except for Regent Cea, who was excused.

#### MATTERS NOT REQUIRING BOARD ACTION

Workforce Innovation and Opportunity Act (WIOA) 2020 Combined State Plan – The Committee was provided with information on the development of the New York State 2020 WIOA Combined State Plan. Under WIOA, states are required to develop a strategic plan every four years that focuses on strengthening and improving their respective workforces. The draft 2020 WIOA Combined State Plan builds on the previous plans efforts to improve and strengthen New York State's workforce development system. New York State envisions a unified workforce development system that is regionally coordinated and programmatically seamless, delivering workforce training, business services, and statewide job linkages to all New Yorkers. To implement New York's vision and goals, the partners have and will continue to seek several strategies for the One-Stop Career Center System. These ensure all partners work together to align and coordinate services, providing job seekers and businesses seamless service delivery. In the draft 2020 WIOA Combined State Plan, the partners will continue to work together to implement strategies to further build upon successes and the vision of a unified workforce development system inclusive of education, training and businesses.

### **HIGHER EDUCATION**

#### MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on January 14, 2020, copies of which have been distributed to each member of the Board of Regents.

### **Matters Not Requiring Board Action:**

**Update on the Implementation of the edTPA Teacher Certification Requirement in New York State.** Your Committee heard Department staff present an update on the implementation of the edTPA teacher certification requirement in New York State, including a summary of the reconvened edTPA Task Force work, recommendations made at that

time, and changes that resulted from the recommendations. VOTED: The Committee voted to freeze all subject area New York State edTPA passing scores recommended by the standard-setting panel at the 2018-2019 levels and extend them through January 1, 2020 through December 31, 2021.

Proposed Amendment to Section 80-1.6 of the Regulations of the Commissioner of Education to Allow a Time Extension for the Initial Reissuance and Provisional Renewal. Your Committee discussed proposed amendments to Section 80-1.6 that will allow educators who hold an Initial certificate, Initial Reissuance, Provisional certificate, or Provisional Renewal to receive one Time Extension after the issuance of their first Initial or Provisional certificate. Following the 60-day public comment period required under the State Administrative Procedure Act, it is anticipated that the proposed amendment will be presented to the Board of Regents for adoption at its May 2020 meeting. If adopted at the May 2020 meeting, the proposed amendment will become effective on May 20, 2020.

# **Matters Requiring Board Action:**

Proposed Amendments to Sections 80-3.15 and 80-4.3 of the Regulations of the Commissioner of Education Relating to the Addition of Subject Areas to the Limited Extension and Statement of Continued Eligibility (SOCE) for Certain Teachers of Students with Disabilities and Technical Amendments to the Limited Extension, SOCE, and Subject Area Extensions in Grades 7-12 for Certain Teachers of Students with Disabilities. Your Committee discussed whether the Board of Regents should approve the amendments to the Commissioner's Regulations to add general science and languages other than English to the list of subject areas for the limited extension and SOCE for certain teachers of students with disabilities as well as proposed technical amendments to add certain special education certificate titles to the list of titles eligible for the limited extension, SOCE, and subject area extension in grades 7-12 for certain teacher of student teachers with disabilities. VOTED: that the Board of Regents approve the amendments to Sections 80-3.15 and 80-4.3 of the Commissioner's Regulations, as submitted, effective January 29, 2020.

# Revision to a Charter Authorized by the Board of Regents – School in the Square Public Charter School [P-12 (A) 1]

Your Committee recommends that the Board of Regents find that: (1) the charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the charter school can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to amend the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to amend the charter will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for School in the Square Public Charter School and amends the provisional charter accordingly.

The motion passed. Regents Cashin, Collins, and Mittler abstained from the vote.

# Charter Schools: Renewals to Charters Authorized by the Trustees of the State University of New York [P-12 (A) 2]

Your Committee recommends that the Board of Regents return the proposed charters for Kings Collegiate Charter School, Leadership Preparatory Bedford Stuyvesant Charter School, and Leadership Preparatory Brownsville Charter School to the Trustees of the State University of New York for reconsideration with the following comment and recommendation: Approving the renewal of any charter school years before the expiration of the charter does not allow timely review of the school's educational and fiscal soundness, community support, legal compliance, or means by which the school will meet or exceed enrollment and retention targets for students with disabilities, English language learners, and students who are eligible applicants for the free and reduced price lunch program. The charters should be abandoned, and the schools should be directed to resubmit the application no earlier than one year prior to the expiration of the charter term.

The motion passed.

Proposed Addition of Section 170.14 of the Regulations of the Commissioner of Education Relating to Financial Transparency Reporting Requirements [P-12 (A) 3] Your Committee recommends that the Board of Regents take the following action: that section 170.14 of the Regulations of the Commissioner of Education be amended, as submitted, effective January 14, 2020, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to immediately conform the Regulations of the Commissioner of Education to the

requirements of the Every Student Succeeds Act, which requires each school district to submit a financial transparency report for inclusion in its report card beginning with actual expenditures from the 2018-19 school year and to immediately notify school districts of their obligation to file such report.

The motion passed.

# Conditional Approval of the Learning Standards for Computer Science and Digital Fluency [P-12 (A) 4]

Your Committee recommends that the Board of Regents conditionally approves the learning standards for the new discipline of Computer Science and Digital Fluency, with the requirement that Department staff take the immediate next steps as outlined in the Board of Regents item.

Your Committee discussed amending current regulations to provide additional guidance and clarity to the charter sector, ensure that the regulations reflect the current Department data naming conventions, include updated reporting requirements, and help to ensure that the Department obtains information necessary to comply with federal and State reporting requirements for all schools.

Expanding the Pool of Applicants to Serve as Impartial Hearing Officers to Hear Special Education Due Process Complaints Filed in New York City [P-12 (D) 3]

Your Committee discussed expanding the pool of applicants to hear special education due process complaints filed in New York City. NYSED will continue to engage stakeholders in discussions on expanding the pool of qualified IHOs in New York City and other issues relating to the special education due process system and will come back to you in the next couple of months with proposed regulatory changes.

Kendall-Cargill, Registered Professional Nurse and Nurse Practitioner (Family Health), Calendar Nos. 31116 & 31117, we recommend that the determination rendered by the Board of Regents in these matters on December 10, 2019 to grant the Application For Consent Order submitted by respondent be corrected and clarified, that, notwithstanding anything else to the contrary, these matters were considered on the regular consent application calendar before the Board of Regents, were not severed and separated, and were approved as requested, and that the determination, with Regent Catherine Collins abstaining, to grant this consent application remains in effect as of the effective date of the Vote and Order that was issued with respect to the December 10, 2019 determination of the Board of Regents in these matters.

# Proposed Amendment to Sections 69.1, 69.2 and 69.3 of the Regulations of the Commissioner of Education Relating to the Education, Experience, Examination and Endorsement Requirements for Licensure as an Architect (Discussion)

Since this proposed amendment, which more closely aligns the New York State architect licensure requirements with national standards and streamlines the licensure by endorsement process, was discussed at the September 2019 meeting, revisions have been made to it to clarify the text and intent of the proposed rule. The revised proposed amendment will be published in the State Register and subject 45-day public comment period.

# Proposed Amendment to Section 61.18 of the Regulations of the Commissioner of Education Relating to the Residency Requirement for Dental Licensure (Discussion)

The proposed amendment adds dental anesthesiology to the list of accredited residency programs in a specialty of dentistry that can be used to meet the residency program requirement for dental licensure. The proposed amendment further conforms the regulation to national standards because, on March 11, 2019, the National Commission on Recognition of Dental Specialties and Certifying Boards recognized the new specialty of dental anesthesiology, which joined nine other ADA-recognized dental specialties.
