#### **CULTURAL EDUCATION**

The Cultural Education Committee held its scheduled meeting on Monday, January 8, 2024. All members were present except Regent Aramina V. Ferrer, Regent Susan W. Mittler, and Regent Catherine Collins, who were excused. Chancellor Lester W. Young and Regent Wade S. Norwood also attended the meeting.

#### MATTERS NOT REQUIRING BOARD ACTION

**Deputy Commissioner Report** – Department staff presented a report on the upcoming exhibition of the 1862 Preliminary Emancipation Proclamation and select pages from the speech Dr. Martin Luther King, Jr. delivered in New York City in September 1962 to commemorate the 100th anniversary of the document. This new exhibition, The Moral Arc Toward Freedom, will be open to the public on Tuesday, February 13 through Sunday, March 3, 2024. In support of the opening of this new exhibition, a public program featuring New York State Poet Patricia Spears Jones, historian Dr. Jennifer Burns, and New York State Museum curator Dr. Jennifer Lemak will be held on Thursday, February 15, 2024, at the Huxley Theater. This event is co-sponsored by the New York State Education Department's Office of Cultural Education and the New York State Writers Institute.

**State Aid for Libraries** – Department staff presented on the array of library aid programs administered by the New York State Library (NYSL) and the significant benefit of this aid to

libraries of all types. Staff provided a brief overview of the New York State Library which is comprised of three divisions: the Regent Joseph E. Bowman Jr. Research Library, the Talking Book and Braille Library (TBBL), and the Division of Library Development.

The NYSL administers approximately \$100 million in State aid to libraries and \$34 million in aid for library construction. To advance equity and improve services for lifelong learning, this aid supports public library systems, school library systems, tribal libraries and a variety of conservation/preservation and other statewide programs.

**OCE/P-20 Collaborations** – Department staff presented on the status of collaborative programs and resources from the Office of Cultural Education and P-20. Topics covered during the presentation included: Solar Eclipse Resources for K-12 Classrooms; an overview of the Something Terrible Happened to Joey screening and panel event with families, educators, and mental health professionals from across New York State to discuss surviving and thriving after childhood trauma; P-3 Cultural Education Toolkit for younger students; Digital Resource Kit; updates regarding the Seal of Civic Readiness +1 Pathway; and expanded learning opportunities. The presentation concluded with an overview of the value and necessity of continuing the collaborative efforts between the Office of Cultural Education and P-20 in the furtherance of building connections that will help students to engage in their local community, its resources, and cultural institutions.

Consent Agenda - Finally, Department staff presented an overview of a Consent Agenda item related to the transfer of a National Science Foundation grant to the USNY Regents Research Fund.

The Professional Practice Committee held its scheduled meeting on January 9, 2024. All members were present except for Vice Chancellor Josephine Victoria Finn and Regent Catherine Collins, who were excused. Chancellor Lester W. Young, Regent Luis O. Reyes, Regent Roger Tilles, Regent Judith J. Chin, and Regent Shino Tanikawa also attended the meeting, but did not vote on any action.

#### **ACTION ITEMS**

#### Professional Discipline Cases [PCC EXS (A) 1 – 3; 5]

The Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in four cases. In addition, the Committee recommends, upon the recommendation of the Committee on the Professions, that 29 consent order applications and 17 surrender applications be granted, and further recommends that 1 summary suspension application be granted.

These recommendations are made following the review of 51 cases involving seventeen registered professional nurses, nine licensed practical nurses, seven certified public accountants, two dentists, two veterinarians, one CPA professional service corporation,

one dental hygienist, one licensed master social worker who is also a licensed clinical social worker, one licensed practical nurse who is also a registered professional nurse, one massage therapist, one pharmacy, one psychologist, one registered professional nurse who is also certified as a nurse practitioner in Adult Health, one veterinary technician who is also a veterinarian, and one veterinary technician.

#### Restoration [PPC EXS (A) 4]

The Committee recommends that the application of Mellissa Thompson for the restoration of her license to practice as a Registered Professional Nurse in New York State be denied.

Proposed Amendment to Section 29.2 of the Rules of the Board of Regents and Addition of Subpart 79-21 to the Regulations of the Commissioner of Education Relating to General Misconduct Provisions for the Health Professions and Requirements for Histotechnologist Licensure [PPC (A) - 1 REVISED (1/8/2024)] – Department staff presented for emergency action proposed amendments to the Regents Rules and the Commissioner's regulations to conform them to Chapter 446 of the Laws of 2022, which effective January 21, 2024, establishes the new clinical laboratory technology profession of histotechnologist and establishes the licensure requirements for it. The proposed amendments also add the histotechnologist and other clinical laboratory professions to the list of health professionals subject to the general misconduct provisions in 29.2.

The Committee recommends that section 29.2 of the Rules of the Board of Regents be amended, as submitted, and subpart 79-21 of the Regulations of the Commissioner of Education be added, as submitted, effective January 21, 2024, as an emergency action, upon the finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare in order to timely implement the provisions of section 10 of Chapter 446 of the Laws of 2022, effective January 21, 2024, and to immediately clarify that clinical laboratory technology professions are subject to the general misconduct provisions for health professions.

The motion passed unanimously.

proposed amendments to the Commissioner's regulations to conform them to Chapter 446 of the Laws of 2022 by establishing the requirements for the registration of curricula that are aligned to the multiple pathways that lead to licensure in the clinical laboratory professions.

Update on Progress for the Office of the Professions (OP) Modernization Program, the Multi-Year, Multi-Project Program to Modernize All Licensing and Renewal Activity for Title VIII Professionals in New York State – Department staff presented a comprehensive overview to the Regents, highlighting the current progress of the OP Modernization Program. The presentation will delve into how the new system is strategically designed to enhance the licensure process and renewal activities for professionals across more than 50 professions in New York State.










## Current State of NYSED's LDS

We have a robust P-12 data warehouse with some postsecondary data to meet reporting needs. However:

- Disparate, siloed, and aged technical infrastructure must be addressed
- Expansion is necessary for higher education and workforce data
- Previous unsuccessful attempts resulted in missed opportunities



## Current State of NYSED's LDS

USDE lists 14 SLDS requirements to assist with status review:

- One item, "Secure Access to Data," is considered "Complete"
- Seven items, including "Governance," "Privacy Protection," and "Data Quality," are rated as "Currently in progress" or as early stage
- Six items, including "Institutional Support," "Sustainability," and "Enterprise-wide Architecture," are rated with the status of "Has not begun"




