SUMMARY

Issue for Decision

Should the Regents approve the proposed renewals to the charters of the following three schools authorized by the Chancellor of the New York City Department of Education (NYCDOE):

- 1. Rochdale Early Advantage Charter School (Full-Term Renewal and Enrollment Decrease)
- 2. **Teaching Firms of America Professional Preparatory Charter School** (Full-Term Renewal, Enrollment Expansion, and Name Change)
- 3. New Heights Academy Charter School (Short-Term Renewal)

Reason(s) for Consideration

Required by State statute.

Proposed Handling

This issue will be before the Board of Regents P-12 Education Committee and the Full Board for action at the March 13, 2017 Regents meeting.

Procedural History

The Chancellor of the NYCDOE approved these three renewal charters and submitted them to the Regents for approval and issuance of the renewal charters as required by Article 56 of the Education Law, the New York State Charter School Statute. The Chancellor of New York City Department of Education asks that the charters be revised as indicated and has provided a summary for each school as set forth below.

VOTED: That the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the **Rochdale Early Advantage Charter School** as proposed by the Chancellor of the New York City Department of Education, and that its provisional charter be extended for a term up through and including **June 30, 2022.**

VOTED: That the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the **New Heights Academy Charter School** as proposed by the Chancellor of the New York City Department of Education, and that its provisional charter be extended for a term up through and including **June 30, 2020**.

Timetable for Implementation

The Regents action for Rochdale Early Advantage Charter School, Teaching Firms of America Professional Preparatory Charter School, and New Heights Academy Charter School will become effective July 1, 2017.

REACS enrolls a slightly higher proportion of Economically Disadvantaged (ED) students when compared to the district of location, an approximately equal percentage of Students with Disabilities (SwD), but a smaller percentage of English language learners (ELLs) (Table 5).

The school is making good faith efforts to recruit, serve, and retain at-risk students². The school reports efforts to recruit ELLs that include direct mail advertising in languages other than English; the ESL and second language programs being covered at school open houses; outreach by multi-lingual staff; outreach to specialized feeder schools and programs; specific language in school brochures; information sessions held in trusted cultural centers in the community to attract more families who speak a language other than English; translations, when possible, at school events by using the school staff or the school's parent population; and a special outreach effort to focus on immigrant communities.

Summary of Public Comment

As required by the Charter School Act, the NYC DOE held a public hearing about the proposed revision on November 1, 2016. 114 individuals attended the hearing. 17 comments were made in support and none were made in opposition to the proposed charter revision. Comments in support focused on the school being deserving of a full term 5-year renewal.

TFOA enrolls a slightly higher proportion of Economically Disadvantaged (ED) and English language learner (ELL) students when compared to the district of location and a smaller percentage of Students with Disabilities (SwDs) (Table 5).

The school is making good faith efforts to recruit, serve, and retain at-risk students⁴. The school reports efforts to recruit SwDs that include conducting direct outreach to over 50 early childcare centers, shelters and Community-Based Organizations, with a special focus on engaging any staff or coordinators most directly responsible for services to SwDs.

Summary of Public Comment

As required by the Charter School Act, the NYC DOE held a public hearing about the proposed revision on November 16, 2016. 40 individuals attended the hearing. 11 comments were made in support and none in opposition to the proposed charter revision. Comments in support focused on allowing Teaching Firms of America to expand to the 12th grade levels.

New Heights enrolls a higher proportion of Economically Disadvantaged (ED) students when compared to the district of location but a smaller percentage of English language learners (ELLs) and Students with Disabilities (SwDs) (Table 5).

The school is making good faith efforts to recruit, serve, and retain at-risk students⁶. The school reports efforts to recruit ELLs and SwDs through outreach to the local Committee on Special Education (CSE) offices in Manhattan and the Bronx. They also have reached out to social services agencies serving these populations. This outreach has led the CSE offices to refer families to the school even after the lottery was conducted. In response to New Height's community demographics, they have also reached out to the Alianza Dominicana, Sinergia, and the Association of Progressive Dominicans, all organizations that cater to native Spanish speakers. The school has added a full-time, dedicated ESL teacher who holds small groups interventions and pushes into classrooms to support students to create a stronger academic program for ELLs. New Heights also has bilingual social workers on staff.

Summary of Public Comment

As required by the Charter School Act, the NYC Department of Education held a public hearing about the proposed revision on October 27, 2016. 70 individuals attended the hearing. 26 comments were made in support and none were made in opposition to the proposed charter revision. Comments in support focused on the school feeling like a family and deserving a 5-year renewal.
