#### **SUMMARY**

### **Issue for Discussion**

To provide the Board of Regents with an update on the New York State Rehabilitation Council's (SRC) 2017-18 activities and recommendations.

## Reason(s) for Consideration

Review of policy recommendations related to the delivery of vocational rehabilitation services to individuals with disabilities.

## **Proposed Handling**

This item will come before the Board of Regents ACCES Committee at its April 2019 meeting.

## **Procedural History**

The SRC was established to fulfill the requirements of the federal Rehabilitation Act of 1973, as amended and to advise the New York State Board of Regents, the Commissioner of Education, and the Office of Adult Career and Continuing Education Services-Vocational Rehabilitation (ACCES-VR) on the provisions of vocational rehabilitation services.

#### **Background Information**

The SRC is comprised of twenty-one voting members representing: disability advocacy groups, transition educational services, community rehabilitation service

providers, businesses, parent training and information centers and independent living centers. There are also several non-voting state agency members including: the State Education Department (ACCES-VR and Office of Special Education); NYS Commission for the Blind; NYS Justice Center for the Protection of People with Special Needs; NYS Office for People with Developmental Disabilities; NYS Office of Mental Health; NYS Office of Alcoholism and Substance Abuse Services and NYS Department of Labor.

The SRC convenes quarterly in-person meetings of the full Council in addition to monthly committee conference calls. Committees include:

- The Membership Committee which monitors vacancies and recruits new members;
- The Quality Assurance and Improvement Committee which provides feedback to ACCES-VR's Quality Assurance and Monitoring Unit on various issues related to improving the quality of vocational rehabilitation services provided to individuals with disabilities;
- The Transition from School to Adult Life Committee which makes recommendations on policies and practices that can improve student transition to ACCES-VR services;
- The Workforce Development Committee which makes recommendations on ways to engage the business community in hiring more employees with disabilities; and
- The Policy and Planning Committee which advises ACCES-VR on the creation of policies and procedures used to assist individuals with disabilities in achieving their career and vocational goals.

ACCES-VR has 651 staff across 25 offices. In Federal Fiscal Year 2017-18, 93,051 individuals with disabilities received services. Specific demographics on ACCES-VR participants are as follows:



As an advisory body, the SRC works collaboratively with ACCES-VR making recommendations that support the following goals outlined in the New York State Plan required by the Workforce Innovation and Opportunity Act:

- increase the employment rate for individuals served by ACCES-VR;
- increase the wages of individuals served by ACCES-VR;
- increase services to students and unserved/underserved groups;
- improve the quality of ACCES-VR services;
- increase the VR participant survey satisfaction response rate;
- increase the number of vendors that meet or exceed performance measures;
- increase the percentage of individuals with disabilities receiving a postsecondary credential; and
- effectively serve businesses to increase the hiring of employees with disabilities.
