REGENTS COMMITTEE ON AUDITS/BUDGET AND FINANCE

MATTERS NOT REQUIRING BOARD ACTION

Proposed Amendment of Sections 52.21, 80-1.2, 80-3.7, and 80-5.6 and Subpart 80-6 of the Regulations of the Commissioner of Education Relating to Teaching Assistant Certification [HE (D) 1] - Department staff presented proposed regulatory amendments to establish Initial and Professional Teaching Assistant (TA) certificates; outlines when the current Level I, II and III TA certificates would no longer be issued; expand the pool of eligible candidates for the Pre-Professional TA certificate; allow one year of experience under the Pre-Professional TA and new Professional TA certificates to satisfy the teaching experience requirement for the individual evaluation pathway to Initial teaching certification; codify that holders of the new Professional TA certificate would complete registration and continuing teacher and leader education (CTLE) requirements; and create requirements for institutions of higher education to register programs that lead to Professional TA certification.

Deputy Commissioner William Murphy reviewed the items on the Consent Agenda.

ACTION ITEMS

Revised Perkins V State Plan for BOR approval [P12 (A) 1] - Department staff updated the Board on public response to the proposed revisions to the Perkins V State Plan and requested approval for submission to USDE in May 2025.

The Committee recommends that the Board of Regents approve the revisions to New York's Perkins V State Plan as attached and direct staff to submit the revised plan to the office of the Governor for review, and, subsequently to the U.S. Department of Education no later than May 1, 2025.

The motion passed unanimously.

Proposed Amendment of Sections 100.5(a) and (b) and 100.4(d) of the Regulations of the Commissioner of Education Relating to Exemptions from Diploma Assessment Requirements for Major Life Events [P12 (A) 2] - Department staff presented the proposed amendment to the Commissioner's regulations to allow a superintendent (or the principal/head of school of a registered nonpublic school or charter school, as applicable) to make a local determination to provide exemptions from the diploma assessment requirements for students who experienced a major life event prior to the planned administration of a required diploma assessment (i.e., Regents Examination, NYSED-Approved Regents Examination Alternative, or a NYSED-Approved Pathway Assessment).

The Committee recommends that sections 100.5(a) and (b) and 100.4(d) of the Regulations of the Commissioner of Education be amended, as submitted, effective March 11, 2025, as an emergency action upon a finding of the Board of Regents that such action is necessary for the preservation of the general welfare to provide regulatory flexibility so that eligible students may be granted exemptions from diploma assessment requirements for major life events.

The motion passed unanimously.

MOTION FOR ACTION BY FULL BOARD

The P-12 Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on March 11, 2025, copies of which have been distributed to each Regent.

MATTERS NOT REQUIRING BOARD ACTION

Proposed Amendment of Section 19.5 of the Rules of the Board of Regents and Section 200.22 of the Regulations of the Commissioner of Education Relating to the Prohibition of Corporal Punishment, Aversive Interventions, Prone Restraint and Seclusion; and Standards for Behavioral Interventions [P12 (D) 1] - Department staff presented both a proposed amendment of Section 19.5 of the Rules of the Board of Regents to conform with the amended Section 305 of the Education Law (as added by Chapter 551 of the Laws of 2024) that prohibits corporal punishment in all schools public and private, and a proposed amendment to Section 200.22 of the Regulations of the Commissioner of Education indicating behavioral interventions for students with disabilities will be provided in accordance with Section 19.5 of the Rules of the Board of Regents.

Proposed Amendment of Section 135.5 of the Regulations of the Commissioner of Education Relating to First Aid Course Requirements for Coaches [P12 (D) 2] - Department staff presented proposed amendments to section 135.5 of the Regulations of the Commissioner of Education Relating to First Aid Course Requirements for Coaches.

REGENTS COMMITTEE ON PROFESSIONAL PRACTICE

The Professional Practice Committee held its scheduled meeting on March 11, 2025. All members were present except for Regent Collins, who was excused.

Chancellor Young, Regent Mittler, Regent Ferrer, Regent Tanikawa, Regent Rivera, and Regent Krist also attended the meeting, but did not vote on any action.

ACTION ITEMS

Professional Discipline Cases [PPC EXS (A) 1 – 3]

The Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 25 consent order applications, and that 2 surrender applications, be granted.

These recommendations are made following the review of 31 cases involving seven licensed practical nurses, five registered professional nurses, four certified public accountants, three dentists, two veterinarians, one dental service professional corporation, one licensed master social worker who is also a licensed clinical social worker, one massage therapist, one occupational therapist, one physical therapist assistant, one psychologist, and one public accountancy professional service limited liability company, and one veterinary technologist (See Appendix II).

Restorations [PPC EXS (A) 4 – 5]

The Committee recommends that the application of Rools Deslouches for the restoration of his licenses to practice as a licensed practical and registered professional nurse, and his certificate to practice as a nurse practitioner (adult health) in New York State be denied, with Regent Frances G. Wills, Regent Adrian I. Hale, and Regent Hasoni L. Pratts opposed (See Appendix II).

The Committee recommends that the application of Palakkumar Patel for the restoration of his license to practice as a physician assistant in New York State be denied, with Regent Adrian I. Hale and Regent Hasoni L. Pratts opposed (See Appendix II).

Proposed Amendment of Sections 66.5 and 66.6 of the Regulations of the Commissioner of Education Relating to the Use of Therapeutic Pharmaceutical Agents and Continuing Education Requirements for Licensed Optometrists Certified to Prescribe and Use Therapeutic Pharmaceutical Agents [PPC (A) 1]

Department staff presented for emergency action a proposed amendment of sections 66.5 and 66.6 of the Commissioner's regulations to conform them to Chapter 516 of the Laws of 2024, which effective November 22, 2024, amended the Education Law to add nasal sprays to the list of topical therapeutic pharmaceutical agents that optometrists are authorized to use for the treatment of dry eye disease.

The Committee recommends that sections 66.5 and 66.6 of the Regulations of the Commissioner of Education be added, as submitted, effective March 11, 2025, as an emergency action, upon a finding that such action is necessary for the preservation of the public health and general welfare in order to timely implement the provisions of section 1 of Chapter 516 of the Laws of 2024, which became effective November 22, 2024.

The motion passed unanimously.

MOTION FOR ACTION BY FULL BOARD

The Professional Practice Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on March 11, 2025, copies of which have been distributed to each Regent.

MATTERS NOT REQUIRING BOARD ACTION

Proposed Amendment of Section 17.6 of the Rules of the Board of Regents Relating to the Regulation of Surrender Orders in Disciplinary Proceedings in the Professions [PPC (D) 1] — Department staff presented a proposed amendment to section 17.6 of the Regents Rules to eliminate this requirement, which will further the protection of the public by enabling the surrender order process for disciplinary matters involving licensed pharmacists and registered pharmacy establishments to be completed more expeditiously.

Deputy Commissioner David Hamilton reviewed the items on the Consent Agenda.







THE URBAN ASSEMBLY New York HARBOR SCHOOL

The Urban **Assembly New York** Harbor School CTE **Programs**

AQUACULTURE (AQ)

Aquaculture students work towards understanding the fundamentals of water chemistry, organism biology, business, and marketing. Sophomores work with local species of New York Harbor. Juniors learn the dynamics of monospecies culture. Seniors apply their knowledge growing oysters for the Billion Oyster Project.



MARINE SYSTEMS TECHNOLOGY (MST)

MST prepares students for careers in building, maintaining and repairing boats, and culminates in an American Boat and Yacht Council's Marine Systems Technician Certificate. Students put their vessel maintenance skills to use building "oyster cabinets" the infrastructure for many BOP reefs.



VESSEL OPERATIONS (VO)

VO prepares students for careers as licensed deck crew, and serves as a stepping stone into management and operations positions aboard small passenger vessels and commercial towing units. Students receive extensive theoretical and practical training in navigation, boat handling, seamanship, safety and industry rules and standards. VO students operate the vessels required to build, maintain, and monitor BOP's oyster hatchery, nursery, and reef sites.



MARINE BIOLOGY RESEARCH PROGRAM (MBRP)

MBRP employs Phenomena-Based Learning strategies to teach the basics in ecology, research, GIS, and oceanography. Our scholars design and implement research projects that address environmental issues and present their work to the broader NYC community while consulting with mentor scientists. Our scholars have worked with various organizations including the EPA, HRF, ESRI, ConEdison, SUNY, CUNY, among others.

MARINE AFFAIRS, POLICY & ADVOCACY (MAPA)

This course examines the world's marine affairs and resources; usage and management efforts from the numerous stakeholders' perspectives Economic, legal, and policy issues are considered as well as conservation measures. Students will be able to communicate the role of citizen engagement in policy making, as well as the roles of community, education, and government in the development and implementation of laws, restoration projects and policy in our waterways.



OCEAN ENGINEERING (OE)

OE introduces students to engineering in an ocean environment. They design, build, and operate Remotely Operated Vehicles that can be used to collect data and monitor BOP's oyster reefs. Ocean Engineering students also design the 3D structures used in BOP's reef building.

PROFESSIONAL DIVING (PD)

PD is the only program of its kind in the United States, training public high school students as effective scientific SCUBA divers and putting them to work underwater on real environmental restoration projects. Professional Diving students can graduate to careers in the commercia and recreational diving industries and work directly on Billion Oyster Project as they dive to install and inspect reef structures and oysters.
