#### **STANDING COMMITTEE REPORTS**

#### ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES)

Your Adult Career and Continuing Education Services (ACCES) Committee held its scheduled meeting on April 10, 2018. All members were present, with the exception of Regent Reyes and Regent Tilles, who were excused.

#### MATTERS NOT REQUIRING BOARD ACTION

Proposed Amendment of Part 126 of the Regulations of the Commissioner of Education Relating to the Operation of Licensed Private Career Schools – Your committee discussed amending Part 126 of the Commissioner's regulations to: add a new section, 126.10(k), to implement Education Law 5001(4)(f)(3) to establish alternative licensing procedures for non-profit licensed career schools that are exempt from taxations and whose programs are funded exclusively through donations; amend section 126.6 to make a technical correction to allow for electronic submissions due to technological advancements since the statute was originally enacted; and, amend section 126.7 to make a technical correction to allow a licensed private career school to include as part of its enrollment agreement the ability to withhold a diploma, certificate, or other document evidencing satisfactory program or course completion. The proposed amendment will be presented to the Board of Regents for permanent adoption at the July 2018 meeting, and will become effective as a permanent rule on August 1, 2018.

#### CULTURAL EDUCATION

Your Committee on Cultural Education had its scheduled meeting on April 9, 2018. Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report.

In attendance were committee members: Regent Tilles, Chair Regent Cea, Regent Cottrell Regent Chin, Regent Johnson, Regent Ouderkirk and Regent Mead. Regents, in addition to CE Committee Members, in attendance were: Chancellor Rosa, Vice Chancellor Brown, Regent Hakanson, Regent Collins, Regent Cashin, Regent Finn, Regent Mittler, Regent Young, Regent Norwood, and Regent Reyes. Also in attendance were Commissioner Elia, Executive Deputy Commissioner Berlin, and Counsel and Deputy Commissioner for Legal Affairs Alison Bianchi.

#### ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and introduced Deputy Commissioner Mark Schaming. Deputy Commissioner Schaming provided a brief report on Office of Cultural Education news and activities. Today, Lieutenant Governor Hochul presented the Museum Association of New York award of merit to the New York State Museum for the Votes for Women exhibition. State Museum historian and exhibition cocurator Ashley Hopkins-Benton accepted the award on the museum's behalf. Deputy Commissioner Schaming noted Archaeologist from the New York State Museum will begin excavating at the Van Schaick Mansion in Cohoes as part of the Archaeology of Slavery in the Hudson River project that began in 2015. On Monday March 5, Joost Taverne, the Cultural Attache from the Dutch Consulate visited and viewed New Netherland Early Dutch collections. It was an important tour and discussion as the Office of Cultural Education plans galleries, curate collections, and host researchers in the coming months. The State Archives received a small grant from the National Archives to provide funds to historical records repositories statewide to implement the recommendations of needs assessments conducted by the Documentary Heritage Program. Lastly, tonight at 6:30 p.m., the Office of Cultural Education will proudly welcome Kathryn K. Matthew, Director of the Institute of Museum and Library Services (IMLS), to launch the State Library's Bicentennial Celebration.

#### **Educational Programs at the Office of Cultural Education** [CE (D) 2]

Department staff and an educator from Fort Plain Central School District shared information on how, by combining resources, the Office of Cultural Education (OCE) is supporting the increasing needs of educators and students throughout New York State. By creating programming, professional development opportunities, and outreach initiatives that provide a depth of content and diverse viewpoints on specific standards-based topics this unified approach is helping the education community see: the connection between all the entities of OCE; the positive impact cultural resources have on student achievement, and how using cultural resource with students helps students meet state education standards.

## **Proposed Amendments of §90.2 and §90.16 of Commissioner's Regulations** [CE (D) 1]

State Library staff discussed the proposed amendments of §90.2 and §90.16 of the Commissioner's regulations. Proposed amendments of §90.2 are needed to update and clarify certain terminology related to Standards for Registration of Public, Free Association and Indian Libraries. Proposed amendments of §90.16 of the Commissioner's regulation to implement Education Law §273 (7), as amended by Chapter 362 of the Laws of 2013 relating to the Conservation and Preservation of Library Research Materials. Following the 60-day public comment period, it is anticipated that the proposed amendment will be presented to the Board of Regents for adoption as a permanent rule at the July meeting. If adopted at the July meeting, the proposed amendment will become effective as a permanent rule on August 1, 2018.

#### HIGHER EDUCATION

Your Higher Education Committee held its scheduled meeting on April 10, 2018. All members were present with the exception of Vice Chancellor Brown and Regent Tilles.

#### MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in

the written report of the Committee's deliberations at its meeting on April 10, 2018, copies of which have been distributed to each member of the Board of Regents.

#### Matters Not Requiring Board Action:

#### Update on TeachNY

Your Committee was provided with an update on the TeachNY initiative. TeachNY began with a grant by the Department to SUNY to convene a group of State and national experts to set a bold new course for educator preparation in New York. After the group of experts – the TeachNY Advisory Council – released its recommendations, Commissioner Elia was part of a statewide listening tour to solicit feedback from over 1,000 practitioners. A Statewide Roundtable was convened to consider policy options, and that group's work is the model for a national Teacher Table initiative. New York will be the second state to launch a Teacher Table and we are currently working with stakeholders to select a diverse group of practitioners to serve on the Table, which will launch this month.

# Proposed Amendment to Sections 80-3.3 and 80-3.7 of the Regulations of the Commissioner of Education to Allow Individual Evaluation for Certain Certificate Titles in the Classroom Teaching Service

Your Committee discussed a proposed amendment to the Commissioner's Regulations to allow individual evaluation for certain certificate titles in the classroom teaching service. Due to teacher shortages in New York State, the Department is proposing an amendment to reinstate individual evaluation for the following certificate titles: Early childhood education (birth-grade 2); Childhood education (grades 1-6); Generalist in middle childhood education (grades 5-9); English language arts (grades 5-9); English language arts (grades 5-9); English language arts (grades 5-12). This amendment would create larger pools of qualified teachers for school district hiring. Following the 60-day public comment period, it is anticipated the proposed amendment would be presenting to the Board for adoption at its July 2018 meeting.

#### **ACTION ITEMS**

## Superintendent Determination Option for Certain Students with Disabilities to Graduate with a Local Diploma [P-12 (A) 2]

Your Committee recommends that the emergency action taken at the February 2018 Board of Regents meeting to amend paragraph (12) of subdivision (d) of §100.5 of the Regulations of the Commissioner of Education, is rescinded, effective April 24, 2018 and that paragraph (12) of subdivision (d) of §100.5 of the Regulations of the Commissioner of Education and subclause (3) of clause (a) of subparagraph (ix) of paragraph (2) of subdivision (d) of §200.4 of the Regulations of the Commissioner of Education be amended, as submitted, effective April 25, 2018, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to ensure that certain students with disabilities who are graduating from high school in January 2018 and thereafter are aware that they may be considered an eligible student for the superintendent determination option if they meet the requirements of the proposed rule. It is also necessary to ensure that superintendents are on notice that they must, upon the written request of a parent or guardian, make a determination as to whether certain students with disabilities are eligible for a local diploma, if the student meets the requirements of the proposed rule.

#### Minimum Instruction Requirement for State Aid [P-12 (A) 5 - REVISED]

A motion to amend regulations as presented in the item was moved by Regent Collins and seconded by Regent Norwood. Regent Collins withdrew her motion. The new motion moved by Vice Chancellor Brown and seconded by Regent Tilles is as follows:

Your Committee recommends that §§175.2 and 175.5 of the Regulations of the Commissioner of Education, be amended as submitted, effective July 1, 2018, to ensure that school districts and applicable unions can set their calendars for the 2018-2019 school year and complete any collective bargaining negotiations necessary to comply with the new requirements of the proposed amendment and that the Board directs the Commissioner to work with individual school districts to address specific concerns as they transition to implement the regulation.

Regent Johnson was in opposition. Regents Collins and Mittler abstained. The motion passed.

## Implementation of New York State's Approved Every Student Succeeds Act (ESSA) Plan [P-12 (A) 6]

Your Committee recommends that Department staff is directed to finalize and file the proposed amendments to sections 100.2(ff), 100.2(m), 100.18, 100.19 and Part 120 of the Commissioner's Regulations and the addition of a new section 100.21 of the Commissioner's Regulations with the Department of State for publication in the State Register, consistent with the State's USDE-approved ESSA plan as described herein.

Your P-12 Education and Higher Education Committees held their scheduled meeting on April 10, 2018. All members were present, except for Vice Chancellor Brown and Regent Tilles, who were excused.

#### MATTERS NOT REQUIRING BOARD ACTION

## Grade-Level Extensions for Certain Candidates who hold a Students with Disabilities Generalist Teaching Certificate [P-12/HE (D) 1]

The Committees discussed proposed amendments to regulations relating to grade-level extensions for certain candidates who hold a Students with Disabilities Generalist certificate. Discussion focused on the four different extension certificates proposed for current holders of Students with Disabilities Generalist certificates. By extending the grade bands in which qualified teachers of students with disabilities may teach, the Department believes this will help to address the shortage of teachers of students with disabilities. Following the 60-day public comment period, several comments were made on the proposed amendment previously discussed in December 2017. In response to those comments and other comments received from the field, the Department recommends making additional revisions to add an extension for teachers holding a Students with Disabilities Generalist certificate in grades 5-9. It is anticipated that the proposed amendment will be presented to the Board of Regents for adoption at its May 2018 meeting.

Creation of Limited Extensions for Teachers Holding a Students with Disabilities Generalist Certificate Who Teach a Special Class in Grades 7-12 and a Statement of Continued Eligibility for Teachers Holding a Students with Disabilities Generalist Certificate Who Teach a Special Class in Grades 7-12 and Were Previously Allowed to Teach in Another Content Area by School Districts Using the HOUSSE Rubric for Federal Aid Purposes under the No Child Left Behind Act [P-12/HE (D) 2]

The Department is proposing two options for teachers who hold the students with disabilities generalist in grades 7-12 certificate and are assigned to teach special classes, but do not hold the specific subject area certificate(s). Following the 60-day public comment period required under the State Administrative Procedure Act, it is anticipated

that the proposed amendment will be presented to the Board of Regents for adoption at its July 2018 meeting.

#### PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on April 10, 2018. All Committee members were present.

#### **ACTION ITEMS**

#### **Professional Discipline Cases**

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 43 consent order applications and 10 surrender applications be granted, with Regent Wade S. Norwood abstaining in one of those consent applications (Cal. No.30064) and Regent Catherine Collins abstaining in another one of those consent applications (Cal. No. 29842).

In the case of Seth G. Kohl, Chiropractor, Calendar No. 30120, we recommend that the joint application by both petitioner and respondent in this matter to amend the Application to Surrender respondent's License that was previously submitted to the Board of Regents and granted by the Board of Regents on February 13, 2018 be granted, said previously submitted Application to Surrender License be deemed amended, on the consent of both parties, to show that respondent's correct license number is "005269" and to delete the reference in such submitted Application to license number "005259", said previously submitted Application by respondent to Surrender his License otherwise remains in effect, the Vote & Order dated February 13, 2018 regarding respondent shall continue to be effective, and the Vote & Order of the Deputy Commissioner to be issued herein shall be effective nunc pro tunc on and as of the effective date of the Vote and Order that was issued with respect to the February 13, 2018 determination of the Board of Regents in this matter.

# **NYS Milestones for the Arts**

- In January 2015 the Board of Regents amended sections 100.2 and 100.5 of the Commissioner's Regulations to implement the 4+1 Pathways to graduation option allowing students to meet the requirements for a diploma in different ways. The amendment created graduation pathways assessments in the Humanities, STEM, Biliteracy, CTE and the Arts.
- In 2015 the Department established the Blue Ribbon Commission on the Arts to assist in identifying and recommending comparably rigorous assessments available to students pursuing a graduation pathway in the arts.

# **NYS Milestones for the Arts**

- In March 2016, the AP and IB assessment options were approved by the Commissioner for the Arts Pathway as a first step. However, many schools in NYS do not offer AP and IB arts courses and assessments. In addition, these courses are generally for students who are advanced in the arts, meaning 3-5 unit sequence arts majors generally are most prepared to to take these assessments.
- In **April 2016** the Department called for teams of arts educators in dance, music, theater, visual and media arts to develop new learning standards for the arts over the coming summer.

# **NYS Milestones for the Arts**

- In **April 2017**, the Board of Regents approved the NYS Strategic Plan for the Arts that includes a detailed report on the work of the Blue Ribbon Commission and the National Arts Assessment Experts.
- In July 2017, the Office of State Assessment (OSA) assigns staff to assist in the Blue Ribbon Commission's work. OSA reviews the Commission's Report along with the NYSED's Commencement General Education (C-GEL) arts assessments in dance, music, theater, and visual arts. A technical report of the assessments is produced.
- In **September 2017**, the Regents approved the new PK-12 NYS Learning Standards for the Arts.
- In **November 2017,** the Arts CAP met to develop roadmaps for the arts & assist with the professional development of new arts standards.

# 2017 Pk-12 Learning Standards for the Arts: Professional Development Update

- September 2017 through March 2018 there have been over 60 professional development trainings across the state. Currently seven more are scheduled in April and May.
- The Department and S/CDN are planning summer professional development sessions statewide (in two to three locations) for teachers of the arts (dance, music, theater, visual and media arts) and a NYSED S/CDN Arts PD for Administrators was held in March.
- There are approximately 90 NYSED teacher trainers for the 5 disciplines.

# The 2017 PK-12 Learning Standards for the Arts & the need for new assessments

The Research and the Blue Ribbon Commission's Sub-Committee Reports

# **Program Waivers**

### Summary of the Sub-Committee Work

While Program Waivers have strong potential to expand the varieties of ways students could earn Regents credit for their arts study, this committee noted two factors that diminish that potential:

1) Individual student review is an important component of program waivers, however the portfolio review option would cover the same students, plus more students in a wider variety of settings.

2) The investment needed to create an application process and evaluation mechanism for program waivers is significant.

# **Summary of the Sub-Committee Work**

## **Charge of the Portfolio Committee**

To develop a process for students to submit their evidence of Pathway-level achievement thereby waiving the necessity of a Regents exam.

### Considering:

- types of student evidence to be submitted
- how work is submitted
- who reviews the work
- criteria used to judge the work

# Portfolio

Provides a full picture of student achievement in the Arts discipline and allows for student to demonstrate learning through various modalities.

## Portfolio Elements Recommendation is to include:

- Written Work (Reflective Essay)
- Projects Over Time (documents student interest and expertise)
- On Demand Task (evidence of three year development)

Portfolios to be aligned with new NYS Learning Standards for the Arts

(Dance, Music, Theatre, Visual and Media Arts)

# Portfolio Recommendations:

**Essential Identifications on Each Portfolio** 

Dates on all entries to show growth over time
 Works showing drafts and corrected versions included
 Reflections both formative and summative

# Remarks

Portfolio will provide a welcome opportunity for students with disabilities, Language other than English students, students with learning differences and other under-served student populations to showcase the strengths of their accomplishments.

The sub-committee strongly supports use of the Portfolio model as a component in the Individual Arts Assessment Plan (IAAP).

To make recommendations for the adoption or adaption of existing assessment materials and assessment strategies to maximize the use of existing assessment resources.


## C-GEL: Summary of the Sub-Committee Work

#### **Background:**

- In March 2016, the AP and IB assessment options were approved by the Commissioner for the Arts Pathway as a first step. However, many schools in NYS do not offer AP and IB arts courses and assessments. In addition, these courses are generally for students who are advanced in the arts, meaning 3-5 unit sequence arts majors generally are most prepared to to take these assessments.
- In July 2017, the Office of State Assessment (OSA) assigned staff to assist in the Blue Ribbon Commission's work. OSA reviewed the Commission's Report along with the NYSED's Commencement General Education (C-GEL) arts assessments in dance, music, theater, and visual arts. A technical report of the arts assessments has been produced.

### Purposes & Benefits of Using C-GEL as a Model for IAAP

- C-GEL was developed in partnership with the NYSED Office of Assessment using *Goals 2000* funding. C-GEL is intended to be a voluntary assessment and **model** for teacher and district use.
- C-GEL includes performance/portfolio assessment practices (end of course and through course) approved and developed by NYS practitioners (all PK-20 and fields represented).
- The developers of C-GEL and the Blue Ribbon Commission agree that a portfolio of student work, based on on-going performance and on-demand assessments collected over time better measures learning in the arts.

### Purposes & Benefits of Using C-GEL as a Model for IAAP

- C-Gel can assist NY arts educators to assure that all New York students have a substantial grounding in the arts discipline chosen by the student.
- C-GEL could serve as a model for through-course and end-of-course assessment in more advanced arts courses in NY to be developed for Phase 2. This would help assure that students continue their learning in a manner to qualify more of them for the Arts Pathway endorsement.
- C-GEL can provide equity and access to all students and school districts while the IAAP assessments are being developed.

### Purposes & Benefits of Using C-GEL as a Model for IAAP

- Benchmarking of student performances can be collected and used for IAAP development.
- The IAAP arts performance assessment collection of evidence over time could be developed using the CDOS work that was released by NYSED June 2016. (There is a nexus here with CDOS Standard 3b-Arts and Humanities Majors).
- The IAAP could be used as a model performance assessment for all content areas.

# The Process

Following the guidelines proposed by the arts assessment experts in the IAAP document, we reached out to every region in NYS and ensured that urban, rural and suburban districts were contacted and represented to the best of our ability.

The following districts volunteered to participate: Buffalo Public Schools, Ossining Union Free Schools, Fredonia Central Schools, Williamsville Central Schools, Wappingers Central Schools, Indian River Central Schools, and New Rochelle Public Schools.



- BEDS information was reviewed to determine the arts courses that were highest in enrollment. Those courses were:
- **DANCE:** Creative Dance/ Movement; Modern Dance; Other
- **MUSIC:** Concert Band; Orchestra; Chorus
- **THEATER:** Acting; Other
- VISUAL ARTS: Studio in Art; Drawing & Painting; Photography; Ceramics Computer/Media Arts

# **The Process**

Based on that information, we asked arts teachers to have their students participate in an arts assessment focus-group in those areas.

Surveys for students and teachers were created that focused on assessments in the arts. Participating arts teachers were given online surveys created using *Google Forms* (One for them, and one to be distributed to students). At last count, we had over 550 responses from students and teachers.

Emails were also sent to these arts teachers requesting 2015-2016 end-ofcourse and end-of-year arts assessments in the above courses.


We received over 30 examples of assessments used in the arts classroom.



# **Teacher Feedback**

Arts teachers were asked to complete their own survey as it applied to arts assessments. Most were in general agreement that a **performance based arts assessment was the best gauge in determining growth and mastery for students.** 

All teachers felt that offering IAAP as an alternative Regents option was an excellent idea and a long time coming.

### The IAAP assessment system should use three basic types of assessment:

- State Provided Course-Embedded (Through-Course) or End-of-Course Assessments.
- Individual Capstone Project to be Carried Out by the Student in High School.
- Student self-reflections on their work and other indirect measures of student achievement and attitudes in the arts.

#### **PK - 9 NYS Arts Education**

Five disciplines: Dance, Music, Theatre, Media and Visual Arts.

One unit of credit (CR 100.5) is required for **HS graduation**.

#### Local assessments used within courses.

4+1 Arts Pathway approved options of IB and AP assessments are not practical for most students at this HS I Level nor are they *available* to ALL students.

\* HS I Proficiency could be measured by NYS CGEL if practitioners aligned the assessments to the new 2017 NYS Learning Standards for the Arts.

#### Grades 9 -12 NYS Arts Electives

Students choose an arts discipline to major in for a Three-Unit sequence.

Three units of credit are needed for a **Regents Diploma.** 

4+1 Arts Pathway approved options of IB and AP assessments may be acceptable for some students at this HS II Level, however, they are not available to ALL students.

The proposed Individual Arts Assessment Plan (IAAP) could be used to ensure the Arts Pathway is available to all NYS students.

#### Grades 10 -12 NYS Arts Electives

Students focus deeper arts discipline to Major in for a Five-Unit sequence.

### Five units of credit are needed for a **Regents Diploma with Advanced Designation.**

4+1 Arts Pathway approved options of IB and AP assessments are acceptable for most students at this HS III Level, however, they are not *available* to ALL students.

The proposed Individual Arts Assessment Plan (IAAP) could be used to ensure the Arts Pathway is available to all NYS students.

#### C-GEL prepares students for the IAAP & other advanced arts assessments.
