SUMMARY	

# Issue for Decision (Consent)

Should the Board of Regents adopt the proposed amendment of sections 80-3.10, 80-5.8, 80-5.20, and 80-5.23 of the Regulations of the Commissioner of Education relating to educator certification for candidates from another state or territory of the United States or the District of Columbia?

## Reason(s) for Consideration

Review of policy.

# Proposed Handling

The proposed amendment is submitted to the Full Board for adoption as a permanent rule at its May 2023 meeting. A copy of the proposed amendment is attached (Attachment A).

## **Procedural History**

The proposed amendment was presented to the Higher Education Committee for discussion at its January 2023 meeting. A Notice of Proposed Rule Making was published in the State Register on January 25, 2023, for a 60-day public comment period. Following publication in the State Register, the Department received two comments on the proposed amendment. An Assessment of Public Comment is included (Attachment B). No changes to the proposed amendment are recommended at this time. A Notice of Adoption will be

published in the State Register on May 31, 2023. Supporting materials are available upon request from the Secretary to the Board of Regents.

### **Background Information**

Two of the pathways to certification are designed for candidates who hold a certificate from, and/or completed an educator preparation program in, another state or territory of the United States (U.S.) or the District of Columbia.

The first pathway is the "Endorsement of a Certificate" ("endorsement") pathway. For teacher or educational leadership certification through this pathway, candidates must meet the following requirements in addition to education and general requirements for certificates prescribed in Subpart 80-1 of the Commissioner's regulations (8 NYCRR 80-5.8(a) and 80-5.20(a)-(c)):

- **Certificate**. Hold a valid certificate from another U.S. state(s) or territory/territories or the District of Columbia that is equivalent to the title and type of the certificate sought.
- **Experience**. Complete at least three years of satisfactory experience within seven years immediately preceding the certificate application (1) in a public school in another U.S. state(s) or territory/territories or the District of Columbia; (2) in a position that would have required the equivalent of an Initial or Professional teacher certificate in the certificate title sought/title and type of the educational leadership certificate sought; and (3) under the authority of a certificate issued by such other state authorizing such service. The Commissioner may also determine that other experience is equivalent to the above requirements.
- **Ratings**. Receive evaluation ratings of effective or highly effective in at least three years of experience in a public school in other U.S. state(s) or territory/territories or the District of Columbia in the certificate title sought, or the substantial equivalent of such ratings.

The endorsement pathway for Initial and Professional School Counselor certification is similar, with a few exceptions. Some differences include that: (1) the non-New York State certificate must be from another U.S. state or territory, which is unclear as to whether candidates can hold certificates from multiple states; (2) candidates can complete at least three years of satisfactory experience within five years (instead of seven years) immediately preceding the certificate application; and (3) evaluation ratings are not required (8 NYCRR 80-5.23(a)).

The second pathway is the "Completion of a Comparable Educator Program in Another U.S. State" ("comparable program") pathway. For this pathway, candidates must complete a substantially equivalent teacher preparation program at an institution of

higher education<sup>1</sup> that leads to certification in the title and type of certificate sought in the jurisdiction where the institution is located (8 NYCRR 80-5.8(b)(1)). Teacher candidates must also meet the general requirements for certificates prescribed in Subpart 80-1 of the Commissioner's regulations and the degree and examination requirements set forth in Section 80-5.8 of the Commissioner's regulations to obtain certification through this pathway.

Candidates who apply for educational leadership certificates through this pathway must complete an educational leadership program<sup>2</sup> at an institution of higher education that leads to the certificate title and type sought, or a similar certificate title and type, in the jurisdiction where the institution is located (8 NYCRR 80-3.10). Educational leadership candidates must also meet the experience and examination requirements prescribed in section 80-3.10 of the Commissioner's regulations to obtain certification through this pathway.

#### **Proposed Amendment**

The Department proposes to streamline both the endorsement and comparable program pathways, providing additional flexibility and increasing the pool of candidates during this time of teacher shortages.

#### **Endorsement Pathway:**

The Department proposes to revise the certificate requirement in the endorsement pathway for teacher, educational leader, and Initial and Professional School Counselor certification such that certificates from another U.S. state or territory or the District of Columbia may be "comparable" instead of "equivalent" to the New York State certificate title and type sought. Educator certificate titles and types vary greatly across states and change over time. This revision would give the Department more flexibility in determining which certificates from another state could be considered comparable to a New York State certificate and increase the pool of candidates for certification.

The proposed amendment also removes the time period during which candidates must complete their three years of experience for the endorsement pathway. For example, under current regulations, a candidate who worked for six years as an elementary teacher and then five years as a principal in a public school in another state would not be eligible for the Childhood Education certificate through the endorsement pathway because the three years of teaching experience did not occur within the past seven years. This is but one of several circumstances, such as raising a family, by which a candidate's experience

may not qualify.<sup>3</sup> By removing the recentness requirement, candidates who hold a valid certificate from another state but completed their three years of experience more than seven (or five for school counselor candidates) years prior to their application would be eligible for certification.

The proposal includes one technical revision for the endorsement pathway. For Initial and Professional School Counselor certificates through this pathway, the reference to certificates and experience "in another state or territory of the United States" in the eligibility requirements will be replaced with "in other state(s) or territory/territories of the United States." This proposed amendment would make the eligibility requirements consistent with the eligibility requirements for teacher and educational leadership certificates through the endorsement pathway.

### Comparable Program Pathway:

Additionally, the Department proposes to revise the comparable program pathway for teacher and educational leadership certification such that the descriptions of the certificates to which the educator preparation program from another state leads are consistent for both types of certificates.

The proposal also includes two technical revisions related to this pathway. First, the education requirements for candidates who apply for and meet the requirements for an educational leadership certificate on or before September 1, 2019, will be removed from section 80-3.10 because they are defunct; all those who would have qualified are eligible to apply for certification under the current requirements.

Second, at its January 2022 meeting, the Board of Regents replaced references to regionally accredited higher education institutions with "an institution of higher education that is accredited by an institutional accrediting agency recognized for this purpose by the United States Department of Education" throughout the Commissioner's regulations. As such, the references to a regionally accredited higher education institution in section 80-3.10 will be replaced with this new phrase, consistent with the earlier regulatory amendments.

#### Attachment A

AMENDMENT TO THE REGULATIONS OF THE COMMISSIONER OF EDUCATION Pursuant to sections 101, 207, 208, 305, 308, 3001, 3004, and 3009 of the Education Law.

1. Clause (a) of subparagraph (ii) of paragraph (1) of subdivision (a) of section 80-3.10 of the Regulations of the Commissioner of Education is amended to read as follows:

the] <u>The</u> candidate shall hold a master's or higher degree from [a regionally accredited higher education] <u>an</u> institution <u>of higher education that is accredited by an institutional</u> <u>accrediting agency recognized for this purpose by the United States Department of</u>

(i) The candidate shall hold a master's or higher degree from [a regionally accredited higher education] <u>an</u> institution <u>of higher education that is accredited by an</u> <u>institutional accrediting agency recognized for this purpose by the United States</u> <u>Department of Education</u> or an equivalently approved higher education institution as determined by the department; and

(ii) ...

(a) ...

(b)

[(1) for candidates who apply for and meet the requirements for a certificate under this subdivision on or before September 1, 2019, have successfully completed an educational leadership program outside of New York State that is equivalent with a program leading to a professional certificate as a school district business leader in the educational leadership service registered pursuant to section 52.21(c)(5) of this Title or an educational leadership program leading to a regular certificate in an equivalent title to school district business leader, accredited by an accrediting body recognized by the United States Department of Education at a regionally accredited institution outside of

the District of Columbia that is [equivalent] <u>comparable</u> to the title and type of the certificate sought.

(1) The commissioner may recognize and issue an initial certificate to an out-ofstate candidate who completes a teacher education program at an institution of higher education that is accredited by an institutional accrediting agency recognized for this purpose by the United States Department of Education or a higher education institution that the commissioner deems substantially equivalent from another state or territory of the United States or the District of Columbia that leads to certification in the title and type of certificate sought, <u>or similar certificate title and type</u>, in the jurisdiction where the higher education institution is located if the candidate also meets the following requirements:

7. Paragraph (1) of subdivision (b) of section 80-5.20 of the Regulations of the Commissioner of Education is amended to read as follows:

(1) The commissioner may endorse the certificate of other state(s) or [territory(ies)] <u>territory/territories</u> of the United States or the District of Columbia for service as a school district business leader, provided that the candidate meets the following requirements:

(i) The candidate shall hold a valid certificate of other state(s) or [territory(ies)] <u>territory/territories</u> of the United States or the District of Columbia that is [equivalent] comparable to the professional certificate as a school district business leader.

(a) The candidate shall have had at least three years of satisfactory experience in a public school (grades N-12) in other state(s) or [territory(ies)] territory/territories of the United States or the District of Columbia in a position that would have required the professional certificate as a school district business leader for employment in New York State and while under a certificate issued by such other state authorizing such service[, which experience must have been completed within seven years immediately preceding the application for endorsement of the out-of-state certificate]; or the candidate shall have equivalent experience as determined by the commissioner; and

(b) shall submit satisfactory evidence that the candidate received evaluation ratings of effective or highly effective, or the substantial equivalent of such ratings, in at least three years of experience in a public school in other state(s) or [territory(ies)] territory/territories of the United States or the District of Columbia in the certificate title sought as a school district business leader for employment in New York State.

8. Paragraph (1) of subdivision (c) of section 80-5.20 of the Regulations of the Commissioner of Education is amended to read as follows:

(1) The commissioner may endorse the certificate of other state(s) or [territory(ies)] <u>territory/territories</u> of the United States or the District of Columbia for service as a school building leader, provided that the candidate meets the following requirements:

(i) The candidate shall hold a valid certificate of other state(s) or [territory(ies)] <u>territory/territories</u> of the United States or the District of Columbia that is [equivalent] <u>comparable</u> to the initial certificate as a school building leader.

(ii) ...

(iii) ...

(iv)

(a) The candidate shall have had at least three years of satisfactory experience in a public school (grades N-12) in other state(s) or [territory(ies)] <u>territory/territories</u> of the United States or the District of Columbia in a position that would have required the initial certificate as a school building leader for employment in New York State and while under a certificate issued by such other state authorizing such service[, which experience must have been completed within seven years immediately preceding the application for endorsement of the out-of-state certificate]; or the candidate shall have equivalent experience as determined by the commissioner; and

(b) shall submit satisfactory evidence that the candidate received evaluation ratings of effective or highly effective, or the substantial equivalent of such ratings, in at least three years of experience in a public school in other state(s) or [territory(ies)] territory/territories of the United States or the District of Columbia in the certificate title sought as a school building leader for employment in New York State.

9. Subdivision (a) of section 80-5.23 of the Regulations of the Commissioner of Education is amended to read as follows:

(a) School counselor.

The commissioner may endorse the certificate of [another state or territory] <u>other</u> <u>state(s) or territory/territories</u> of the United States or the District of Columbia for service as a school counselor, provided that the candidate meets the following requirements:

(1) The candidate shall hold a valid certificate of [another state or territory] <u>other</u> <u>state(s) or territory/territories</u> of the United States or the District of Columbia that is [equivalent] <u>comparable</u> to the initial or professional certificate as a school counselor.

(2) ...

(3) ...

(4) The candidate shall either:

(i) ...

(ii) have at least three years of satisfactory experience in a public school (grades K-12) in [another state or territory] <u>other state(s) or territory/territories</u> of the United States or the District of Columbia in a position that would have required the equivalent of initial or professional certification as a school counselor for employment in New York State and while under a certificate issued by such other state authorizing such service[, such experience must have been completed within five years immediately preceding the application for endorsement of the out-of-state certificate]; or the candidate shall have equivalent experience as determined by the commissioner.

#### Attachment B

#### ASSESSMENT OF PUBLIC COMMENT

Since publication of the Notice of Proposed Rule Making in the State Register on December 28, 2022, the State Education Department (Department) received the following comments on the proposed amendment:

1. COMMENT: The commenter notes that removing the time frame in which applicants must complete the required experience for the "Endorsement of a Certificate" ("endorsement") pathway to certification is helpful, but questions why three years of experience is required. They believe that this requirement limits the number of applicants who could qualify for certification, asserting that many applicants have one or two years of experience in one or more states. They suggest that applicants could either hold a valid comparable certificate or complete a comparable certification program to obtain certification, noting that this would limit the number of items that need to be sent to the Department and expedite the application review process. They request a more substantial change to the reciprocity pathways to certification.

DEPARTMENT RESPONSE: The certification requirements in other U.S. state(s) and territory/territories and the District of Columbia are different from the certification requirements in New York State (NYS). To accommodate these differences, the endorsement pathway to certification requires applicants to have at least three years of acceptable experience and effective or highly effective evaluation ratings during this experience for teaching and educational leadership certificates, in addition to holding a valid certificate from another state or territory. The current proposal does not seek to remove the experience requirement or lower the requirement from three to two years of

acceptable experience; as such, this comment is outside the scope of the proposed rule.

For the current "Completion of a Comparable Educator Program in Another U.S. State" ("comparable program") pathway to certification, applicants must complete an acceptable educator preparation program at an institution of higher education that leads to certification in the title and type of certificate sought in the jurisdiction where the institution is located. To ensure that applicants who completed an acceptable educator preparation program in another state or territory have the knowledge and skills to work in NYS public schools, they must also pass certification exams similar to applicants who completed a NYS educator preparation program. No changes to the proposed rule are necessary.

2. COMMENT: The commenter does not support removing the seven-year time frame in which applicants must complete the required experience for the endorsement pathway to certification for several reasons. First, they believe that the proposed amendment would allow applicants, including those who have not been teaching for many years, to become certified with extremely minimal requirements. They further argue that the proposed amendment would result in inequity as those pursuing certification via other pathways, especially those completing NYS educator preparation programs, must complete more rigorous requirements.

Second, by removing the time frame, the commenter speculates that applicants may not be aware of current pedagogical best practices. Third, they relay anecdotal evidence that educators who were unable to find teaching positions in their geographic area of the state have left the profession and that some employers give preference to

out-of-state applicants with whom they are familiar, thus bypassing certified NYS residents. They feel that the proposed amendment would increase this practice by employers.

The commenter suggests increasing the time frame for acceptable experience from seven to ten years. The commenter argues that this would allow more candidates to qualify while ensuring that they have current experience and are aware of current pedagogical practices.

While the commenter does not express concerns with the comparable program pathway, they contend that NYS educator preparation programs had different requirements on or before February 1, 2004, and candidates who completed such programs do not have a clear pathway to achieving certification.

DEPARTMENT RESPONSE: The endorsement pathway to certification requires applicants to have at least three years of acceptable experience, and effective or highly effective evaluation ratings during this experience for teaching and educational leadership certificates, in addition to holding a valid certificate from another state or territory. This experience ensures that educators who received a certificate from another U.S. state or territory have the knowledge and skills needed to work in NYS public schools. Although the recentness of applicants' experience may vary, employers may still determine an applicant's knowledge and skills through interviews and observation during a probationary term. Additionally, employers can provide professional learning to applicants in any areas in need of development.

The comments regarding NYS educator preparation programs prior to February 1, 2004, are beyond the scope of the proposed rule; however, the Department will take them into consideration. No changes to the proposed rule are necessary.
