## Issue for Decision

Should the Board of Regents approve the proposed merger of **Nuasin Next Generation Charter School** (an education corporation authorized by the Chancellor of the New York City Department of Education) with and into **Next Generation Charter School** (an education corporation authorized by the State University of New York Board of Trustees) with **Next Generation Charter School** as the surviving education corporation under the amended name "**Next Generation Charter Schools**?"

## Reason(s) for Consideration

Required by State statute.

## **Proposed Handling**

This issue will come before the P-12 Education Committee for recommendation, and the Full Board for action, at its May 2025 meeting.

## Procedural History

The May 2010 amendments to Education Law §2853(1)(b-1) eliminated language that prohibited education corporations in New York from operating more than one charter school, and now allow charter schools and the families they serve to realize the many potential benefits of governance and operational merger.

The Chancellor of the New York City Department of Education made the revision recommendation being presented to the Board of Regents for approval and issuance as required by Article 56 of the Education Law.

### **Background Information**

The merger of existing charter school governing boards requires revisions to each of the charters of the merging schools, which must be approved by the respective charter entity or entities involved. This means that in situations where schools that wish to merge have different charter entities, the approval of all parties – the boards of trustees of the schools and each chartering entity – is required before any such merger may occur.

The State University of New York Board of Trustees have yet to take action regarding this proposed merger. Regents action regarding this merger is required but the final merger is contingent upon approval by the State University of New York Board of Trustees.

Mergers have no impact on the number of charters available under the statutory charter cap. Mergers are generally administrative/governance-related revisions. The merger does not abridge the obligations of each of the applicable charter schools from individually meeting all authorizer standards, and each school continues to be held accountable to such standards separately.

#### **Recommendation**

The Chancellor of the New York City Department of Education recommends that the Board of Regents take the following action(s):

VOTED: That pursuant to the authority contained in Education Law §§ 223 and 2853(1)(b-1):

Nuasin Next Generation Charter School will be and hereby is merged with Next Generation Charter School, with Next Generation Charter School as the surviving education corporation under the amended name of "Next Generation Charter Schools."

**Next Generation Charter School**, the surviving corporation under the amended name of "**Next Generation Charter Schools**," shall continue to administer the educational operations and purposes of the constituent corporations in the same manner as they presently exist.

The separate existence of Nuasin Next Generation Charter School and Next Generation Charter School hereby ceases, and Next Generation Charter School, the surviving corporation under the amended name of "Next Generation Charter Schools," is hereby vested with all the rights, privileges, immunities, powers and authority possessed by or granted by law to each of the constituent corporations. All assets and liabilities of the respective constituent corporations are hereby assets and liabilities of such surviving corporation. All property, real, personal, and mixed, and all debts to each of the corporations on whatever account are hereby attached to Next Generation Charter School, the surviving corporation under the amended name of "Next Generation Charter School, the surviving corporation under the amended name of "Next Generation Charter School, and may be enforced against it to the same extent as if the debts, liabilities, and duties had been incurred or contracted by it.

The merged corporation shall operate under the provisional charter granted to **Next Generation Charter School** under the amended name of "**Next Generation Charter Schools.**"

## Timetable for Implementation

The Regents action for the above-named charter schools will become effective July 1, 2025 contingent upon approval by the State University of New York Board of Trustees.

## **Rationale for Revision Recommendation**

In accordance with Education Law, Article 56, Sections 2851(4) and 2852(2), the New York City Department of Education (NYCDOE) recommends that the Board of Regents grant the revision described above in the **Issue for Decision** section, for the following reasons.

- The merger is expected to permit more efficient and complete sharing of programming, practices, and resources for the schools' students with disabilities (SWD) and the schools' McKinney-Vento, economically disadvantaged (ED), and English language learning (ELL) students.
- The merger is expected to produce additional efficiencies, such as common governance and common oversight, and handling of finances.
- The requested revision will have no bearing on the number of charters available for issuance in New York City or the State.



The Board of Regents granted an initial charter to Nuasin, operating as Metropolitan Lighthouse Charter School, in September of 2009. Nuasin commenced instruction in Fall 2010, initially serving 138 students in Kindergarten through Grade 2. Nuasin's charter was subsequently renewed by the Board of Regents in 2014, 2019, and 2022. The charter school was granted revisions in 2014, 2019, 2021, and 2022.

# **Summary of Public Comment**

The required public hearing was held by the New York City Department of Education on February 13, 2025. Nineteen people attended the hearing, and five spoke. Five were in favor of the merger. No one spoke in opposition.
