STANDING COMMITTEE REPORTS

ADULT CAREER AND CONTINUING EDUCATION SERVICES (ACCES)

Your ACCES Committee held its scheduled meeting on May 19, 2015. All members were present.

MATTERS NOT REQUIRING BOARD ACTION

<u>Update on the new High School Equivalency exam – Test Assessing Secondary Completion™ (TASC)</u> – the Committee was provided an update on the TASC™ test for High School Equivalency (HSE), which was implemented in January, 2014. Since that time, New York State began administering the TASC Forms A, B, and C. In mid-March 2015, testing on Forms A, B, and C ceased as new Forms D, E, and F were finalized for testing. Also in March 2015, CTB/McGraw-Hill launched a new computerized registration and scheduling system to help ensure accurate data collection and the equitable distribution of test forms.

In January 2015, thirty Master Teachers were trained in high-emphasis science concepts, and in March 2015, another thirty received professional development in math, which is the TASC subtest that is the most challenging for New York State examinees to pass. These Master Teachers are working with the Regional Adult Education Network center directors to provide this information and national standards training in their regions. To date, over one thousand adult education teachers have received training on instructional approaches from the Master Teachers. In addition, to support our instructors of adult education and test center administrators, SED, in conjunction with CTB-McGraw-Hill, has been providing regional training and informational webinars and communicating with test centers on the annual developments with the TASC test.

Overall, the first year of the new HSE has been a success, however, SED continues to face challenges in supporting this new, more rigorous national test that measures career/college readiness standards.

HIGHER EDUCATION

Your Higher Education Committee held its scheduled meeting on May 18, 2015.

Action Items

Change in Scope of Institutional Accreditation: Phillips Beth Israel School of Nursing.

Your Committee reviewed the request for a change in the scope of institutional accreditation for Phillips Beth Israel School of Nursing and recommend that the Board of Regents approve a change in scope of the institutional accreditation of Phillips Beth Israel School of Nursing, in recognition of the institution's new authority to prepare and deliver the liberal arts and sciences components of the School's programs.

Proposed Amendment of Section 145-2.2 of the Regulations of the Commissioner of Education to Establish Standards for Students to Be Reinstated to the Status of Good Academic Standing in Order to Resume Receiving Awards that were Previously Suspended under the Tuition Assistance Program.

Your Committee discussed amending Section 145-2.2 and recommend that subparagraph (ii) of paragraph (2) of subdivision (b) of section 145-2.2 of the Regulations of the Commissioner of Education is repealed and a new subparagraph (ii) of paragraph (2) of subdivision (b) of section 145-2.2 of the Regulations of the Commissioner of Education is added, effective June 3, 2015, as submitted.

Additional Changes to Education Law Contained in the Enacted 2015-16 Budget Relating to Higher Education that May Require Regulatory Changes.

Your Committee discussed possible regulatory amendments required as a result of changes to the Education Law enacted as part of the 2015-16 New York State Budget. The major changes that may require regulatory action are: Graduate Level Teacher and Leader Preparation Program Admission Standards, Suspension and Deregistration; Foster Youth College Success Initiative; and Teacher Tenure Hearings.

P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on May 18 and May 19, 2015. All members were present, except for Regent Tallon, who was excused.

ACTION ITEMS

Renewal Decisions for Charter Schools Authorized by the NYCDOE [P-12 (A) 1]

Your Committee recommends that the Board of Regents finds that, Bronx Community Charter School: (1) meets the requirements set out in Article 56 of the Education Law,

and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of this article; and (4) granting the application would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of Bronx Community Charter School as proposed by the Chancellor of the New York City Department of Education, and

extends its provisional charter for a term up through and including June 30, 2020.

Your Committee recommends that the Board of Regents finds that, Democracy Prep Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of this article; and (4) granting the application would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of Democracy Prep Charter School as proposed by the Chancellor of the New York City Department of Education, and

extends its provisional charter for a term up through and including June 30, 2020.

Your Committee recommends that the Board of Regents finds that, Hyde Leadership Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of this article; and (4) granting the application would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of Hyde Leadership Charter School as proposed by the Chancellor of the New York City Department of Education, and

extends its provisional charter for a term up through and including June 30, 2018.

Your Committee recommends that the Board of Regents finds that, South Bronx Classical Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of this article; and (4) granting the application would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of South Bronx

Classical Charter School as proposed by the Chancellor of the New York City Department of Education, and extends its provisional charter for a term up through and including June 30, 2019.

Renewal Decision for a Charter School Authorized by the Board of Regents [P-12 (A) 2] Your Committee recommends that the Board of Regents finds that, the Genesee Community Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the applicant can demonstrate the ability to operate the school in an educationally and fiscally sound manner; (3) granting the application is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of this article; and (4) granting the application would have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the renewal application of the Genesee Community Charter School and that a renewal charter be issued, and that its provisional charter be extended for a term up through and including June 30, 2020.

Revisions to a Charter Authorized by the Board of Regents [P-12 (A) 3]

Your Committee recommends that the Board of Regents finds that: (1) the charter school meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) the charter school can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to amend the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to amend the charter will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the charter revision for Charter High School for Law and Social Justice and amends the provisional charter accordingly.

Madam Chancellor and Colleagues: Your P-12 Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on May 19, 2015, copies of which have been distributed to each Regent.

MATTERS NOT REQUIRING BOARD ACTION

<u>APPR Discussion</u> – the Committee discussed a summary of the information received from stakeholders and experts as well as options for the Board to consider as the Department prepares regulations related to teacher and principal evaluation. Specifically, the Committee examined the Guiding Principles and discussed recommendations relating to Observations and Student Performance. The Committee also reviewed the Evaluation Matrix, as mandated under current statute. Department staff will consider the recommendations made by the Regents as they prepare proposed

regulations to be presented at the June meeting. A draft position paper will also be presented in June for the Committee to review.

Smart Schools Bond Act Update [P-12 (D) 1] – the Committee discussed the Smart Schools Bond Act which authorizes the issuance of \$2 billion of general obligation bonds to finance improved educational technology and infrastructure to improve learning and opportunity for students throughout the State. It also requires school districts to develop and receive approval of their Smart Schools Investment Plan from the Smart Schools Review Board, which is comprised of the Chancellor of the State University of New York, the Director of the Budget and the Commissioner of the State Education Department. School districts are also required to consult with parents, teachers, students, community members, and other stakeholders in developing their investment plan. Districts will begin submitting their investment plan via the Department Web Portal for review and approval on or before June 15.

My Brother's Keeper [P-12 (D) 2] – the Committee discussed "My Brother's Keeper" initiative to address persistent opportunity gaps faced by young men of color and ensure that all young people can reach their full potential. My Brother's Keeper is focused on six milestones:

- Getting a Healthy Start and Entering School Ready to Learn
- Reading at Grade Level by Third Grade
- · Graduating from High School Ready for College and Career
- Completing postsecondary education or training
- Successfully Entering the Workforce
- Keeping Kids on Track and Giving Them Second Chances

The Committee recommends that the Department establish a workgroup to articulate the alignment between My Brother's Keeper and the New York State reform agenda and report back to the Board this summer with recommendations.

Expulsion and Suspension of Children, Ages 3-5, from Regular Early Childhood and Special Education Programs [P-12 (D) 3] – the Committee discussed the federal Policy Statement on Expulsion and Suspension in Early Childhood Settings. The policy statement has raised awareness of problematic issues, provided recommendations to states and programs, and identified sources to assist in the effort. Staff made the following recommendations:

- Establish statewide policies to reduce and ultimately eliminate expulsions and suspensions of preschool students;
- Develop statewide guidance and disseminate it to each preschool program in the State;
- Build capacity to collect data to inform statewide guidance and identify trends;
- Provide regional professional development to preschool providers on positive and multi-tiered levels of behavior support.

School Receivership [P-12 (D) 4] – the Committee discussed a recommendation to amend Commissioner's regulations relating to school receivership in order to implement Section 211-f of Education Law as added by Chapter 56 of the laws of 2015. The proposed amendments designate current Priority Schools that have been in the most severe accountability status since the 2006-07 school years as persistently failing schools and vests the superintendent of the district with the powers of an independent receiver. The Committee reviewed the recommended changes to the regulations and directed the Department to consult with stakeholders regarding the new draft regulations in order to solicit their feedback and recommendations prior to Department staff submitting proposed emergency regulation to the Board of Regents at its June meeting.

P-12 EDUCATION/ HIGHER EDUCATION JOINT COMMITTEE

Your P-12 Education Committee and Higher Education Committee held a joint meeting on May 18, 2015

Action Item

Creation of Safety Nets for Candidates Who Take the New Teacher Certification Examinations (ALST, EAS and the Redeveloped CSTs) and an Extension of the Safety Net for the edTPA. Your Committees discussed amending Part 80 of the Commissioner's Regulations to provide a safety net for candidates who take the new teacher certification examinations.

Your Committees recommend that Sections 52.21, 80-1.5, 80-3.3, 80-3.4 and 80-5.13 of the Regulations of the Commissioner of Education be amended, as submitted, effective May 19, 2015, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to ensure that teacher candidates who will be applying for certification prior to June 30, 2016, have timely and sufficient notice of the safety net options available to them so that they may receive an initial certificate. The emergency rule will become effective May 19, 2015. It is anticipated that the proposed amendment will be adopted by the Board of Regents as a permanent rule at their September 2015 meeting. If adopted at the

September 2015 meeting, the proposed amendment will become effective as a permanent rule on October 7, 2015.

If New York wished to further reduce testing time, there are other options:
