#### **Issue for Decision**

Should the Regents approve the proposed renewal to the charter of the following school authorized by the Chancellor of the New York City Department of Education (NYCDOE):

1. Bronx Academy of Promise Charter School (full-term, five-year renewal)

## Reason(s) for Consideration

Required by State statute.

## **Proposed Handling**

This issue will be before the Board of Regents P-12 Education Committee and the Full Board for action at the June 2018 Regents meeting.

#### **Procedural History**

The Chancellor of the NYCDOE approved the renewal of this charter and submitted it to the Board of Regents for approval and issuance as required by Article 56 of the Education Law. The Chancellor of the New York City Department of Education asks that the charter be revised as indicated and has provided a summary for the school as set forth below.

#### **Recommendation**

VOTED: That the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the renewal charter of the **Bronx Academy of Promise Charter School** as proposed by the Chancellor of the New York City Department of Education, and that its provisional charter be extended for a term up through and including **June 30, 2023.** 

#### Timetable for Implementation

The Regents action for Bronx Academy of Promise Charter School will become effective July 1, 2018.

Requested Revisions	To decrease the maximum authorized enrollment from 650 to 615 students at the start of the new charter term on July 1, 2018.

#### **Rationale for Recommendation**

Taking into consideration the entirety of the Accountability Framework for NYC DOE Chancellor-authorized charter schools, the NYC DOE Chancellor is recommending a 5 Year, full-term renewal for Bronx Academy of Promise Charter School with three conditions. BAOP's renewal conditions are in the areas of governance and enrollment targets for at-risk students. The Board of Trustees must hold monthly meetings totaling no fewer than 12 meetings per year by the end of the next charter term. Additionally, the school must demonstrate growth in enrolling English Language Learners (ELLs) and Students with Disabilities (SWDs) that meet or exceed the host district rates by the end of the next charter term. Throughout the charter term, the NYC DOE charter authorizing team will conduct annual reviews (Annual Comprehensive Reviews) to serve as a mechanism to monitor the school's growth in these areas and provide feedback as to whether the school is on track to meeting the conditions in each year of the charter term.

Bronx Academy of Promise Charter School has consistently exceeded accountability standards and has performed above the CSD in both ELA and Math in each year of the charter term by significant amounts (20 points above in ELA and 24 points in Math in the most recent year). Additionally, the school has increased proficiency in each year of the charter term in both ELA and Math.

Bronx Academy of Promise Charter School enrolls a lower percentage of ELLs, and a lower percentage of SWDs (see Table 5). The school is demonstrating progress in the enrollment of SWDs and is closely working with the NYC DOE to increase the enrollment of ELLs and economically disadvantaged students as well. The under enrollment of ELLs and SWDs has resulted in a condition for the school in each of these areas. These conditions will be monitored yearly during the Annual Comprehensive Review process. Although Table 5 demonstrates that the school enrolls fewer Economically Disadvantaged students, the school is its own School Food Authority and is working with the NYC DOE to ensure that its data is accurately reported. Through these efforts, the school and the NYC DOE are working to ensure that all students in the Bronx have access to the strong academic program for at-risk students that has been developed at Bronx Academy of Promise.

The school's recruitment efforts, which are described in the Renewal Application include employing a Parent Coordinator that supports the school's economically disadvantaged (ED) student recruitment efforts. The school also advertises in various places (radio, newspaper, and flyer) in languages other than English as well as makes attempts to reach immigrant communities with multi-lingual staff members. The school's recruitment advertisements also include information about the special needs services they offer.

#### **Summary of Public Comment**

As required by the Charter School Act, the NYC DOE held a public hearing about the proposed renewal on November 20, 2017. Seventy-six individuals attended the hearing. Sixteen comments were made in support and none were made in opposition to the proposed charter renewal.
