SUMMARY

Issue for Decision (Consent)

Petition for: Waiver of New York State requirements pertaining to acceptability of licensing examinations

Statement of Problem: Mr. Mann took and passed three sections of the Uniform National Examination (UNE) from June 1985 to June 1988. He then transitioned to the national Landscape Architecture Registration Examination (LARE) and passed three additional sections of the LARE in December 1994, June 1995, and December 1995, for a total of six sections of the exam. Since his complex exam transition history covered four different versions of the national exam, his initial licensure state of Texas incorrectly informed him that he had passed all portions of the national exam and issued him his first license in 1996; however, he had not passed one required section of the LARE, *Programming and Environmental Analysis*.

Mr. Mann has been with the HNTB Corporation, a 7,200-person infrastructure firm, for 29 years and is an executive officer of the company, serving as HNTB's President of Corporate Development and a member of the Board of Directors. He is a national leader and subject matter expert in transportation enhancement/context-sensitive solutions (CSS) projects throughout the United States. He was elevated to fellowship in the American Society of Landscape Architects (ASLA) in 2008 based upon his work in landscape architecture, a status granted to less than 5% of the landscape architects in the US. Additionally, he reports decades of professional memberships in allied organizations, numerous publications and presentations, and dozens of awards, honors, recognitions, and other professional accomplishments over his career.

The Office of the State Board for Landscape Architecture estimates that the applicant passed ninety percent of the content of any given version of the examination. Mr. Mann satisfied the examination requirement in Texas, his initial state of licensure, based on his passing scores on the six sections of the four exam administrations available when he took the exam. Furthermore, he has received reciprocal licensure in 10 other jurisdictions of the US. He is requesting that, in view of his 29 years of licensed professional experience in Texas, licensure in numerous other jurisdictions, and his pre-eminence in the profession, the missing section of the examination be waived pursuant to E.L. 6506(5) and that his qualifications be accepted to satisfy the single missing licensing section of the examination. The Executive Secretary of the State Board for Landscape Architecture supports his request.

Petition for: Endorsement of applicant's medical license from Mexico.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Dies Suarez lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Dies Suarez's application. He recommends that the petitioner's unaccredited training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Dies Suarez obtained her medical license in Mexico in 1997. Her Mexican license is active and in good standing. Additionally, Dr. Dies Suarez holds both a Specialist diploma in Radiology and Imaging and certification in Radiology and Imaging.

The Executive Secretary of the State Board for Medicine recommends that Dr. Dies Suarez's Mexican license be endorsed, and her specialty diploma in Radiology and Imaging and certification by the Mexican Council of Radiology and Imaging be accepted to fulfill the proficiency and clinical competency requirements for endorsement.

Petition for: Endorsement of applicant's medical license from Spain.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Argiles-Martinez lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Argiles-Martinez's application. He recommends that Dr. Argiles-Martinez's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Argiles-Martinez obtained his medical license in Spain in 2007. His Spanish license is active and in good standing. Additionally, Dr. Argiles-Martinez holds a Master's Degree in Molecular Oncology and European Society for Medical Oncology certification.

The Executive Secretary of the State Board for Medicine recommends that Dr. Argiles-Martinez's Spanish license be endorsed, and that the theoretical exams of his specialty degree in Molecular Oncology and the European Society for Medical Oncology examinations be accepted to fulfill the proficiency and clinical competency requirements for endorsement.

Petition for: Endorsement of applicant's medical license from United Kingdom.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Fragoyannis lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Fragoyannis' application. He recommends that Dr. Fragoyannis' training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Fragoyannis obtained his medical license in the United Kingdom in 2005. His British license is active and in good standing. Additionally, Dr. Fragoyannis is ECFMG certified and holds certification with the Royal College of Surgeons of England and the Royal College of General Practitioners.

The Executive Secretary of the State Board for Medicine recommends that Dr. Fragoyannis' British license be endorsed, and his examinations with the Royal College of Surgeons of England and the Royal College of General Practitioners be accepted to fulfill the clinical competency requirements for endorsement.

Petition for: Waiver of New York State licensing requirements pertaining to education and passing an acceptable licensing examination.

Statement of Problem: Among other things, applicants for initial medical licensure in New York must satisfy both the examination requirements of Part §60.4, and the education requirements of Part §60.1. Currently, to fulfill Part §60.4, applicants must either pass the USMLE or COMLEX: national three-part examinations for allopathic and osteopathic physicians, respectively. For education, Part §60.1(a)(4) prescribes that, in addition to the other education requirements for initial licensure, applicants of non-registered programs must have “obtained a passing score on a satisfactory proficiency examination”. Certification by the Educational Commission for Foreign Medical Graduates (ECFMG) is accepted for this purpose, and this certification requires passing the USMLE Step 1 and Step 2 CK (“Clinical Knowledge”). In this way, allopathic international medical graduates (IMGs) are required to complete at least USMLE Step 1 and Step 2 CK in order to fulfill the proficiency examination for the education requirement (60.1), and also complete the entire USMLE sequence in order to fulfill the examination requirement (60.4).

Dr. Ashok Hemal has applied for licensure via the initial licensure pathway and must therefore demonstrate satisfaction of the licensing exam for both the education requirement and the examination requirement. Between April 2005 and January 2006, Dr. Hemal attempted USMLE Step 1 twice, scoring 165 and 163, respectively. During the same period, in February 2004, July 2006, and June 2007, Dr. Hemal attempted USMLE Step 2 CK (“Clinical Knowledge”), obtaining scores of 144, 158, and 148, respectively. These scores are all well below the minimum passing score on both Step 1 and Step 2 CK at that time, which was 182.

While an endorsement pathway exists in Medicine under Part §60.5 for those applicants who have never unsuccessfully attempted the licensing exam, applicants who have attempted and failed any part of the exam (without subsequently passing it) are not eligible for consideration of endorsement, pursuant to General Provision §59.6(c). In light of this, and Dr. Hemal’s history of unsuccessful attempts on USMLE, the applicant would instead petition for a waiver of both the examination and education requirements, under Education Law §6506(5).

Section 6506(5) states that the Board of Regents may “Waive education, experience and examination requirements for a professional license prescribed in the article relating to the profession, provided the Board of Regents shall be satisfied that the requirements of such article have been substantially met.” We do not have evidence that Dr. Hemal has passed a sequence of examinations equivalent to the sequence of proficiency and competency examinations required for physician licensure and thus do not see evidence that these requirements have been substantially met. Dr. Hemal has provided his C.V. as documentation of his professional achievement; however, given

the fact that he failed USMLE Steps 1 and 2 multiple times without ever passing them, a waiver of both the education and examination requirements for licensure is unwarranted. Additionally, we note that North Carolina Medical Board issued a letter of concern in the public record regarding patient harm resulting from his care of a patient on whom he performed surgery. The Executive Secretary for the State Board of Medicine recommends that Dr. Hemal's petition be denied.

Petition for: Endorsement of applicant's medical license from the United Kingdom.

Statement of Problem: Commissioner's Regulations allow endorsement of an applicant's license from another jurisdiction if appropriate requirements are met, and the applicant has not failed any part of New York State's licensing examination. A license granted in a foreign country can be endorsed if licensure in that country is regulated by an organization designated as responsible for quality assurance and acceptable to the Board of Regents. Additionally, the applicant must satisfactorily demonstrate completion of an acceptable proficiency examination, clinical competency examination, three years of American Council on Graduate Medical Education (ACGME) accredited postgraduate training or the equivalent, and five years of satisfactory professional experience.

Dr. Kadir lacks three years of accredited postgraduate training. The Executive Secretary of the State Board for Medicine has reviewed the documentation submitted in support of Dr. Kadir's application. He recommends that Dr. Kadir's training be accepted as the equivalent of the three years of ACGME-accredited postgraduate training required for licensure.

Commissioner's Regulations allow the Board of Regents to accept appropriate foreign medical licenses and diplomate certificates to fulfill the license, proficiency, and clinical competency requirements for New York State licensure by endorsement. Dr. Kadir obtained his medical license in the United Kingdom in 1992. His British license is active and in good standing. Additionally, Dr. Kadir is ECFMG certified and passed examination with the Royal College of Surgeons of Edinburgh in the Specialty of Cardiothoracic Surgery in July 2003.

The Executive Secretary of the State Board for Medicine recommends that Dr. Kadir's British license be endorsed, and his ECFMG certification and specialty in Cardiothoracic Surgery be accepted to fulfill the proficiency and clinical competency requirements for endorsement.

The applicable requirements of Section 3.57 of the Rules of the Board of Regents require completion of a medical education program in a foreign medical school satisfactory to the Department which does not grant the degree Doctor of Medicine (M.D.), and in which the philosophy and curriculum were equivalent, as determined by the Department in accordance with the policy of the Board of Regents, to those in programs leading to the degree Doctor of Medicine (M.D.) at medical schools in the United States satisfactory to, or registered by, the Board of Regents and the Department. Secondly, petitioners must have licensure to practice medicine in New York State in accordance with provisions of Section 6524 or 6528 of the Education Law or their equivalent as determined by the Board of Regents pursuant to their authority under Section 6506 of the Education Law.
