STANDING COMMITTEE REPORTS

P-12 EDUCATION

Your P-12 Education Committee held its scheduled meeting on June 17, 2013. All members were present.

ACTION ITEMS

Protection of People with Special Needs Act

Your Committee recommends that paragraphs (3) and (6) of subdivision (b) of section 200.7 and section 200.15 of the Regulations of the Commissioner be amended as submitted, effective June 30, 2013, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to immediately conform the Regulations of the Commissioner to the requirements of Chapter 501 of the Laws of 2012, so that such requirements may be fully implemented by the Department, residential schools, and other affected parties by the June 30, 2013 effective date, and thereby ensure that students attending residential schools are protected against abuse, neglect and significant incidents that may jeopardize their health, safety and welfare. [P-12 (A) 2]

<u>New York State Career Development and Occupational Studies Commencement</u> <u>Credential (NYS CDOS Commencement Credential)</u>

Your Committee recommends that subparagraph (i) of paragraph (7) of subdivision (b) of section 100.5; section 100.6; and subparagraph (iii) of paragraph (5) of subdivision (a) of section 200.5 of the Regulations of the Commissioner relating to the establishment of a New York State Career Development and Occupational Studies Commencement Credential (NYS CDOS Commencement Credential) be amended, as submitted, effective July 3, 2013. Department actions to support implementation of the credential will be discussed at the July 2013 Board of Regents Meeting. [P-12 (A) 3]

MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your P-12 Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on June 18, 2013, copies of which have been distributed to each Regent.

MATTERS NOT REQUIRING BOARD ACTION

<u>Common Core Implementation Update</u> – The Committee was provided with an update on the Department's progress in implementing the Common Core Learning Standards. Discussion focused on the instructional shifts, evidence collection tools, and the tristate rubric used to evaluate local criteria. The Committee watched two videos that illustrated the Common Core shifts and teacher practice.

<u>Regents Research Paper</u> – The Committee discussed proposed regulatory amendments to Commissioner's Regulations that would establish a Regents Research Paper requirement as an opportunity for students to demonstrate necessary college and career readiness skills and CCLS writing standards that cannot be measured in an examination setting due to time constraints. The regulation would require the completion of a Regents Research Paper for graduation with a Regents or local high school diploma, beginning with those students who first enter grade 9 in September 2013 or thereafter. Committee members requested that more detailed information be provided to guide the discussion when the proposed amendment is submitted to the Board of Regents for adoption in September. [P-12 (D) 1]

<u>BOCES Space Plan Update</u> – The Committee discussed proposed amendments to Commissioner's Regulations to repeal the special education space plan requirements and add a requirement that BOCES district superintendents must determine the adequacy and appropriateness of facilities space housing special education programs in the geographic area of their BOCES. This is a result of mandate relief discussions held in April 2009, where the Board of Regents discussed specific State law/regulation requirements in special education that, if repealed or amended, may result in administrative relief and/or cost savings to school districts. As a result of this discussion, and in consideration of public comment, the Regents provided support for a limited number of these proposals including that the Department seek legislation to repeal space planning requirements while retaining the requirement to ensure stability of space for students with disabilities. [P-12 (D) 2]

<u>Expanded Learning Time</u> – The 2013-2014 enacted budget provides \$20 million for the 2013-2014 school year to increase school-wide learning opportunities in high-quality expanded school day and/or expanded school year programs with a focus on improving academic achievement. The Committee participated in a panel discussion with school leaders from across the state to talk about their extended day and expanded school year programs. Panel members included:

<u>Community Schools</u> - The 2012-2013 enacted budget provides for a \$15 million Community Schools initiative, of the \$75 million NY Education Reform Commission Competitive Grants. The purpose of the grant program is to provide resources for eligible applicants to reconfigure current or integrate existing programs and sources of funding with this new initiative to reach and support at-risk and high-need students and families in their respective communities through enhanced and coordinated service delivery. The Committee participated in a panel discussion with community leaders from community based organizations. Panel members included:

- Jane Quinn, Vice President and Director of National Center for Community Schools Children's Aid Society
- Melanie Mullan, Vice President, Turnarond for Children, Inc.
- Antonina Simeti, Director of Planning and Implementation, Community Learning Schools.

Staff will develop a request for proposals in coordination with the New York State Council on Children and Families to implement community schools programs that use school buildings as community hubs to deliver co-located or school-linked academic, health, mental health, nutrition, counseling, legal and/or other services to students and their families. [P-12 (D) 4]

Increasing Access and Quality of Universal Prekindergarten Grant - The 2013-2014 enacted state budget provided \$25 million in competitive grant funding to establish new full-day and half-day pre-kindergarten placements and to convert existing half-day placements into full-day placements based, in part, on district and student need. Budget funds will be used to expand the NYSED's Universal Preschool program to high need children in high need districts in order to increase learning opportunities and support young children's development in early childhood education. This support results in children who can enter kindergarten better prepared to learn and succeed in elementary and secondary schools. [P-12 (D) 5]

<u>Update on Enrollment and Retention Targets for Charter Schools</u> – the Committee was updated on the ongoing work relating to enrollment and retention targets for charter schools. In December 2012, the Department posted the final enrollment and retention calculators and these targets are now applicable, per statute, to new schools that opened after fall 2010 and schools that have been renewed since January 2011. At charter renewal, New York State charter authorizers must take into consideration the extent to which schools meet or exceed their enrollment and retention targets. Staff from the Department's Charter Schools Office and the SUNY Charter Schools Institute worked together to implement this statutory requirement. The Committee also discussed the 2013-14 release of a Stability Index for all public schools in the State. The proposed Stability Index will calculate the number of students who persist in enrollment for all public schools in the state. For public charter schools the Index may provide the Department with additional data regarding enrollment trends that, in combination with a public inquiry or evidence from a site visit, may trigger a formal audit from the Department. These types of audits are fully within the scope of the Department's authority to conduct investigations and audits into any inquiry to ensure compliance with law and charter. [P-12 (D) 6]

Adoption of New Linkage Rules and an Enhanced Growth Model for Annual Professional Performance Reviews (APPRs)

Your Committees recommend that the Board of Regents approve the linkage rules, the addition of student growth measures for principals in schools with grades 9-12 and an enhanced growth model for APPRs conducted in the 2012-2013 and 2013-2014 school years, all as described in the item;

Your Committees recommend that the Board of Regents approve a value-added measure for the 2014-2015 school year as described in the item; and

Your Committees recommend that the Board of Regents amend section 30-2.2 of the Rules of the Board of Regents as submitted, effective July 1, 2013, as an emergency measure to preserve the public welfare to ensure that school districts and BOCES are notified immediately of the change to the definitions of student growth percentile score for APPRs conducted in the 2012-2013 school year.

P-12 EDUCATION/AUDITS/BUDGER AND FINANCE JOINT MEETING

Your P-12 Education Committee and Audits/Budget and Finance Committee held a joint meeting on June 17, 2013. All members were present.

MATTERS NOT REQUIRING BOARD ACTION

Update on Special Education Fiscal Oversight Actions – The Committee discussed staff recommendations to strengthen the fiscal oversight and accountability measures of special education providers. Discussion focused on the Regents recommendations related to the Special Education Financial Advisory Workgroup and next steps. Other recommendations include the creation of a monitoring plan for the Department to review approved providers; the requirement that special education providers undergo annual fiscal training; and the requirement that special education providers select a certified public accountant from an SED approved list for the purpose of certifying its financial statements. The Department will continue its actions to strengthen the fiscal oversight and accountability measures of special education providers and report to the board regarding further actions taken, as well as any legislative and/or regulatory proposals that may be necessary.

AUDITS/BUDGET AND FINANCE

The Regents Committee on Audits/Budget and Finance met as scheduled yesterday afternoon, June 17, 2013. Chancellor Tisch, Regents Brown, Dawson, Chapey, Cea, Cottrell, Norwood, Phillips, Tallon, Tilles, and Young were in attendance.

Items for Discussion

March 2013 Fiscal Report

Our Chief Financial Officer briefed the Members. General Fund spending reflects the amounts appropriated in the 2013-14 enacted budget. Accounts are in structural balance with the exception of the Tenured Teacher Hearings (TTH) account. The enacted State budget includes a \$6 million appropriation for claims, a \$2.2 million increase from the prior year. With these funds, the deficit at the end of 2013-14 is

projected to be \$6.2 million. Special Revenue accounts are all in structural balance on a current year basis and the accumulated negative balance in the Cultural Education Account is being reduced by approximately \$700,000.

Update on Credit Recovery Audit

The Committee was updated on the status of actions taken to address recommendations contained in an April 2013 Office of the State Comptroller (OSC) audit on the use of Credit Recovery by School Districts.

Completed Audits

The Committee was presented with 19 audits this month. Three of the audits were issued by the Office of Audit Services, 15 by the OSC and one by the New York City Comptroller's Office. Fifteen of the audits were of school districts, two were of charter schools, one was a College, and one examined the use of a network within the New York City Department of Education.

The findings were in the areas of claims processing, cash, financial reporting, information technology, capital construction, budgeting, the Tuition Assistance Program, and the use of a network. The Committee was briefed in more detail on the audits of the use of Unique Student Identifiers in school districts and the audit of Lake Grove/Mountain Lake Maintenance and Tuition Payments.

PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on June 17, 2013. All Committee Members were present, except for Vice-Chancellor Anthony S. Bottar, who was excused. Chancellor Merryl H. Tisch was also present, but did not vote on any case or action.

ACTION ITEMS

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 4 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 33 consent order applications and 8 surrender applications be granted. [PPC EXS (A) 1-3]

These recommendations are made following the review of 45 cases involving twelve registered professional nurses, eight licensed practical nurses, three certified public accountants, three licensed practical nurses who are also registered professional

nurses, two dentists, two professional engineers, two psychologists, one architect, one audiologist, one clinical laboratory technician, one licensed clinical social worker, one licensed master social worker, one massage therapist, one pharmacist, one physical therapist, one physical therapist assistant, and one registered public accountancy partnership.

Restorations

Update on the new High School Equivalency Test – The Committee was provided an update on our progress to assure that a viable pathway to the State High School Equivalency diploma remains available on January 2, 2014 when a new High School Equivalency test is implemented. CTB/McGraw Hill will develop a new test called Test Assessing Secondary Completion (TASC). The cost of the test will be \$52 per test administered in 2014, \$54 in 2015, and \$56 in 2016. CTB/McGraw Hill will be responsible for the development, printing, scoring and transfer of TASC test scores to SED. Regular meetings between SED and CTB/McGraw Hill regarding the development of test have focused on accommodations, business practices, error

corrections and communications. Field testing of TASC began in May and will continue until July. The 2013-2014 State Budget provided SED with an additional \$1.5 million for services and expenses related the High School Equivalency test. The funding will be used to hire new staff to implement the new test, develop a data system for the new test, and train the adult education community to Common Core Standards. A Common Core Workgroup has been formed to develop a multi year action plan to roll out Common Core standards to the Adult Education community. A training workshop on the Tri-State Rubric was conducted by Regents fellows to the Workgroup in May. In addition, in order to create multiple pathways to the High School Equivalency Diploma, we anticipate creating an expert panel to review test instruments other than TASC which will be state subsidized. Test vendors will be asked to submit their instruments for review and recommendation to the Board of Regents. We hope to start this process in the fall of this year.

HIGHER EDUCATION

Your Higher Education Committee held its scheduled meeting on June 18, 2013.

ACTION ITEMS

Proposed Amendment to Section 80-5.5 of the Regulations of the Commissioner of Education Relating to the Employment of Retired Public Employees. Your Committee voted that subdivision (b) of section 80-5.5 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 1, 2013, upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare in order to timely implement the provisions of Part Y of Chapter 57 of the Laws of 2013 of the recently enacted Budget Bill. The proposed amendment will become effective on July 1, 2013. It will then be presented to the Board of Regents for permanent adoption at its September 2013 Regents meeting. If adopted at the September meeting, the proposed amendment will become effective on October 2, 2013.

Renewal of Institutional Accreditation – New York Academy of Art. Your Committee recommends the renewal of Institutional Accreditation for the New York Academy of Art without conditions for a period of seven years, with provision of a five-year financial projection to be included on one or more of The Academy's annual reports, and submission of a mid-term report addressing the recommendation and suggestion in the draft report, and addressing the need for a comprehensive assessment plan and evidence of its implementation.

MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in

the written report of the Committee's deliberations at its meeting on June 18, 2013, copies of which have been distributed to each member of the Board of Regents.

Other matters not requiring action:

Proposed Amendment to Part 80 of the Regulations of the Commissioner of Education Relating to the New Teacher and School Building Leader Certification Examination Requirements. Your Committee discussed proposed changes to the certification examination requirements that were amended in December 2012. Specifically, changes will address the need to remove edTPA for Speech Language, Career and Technical Education and Educational Technology Specialist candidates. Your Committee also discussed whether or not to require the Educating All Students assessment for School District Leaders. It is anticipated that the proposed amendment will be presented for permanent adoption at the September 2013 Regents meeting, after the 45-day public comment period required pursuant to the State Administrative Procedure Act. If adopted at the September meeting, the proposed amendment will become effective on October 2, 2013.

Accreditation Update. Your Committee received a brief review of the process by which institutional accreditation applications are distributed to Board members for their consideration.

CULTURAL EDUCATION

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report. Your Committee on Cultural Education Committee had its scheduled meeting on June 18, 2013.

ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting. The meeting's scheduled starting time was changed to 11am.

Deputy Commissioner Jeffrey Cannell reported on the following. He invited the members of the board to a reception at the Museum opening the Best of SUNY Exhibition. He also mentioned that the Civil War exhibit at the Museum, the Irrepressible Conflict, received an award of merit from the American Association for State and Local History. Finally, he noted the accomplishments of two OCE staff members: Kathleen Roe was elected vice-president/president elect of the Society of

American Archivists and Edward Landing was named a fellow of the Geological Society of America

CE (D) 3 - Summer School for the Arts

Sara Fittizzi, Executive Direction of the Summer School for the Arts (NYSSSA), provided a brief summary on the 2013 summer season for NYSSSA. The month of June not only launched the beginning of the season but marked the 44th year of the program.

The committee received a schedule of performances and other activities in which Board of Regents members may wish to participate. In addition, Fittizzi provided the committee information regarding applications, enrollments and program highlights.

CE (D) 2 - Regents Advisory Council on Libraries Report

Bernard Margolis, State Librarian and Assistant Commissioner for Libraries introduced members of the Advisory Council on Libraries. The members of the committee provided an update report on implementation activities based on the Regents Advisory Council on Libraries recommendations. These recommendations were given to the Committee in 2012 in the report 20/20 Vision. The committee highlighted their recommendations for high-priority actions by the Board of Regents.

CE (D) 1 – Summer Field Schools (Professional Development Workshops for Teachers) Brian Bird, a geologist at the State Museum, provided a report regarding one of the four upcoming Summer Field Schools being offered to teachers this summer. Bird's presentation highlighted the Earth Science Teacher Workshop, which will be held in Albany. Since 2001 over 220 teachers have participated in the Earth Science Program. Bird noted that in 2014, OCE plans to hold the workshop in the Finger Lakes region in order to solicit greater participation by teachers in that region.

The Bottom Line

- For the first time, most students who entered Grade 9 in 2008 or later did not have a local diploma option for graduation.
- Despite this increase in rigor, overall statewide graduation rates remained stable this year. An increasing percentage of students earned a Regents diploma.
- Graduation rates in the Big 5 city school districts generally decreased slightly for the 2008 cohort.
- Graduation rates remain too low, and achievement gaps remain.

The Path Forward

- The Board of Regents continues to advance an educational reform agenda with the goal of ensuring that all students are college and career ready.
- The graduation rates announced today, covering the cohort of students who entered Grade 9 in 2008, do not yet fully reflect the impact that the Regents reform agenda will have on student outcomes.

The Path Forward (cont'd)

Critical aspects of the reform agenda that are expected to lift student performance and prepare them for college and careers include:

- Implementing **Common Core standards** and developing curriculum and assessments aligned to these standards.
- Building **instructional data systems** that measure student success and inform teachers and principals how they can improve practice in real time.
- Recruiting, developing, retaining, and rewarding effective teachers and principals.
- **Turning around** the lowest-achieving schools.



Percentage of Students Graduating with a Local, Regents, or Regents with Advanced Designation diploma <u>After 4 Years</u>





Results Through June, All Students










The Achievement Gap Persists

- The overall graduation rate achievement gap has remained relatively stable.
- The gap is widest for the Advanced Designation diploma.
- Differences are decreasing between the cohort percentages of Black or Hispanic, and White students earning Local Diplomas.

Statewide, the graduation rate achievement gap has remained relatively stable. The gap is larger based on the percent of the cohort that earned a Regents Diploma with Advanced Designation. Differences are decreasing between the cohort percentages of Black or Hispanic and White students earning Local Diplomas.

Percentage Point Difference in Percentage of Cohort Earning Credentials after Four Years


Positive values indicate the rate for Black/Hispanic students was lower than for White students Negative values indicate the rate for Black/Hispanic students was higher than for White students

Beyond Graduation Rates: Aspirational Performance Measures

- The Local Diploma was no longer an option for most general education students who began grade 9 in September 2008 or later (see Slide 22).
- The Department will continue to implement changes to the assessment program to better support the determination of college- and career-readiness.
- The Regents have established Aspirational Performance targets to be used by schools and districts to measure progress.

2008 Cohort Outcomes on two Aspirational Performance Measures (APMs) are reported for all Districts and High Schools

1. Advanced Regents Diploma Percentage APM

The percentage of cohort students who earned a Regents Diploma with Advanced Designation (22 units of credit, 7-9 Regents examinations at 65 or above, and advanced course sequences in languages other than English, CTE, or the arts)

2. ELA/Math APM

The percentage of cohort students who graduated with a Local, Regents, or Regents with Advanced Designation diploma **and** earned a 75 or greater on their English Regents examination **and** earned a 80 or greater on a math Regents examination

Outcomes on APMs are significantly lower than the overall graduation rates.


We will report APMs for schools and districts while college and career-ready graduation requirements are phased in for students.

Aspirational Performance Measures - Usage

NYSED will update these APMs as new research findings become available and as State assessments become aligned with the Common Core State Standards.

Although the ELA/Math APM remains a useful within-year comparison against performance benchmarks and across schools and districts, this measure is not directly comparable across the 2007 and 2008 cohorts, in part because of the different math Regents exams that were introduced and retired during the 2007-08 to 2009-10 school years (see Slide 23).







* The local diploma option remains for general education students who pass three Regents examinations with a score of 65 or above and two Regents examinations through an appeals process. In addition, students with disabilities who earn Regents examination scores between 45 and 64 continue to be eligible for a local diploma under the various safety net options. Students with disabilities who first enter grade 9 prior to September 2011 and fail any of the five required Regents examinations may earn a local diploma by passing the corresponding Regents Competency Test (RCT).
