#### Proposed Amendments to Sections 52.21, 80-2.1 80-3.1, 80-3.11, 80-3.12 and 80-5.23 and the Titles of Subparts 80-2 and 80-3 of the Commissioner's Regulations Relating toSchool Counseling Program Registration, School Counselor Certification Requirements, and a One-Year Time Extension for Institutions of Higher Education to Meet the New Program Registration Requirements BR (CA) 1

**MOVED**, that Sections 52.21, 80-3.1, 80-3.11, 80-3.12 and 80-5.23 and the titles of 80-2 and 80-3 of the Regulations of the Commissioner of Education be amended as submitted, effective July 31, 2019.

#### Proposed Amendment to Section 80-1.5 of the Regulations of the Commissioner of Education Relating to the Extension of the Educational Technology Specialist Content Specialty Test Safety Net BR (CA) 2

**MOVED,** that Section 80-1.5 of the Regulations of the Commissioner of Education be adopted, as an emergency measure, effective July 16, 2019, to preserve the general welfare in order to ensure that the safety net becomes effective immediately so candidates can be held harmless during the redevelopment of the Educational Technology Specialist Content Specialty Test and to ensure that the emergency rule adopted at the April 2019 meeting remains continuously in effect until it can be adopted as a permanent rule; and

#### Proposed Amendment to Sections 80-3.15 and 80-4.3 of the Regulations of the Commissioner of Education Relating to the Extension of the Application Deadline for the Statement of Continued Eligibility (SOCE) for Certain Teachers of Students with Disabilities and to the Extension of the Deadline for Completing Teaching Experience While Under a HOUSSE Rubric for the SOCE and Limited Extension for Certain Teachers of Students with Disabilities BR (CA) 4

#### Proposed Amendment to Sections 80-5.8 and 80-5.20 of the Regulations of the Commissioner of Education Relating to the Eligibility Requirements for the Endorsement Pathway for Certification as an Educator in the Classroom Teaching Service or in the Educational Leadership Service BR (CA) 5

**MOVED**, that Sections 80-5.8 and 5.20 of the Regulations of the Commissioner of Education be adopted as an emergency action, effective September 2, 2019, to allow candidates to take advantage of the proposed eligibility requirements for the endorsement pathway during the summer when many candidates will apply for certification in anticipation of the 2019-2020 academic year and to ensure that the emergency action taken at the June 2019 meeting of the Board of Regents remains continuously in effect until it can be adopted as a permanent rule at the October 2019 Board of Regents meeting.

#### Proposed Amendment to §64.7 of the Regulations of the Commissioner of Education Relating to the Execution by Registered Professional Nurses of Non-Patient Specific Orders to Administer Immunizations BR (CA) 10

**MOVED**, that subdivision (a) of §64.7 of the Regulations of the Commissioner of Education be amended, as submitted, effective August 3, 2019, as an emergency action

upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare to conform the Regulations of the Commissioner of Education to current immunization standards in order to enhance the protection of the public health by expanding access to needed immunizing agents for infants, children and adults during the 2018-2019 influenza season and current measles outbreaks in New York State.

#### Regents Permission to Operate in New York State: Lake Erie College of Osteopathic Medicine BR (CA) 11

**MOVED**, that the Board of Regents grant permission to operate for Lake Erie College of Osteopathic Medicine (LECOM) to offer its D.O. program in Osteopathic Medicine in Elmira, New York. This permission to operate will be effective until July 16, 2020. Once the Department receives notification of COCA final approval and evidence that the D.O. program continues to meet program registration standards, it will be extended until July 16, 2025.

### Proposed Amendment to §155.17 of the Regulations of the Commissioner of Education Relating to School Safety Plans [P-12 (A) 2]

Your Committee recommends that Section 155.17 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2019, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the public safety and general welfare to timely implement Section 32 of Part YYY of Chapter 59 of the Laws of 2019, which become effective on July 1, 2019.

The motion passed.

## Proposed Amendment to Section 104.3 of the Commissioner's Regulations Relating to Assessments and Student Official Transcripts and Permanent Records [P-12 (A) 3]

Your Committee recommends that §104.3 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2019, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to ensure that the proposed amendment implements the provisions of Section 30 of Part YYY of Chapter 59 of the Laws of 2019 and remains in effect until adopted as a permanent rule; and further your Committee recommends that §104.3 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 31, 2019.

Charter Schools: Merger Revisions to Charters Authorized by the Board of Regents [P-12 (A) 4]

#### KIPP NYC Public Charter Schools

VOTED: That pursuant to the authority contained in Education Law §§223 and 2853(1)(b-1)

1. KIPP NYC Public Charter Schools be and hereby is merged with KIPP NYC Public Charter Schools II, with KIPP NYC Public Charter Schools II as the surviving

education corporation under the amended name, KIPP NYC Public Charter Schools.

- 2. KIPP NYC Public Charter Schools II, the surviving corporation, shall continue to administer the educational operations and purposes of the constituent corporations in the same manner as they presently exist.
- 3. The separate existence of KIPP NYC Public Charter Schools and KIPP NYC Public Charter Schools II hereby ceases, and KIPP NYC Public Charter Schools II, the surviving corporation under the amended name KIPP NYC Public Charter Schools is hereby vested with all the rights, privileges, immunities, powers, and authority possessed by or granted by law to each of the constituent corporations. All assets and liabilities of the respective constituent corporations are hereby assets and liabilities of such surviving corporation. All property, real, personal, and mixed and all debts to each of the corporations on whatever account are hereby attached to KIPP NYC Public Charter Schools II, the surviving corporation under the amended name KIPP NYC Public Charter Schools II, the surviving corporation under the amended name KIPP NYC Public Charter Schools, and may be enforced against it to the same extent as if the debts, liabilities, and duties had been incurred or contracted by it.
- 4. The merged corporation shall operate under the provisional charter granted to KIPP NYC Public Charter Schools II under the amended name KIPP NYC Public Charter Schools, which is hereby amended to authorize the operation of seven public charter schools as follows:
  - i. KIPP STAR College Prep Charter School;
  - ii. KIPP NYC Washington Heights Academy Charter School;
  - iii. KIPP Always Mentally Prepared Charter School;
  - iv. KIPP Infinity Charter School;
  - v. KIPP Freedom Charter School;
  - vi. KIPP Bronx Charter School II; and
  - vii. KIPP Bronx Charter School III
- 5. The merger herein shall take effect nunc pro tunc on July 1, 2019; and it is further

VOTED: That the Board of Regents finds that: (1) KIPP NYC Public Charter Schools meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) KIPP NYC Public Charter Schools can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by KIPP NYC Public Charter Schools, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

VOTED: That the Board of Regents finds that: (1) KIPP NYC Public Charter Schools II meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) KIPP NYC Public Charter Schools II can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by KIPP NYC Public Charter Schools II, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

#### **Democracy Prep New York Charter Schools**

VOTED: That pursuant to the authority contained in Education Law  $\$  and 2853(1)(b-1)

- 1. Democracy Prep Endurance Charter School be and hereby is merged with Democracy Prep New York Charter Schools, with Democracy Prep New York Charter Schools as the surviving education corporation.
- 2. Democracy Prep New York Charter Schools, the surviving corporation, shall continue to administer the educational operations and purposes of the constituent corporations in the same manner as they presently exist.
- 3. The separate existence of Democracy Prep Endurance Charter School and Democracy Prep New York Charter Schools hereby ceases, and Democracy Prep New York Charter Schools, the surviving corporation is hereby vested with all the rights, privileges, immunities, powers, and authority possessed by or granted by law to each of the constituent corporations. All assets and liabilities of the respective constituent corporations are hereby assets and liabilities of such surviving corporation. All property, real, personal, and mixed and all debts to each of the corporations on whatever account are hereby attached to Democracy Prep New York Charter Schools, the surviving corporation, and may be enforced against it to the same extent as if the debts, liabilities, and duties had been incurred or contracted by it.
- 4. The merged corporation shall operate under the provisional charter granted to Democracy Prep New York Charter Schools, which is hereby amended to authorize the operation of five public charter schools as follows:
  - i. Bronx Preparatory Charter School;
  - ii. Harlem Prep Charter School;
  - iii. Democracy Preparatory Charter School;
  - iv. Democracy Prep Harlem Charter School; and
  - v. Democracy Prep Endurance Charter School

5. The merger herein shall take effect *nunc pro tunc* on July 1, 2019; and it is further

VOTED: That the Board of Regents finds that: (1) Democracy Prep Endurance Charter School meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) Democracy Prep Endurance Charter School can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by Democracy Prep Endurance Charter School, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

VOTED: That the Board of Regents finds that: (1) Democracy Prep New York Charter Schools meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) Democracy Prep New York Charter Schools can demonstrate the ability to operate in an educationally and fiscally sound manner; (3) granting the request to revise the charter is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) granting the request to revise the charter would have a significant educational benefit to the students expected to attend the schools operated by Democracy Prep New York Charter Schools, and the Board of Regents therefore approves the charter revision and amends the provisional charter accordingly.

The motion passed. Regents Collins and Mittler abstained.

Proposed Amendment to Section 175.5 of the Regulations of the Commissioner of Education Providing for a Waiver for Up to Four School Years (2018-2019, 2019-2020, 2020-2021 and/or 2021-2022) for Certain School Districts That Cannot Meet the Minimum Instructional Hours Because of Safety and/or Scheduling Issues [P-12 (A) 5]

Your Committee recommends that section 175.5 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2019, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to provide schools districts with notice that if they cannot meet the minimum instructional requirements due to safety and/or scheduling issues they can apply to the Commissioner for a single waiver for up to four years of such requirements by November 15, 2019.

The motion passed.

#### MATTERS NOT REQUIRING BOARD ACTION

**P-12 Education Committee 2019-2020 Priorities** – Your Committee discussed a general overview of the opportunities and clarity that the established priorities will provide in guiding work; assessing achievement and forward movement; and forecasting for the field the work that is expected to come before the Committee over the next year. This discussion will continue at the September 2019 P-12 Education Committee.

Proposed Addition of Part 121 to the Regulations of the Commissioner Relating to Strengthening Data Privacy and Security in NY State Educational Agencies to Protect Personally Identifiable Information [P-12 (D) 1 - REVISED] – Your Committee discussed proposed amendments to regulations relating to protecting personally identifiable information. Draft regulations were discussed in January 2019 and based on public comment received, revised regulations were brought before the Committee this month. Major changes include but are not limited to providing clarity regarding the complaint process, the requirements of the Data Security and Privacy Plan, and what should be included as part of the annual data privacy and security awareness training.

**ESSA Financial Transparency Requirement** [P-12 (D) 2] – Your Committee was provided with an update on the implementation of the Every Student Succeeds Act (ESSA) Financial Transparency Requirement, as previously discussed at the April meeting. Over the past fourteen months, the Department has undertaken a rigorous approach of outreach to stakeholders to develop a report template and uniform guidance in submitting expenditure data. Preliminary draft guidance was published in May, and stakeholders have been given until July 17, 2019 to review the document and provide feedback for recommended amendments and improvements. Final guidance will be issued following that period, with all reporting expected to be completed by early 2020.

#### PROFESSIONAL PRACTICE

Your Professional Practice Committee held its scheduled meeting on July 15, 2019. All members were present. Chancellor Betty A. Rosa was also present but did not vote on any case or action.

#### **ACTION ITEMS**

#### **Professional Discipline Cases**

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports, which have been distributed to you, be accepted in 3 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 50 consent order applications and 18 surrender applications be granted, and further recommends that 1 summary suspension application be granted.

These recommendations are made following the review of 72 cases involving sixteen registered professional nurses, fifteen licensed practical nurses, nine licensed practical nurses who are also registered professional nurses, three chiropractors, three dentists, three pharmacists, two licensed master social workers, one certified public accountant, one dental hygienist, one dental professional corporation, one licensed clinical social worker, one massage therapist, one pharmacy, one podiatrist, one professional engineer, one registered professional nurse who is also a nurse practitioner (Adult Health), and one registered professional nurse who is also a nurse practitioner (Family Health).

# Introduction

- Chancellor Rosa noted in February 2019 NYSSBA On Board Commentary "It's time that we rethink the high school diploma" that:
  - "The latest graduation rate figures are similar to the results we have seen in each of the last several years. The graduation rate continues to slowly edge up, but stubborn gaps in achievement persist - gaps that separate students of color, students with disabilities, English language learners, and low-income students from their peers who are white and attend school in low-need districts."
  - "While it was encouraging to see signs that we are moving in the right direction...the rate of improvement is far too slow by any objective measure. Simply put, the system is not working for everyone, and too many students particularly our most vulnerable students - are leaving high school without a diploma."
- Goal: Define what a New York State high school diploma means and what it ought to signify

### What Do Other States Require?

- 60% of states do not require an exit exam to graduate high school.<sup>1</sup>
- Of 20 states with high school graduation exit exams, more than half require 3 or fewer exams.<sup>1</sup>
- Some of New York's Neighboring States:
  - Massachusetts requires 3 exit exams (ELA, Math, and Science)
  - New Jersey requires an ELA and Mathematics High School exam
  - Pennsylvania does not currently require exit exams



## State Expectations for Graduation Matter (2018)<sup>1</sup>

- States offer more than 100 different high school graduation options for students.
- Although often billed as a single, statewide diploma, many states still have different sets of expectations for students to complete high school, depending on the option students choose or on the options made available to them.
- Half of states offer at least two graduation options for students, with a few offering students five or more options.
- States may offer discrete diplomas or the state may present its options as endorsements, designations or different curriculum requirements on top of a single diploma.



## Establish a Blue Ribbon Commission on NY State's Diploma

- Create a working stakeholder group with overlap to commission membership including: current or recent parents, students, educators, researchers, advocates, higher education and business leaders.
  - Big 5, NYSCOSS, NYSSBA, NYSUT, PTA, SAANYS, UFT and others
- The purpose of the commission is to make recommendations to:
  - revise current diploma requirements;
  - ensure all students have access to multiple graduation pathways; and
  - include a recommended transition plan timeline that allows time to prepare for and implement the changes.



# **Big Questions**

- In February 2019, the Chancellor asked Regents Johnson and Mead, Cochairs of the Regents Research Workgroup, to look at revising New York's graduation requirements with a focus on research, practice and policy.
- Their work will include, but not be limited to, addressing key questions, such as:
  - What do we want our children to know and to be able to do before they graduate?
  - How do we want them to demonstrate such knowledge and skills?

  - What other measures of achievement (e.g., capstone projects, alternative assessments or engagement in civic and community activities) could serve as indicators of high school completion?

Dear Chancellor Rosa and Honorable Members of the Board of Regents:

I am writing to notify you that I will resign from my post as Commissioner for the New York State Education Department (NYSED) on August 31, 2019. It has been my great pleasure and honor to serve the students and teachers of New York over the last four years as we work to advance equity and excellence in our education system.

Together with the Governor, State Legislature and distinguished Board of Regents, I am proud of our department's work to reform school accountability and improvement programs; offer improved professional development for our dedicated team of educators; and build an inclusive and responsive education system that is reflective of our diverse and vibrant student population.

During my tenure, we were guided by our goal to close the opportunity gap in all districts across the state, most recently with the development and implementation of the \$1.6 billion Every Student Succeeds State plan in January 2018. This vital and comprehensive set of reforms helped to boost educational equity and put in place a new, more dynamic school improvement process that requires staff, parent and student involvement. New York was also the first state to accept the landmark My Brother's Keeper initiative into law, in an effort to ensure all boys and young men of color in school are on a track for success.

In line with this agenda, we took targeted steps to help address the individual needs of unique and vulnerable student populations, from children with learning difficulties to students experiencing homelessness to English Language Learners and immigrant communities. By promoting a culturally-responsive and well-rounded education with additional support systems, we made academic and social-emotional development for every child a top priority.

We also identified the State's most challenging schools and districts—its urban centers—and developed case by case solutions. In Rochester, for example, we deployed a Distinguished Educator to assess why the district had been failing students for years and used that report as a basis for the development of the District's plan to support students to success. Similarly, in New York City, we established a comprehensive Corrective Action Plan that set forth system-wide reforms specifically targeted at improving services for students with disabilities, English Language Learners and their families.

NYSED championed efforts to improve educational opportunities outside of the traditional classroom setting by working closely with colleagues in the State Departments of Health, Children Services, Mental Health, Juvenile Justice, and Alcoholism and Substance Abuse. We also partnered with higher education institutions, with a focus on strengthening access to colleges and universities for all students and preparing them for life after high school. Our approach centered on addressing teacher shortages, strengthening student teaching requirements, and creating a pilot principal preparation program.

As a former teacher, administrator, and superintendent, I have devoted my entire 45-year career to putting children on a path to success both in school and beyond, and I am enormously grateful for the opportunity to lead the school system here in New York State. Going forward, I hope to translate the experiences I've gained from one of the largest, most complex education systems in the country into lessons to help improve classrooms, schools, and districts for students in every state.
