The Higher Education Committee held its scheduled meeting on July 15, 2024. Chancellor Lester W. Young, Jr. chaired the meeting. All members were present except Regent Catherine Collins, Regent Wade S. Norwood, and Regent James E. Cottrell, who were excused. Regent Roger Tilles, Regent Adrian I. Hale, Regent Hasoni L. Pratts, Regent Patrick A. Mannion and Regent Seema Rivera also attended the meeting but did not vote on any action.

ACTION ITEMS

Proposed Amendment of Section 80-5.27 of the Regulations of the Commissioner of Education Relating to Extending the Validity Period of Emergency COVID-19 Certificates [HE (A) 1] - Department staff presented a proposed regulatory amendment for adoption as an emergency rule to extend the validity period of COVID-19 certificates that expire on August 31, 2024 or January 31, 2025 by changing the expiration date of such certificates to August 31, 2025.

The Committee recommends that section 80-5.27 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2024, as an emergency rule upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare, in order to immediately extend the expiration date of Emergency COVID-19 certificates that are set to expire during the 2024-25 school year to August 31, 2025 and address on-going staffing challenges due in part to disruptions from the COVID-19 crisis.

The motion passed unanimously.

Proposed Amendment of Section 80-5.3 of the Regulations of the Commissioner of Education Relating to Extending Flexibility for Incidental Teaching [HE (A) 2] - Department staff presented a proposed regulatory amendment for adoption as an

emergency rule to extend the flexibility for incidental teaching where certified teachers can teach up to 10 classroom hours a week in a subject area not covered by their certificate through the 2024-25 school year.

The Committee recommends that section 80-5.3 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2024, as an emergency rule upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to continue allowing certified teachers to teach up to 10 classroom hours a week in a subject area not covered by their certificate for the 2024-2025 school year.

The motion passed unanimously.

ACTION ITEM

Proposed Amendment to Section 200.5 of the Regulations of the Commissioner of Education Relating to Special Education Due Process System Procedures [P12 (A) 1] - Department staff presented a proposed amendment for emergency action to clarify that parents of students who are parentally placed in nonpublic schools do not have the right under Education Law § 3602-c to file a due process complaint regarding the payment of services; when such services were recommended by the district on an Individualized Education Services Plan (IESP) and were obtained by the parents of a student with a disability.

The Committee recommends that the Board of Regents finds that section 200.5 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2024, as an emergency rule upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to provide predictability for the upcoming 2024-2025 school year regarding the kind of disputes that fall outside the scope of the (State) entitlement to an impartial due process hearing.

ACTION ITEMS

Proposed Amendment of Section 100.2 of the Regulations of the Commissioner of Education Relating to Completion of the Free Application for Federal Student Aid (FAFSA) by Seniors Enrolled in School Districts [HE/P-12 (A) 1] - Department staff presented a proposed regulatory amendment for adoption as an emergency rule to require school districts to: ensure that parents or guardians of high school seniors (or students if they are 18 years old or older or legally emancipated) complete the FAFSA, DREAM Act application, or waiver indicating that they have chosen not to file an application; notify each high school senior at least twice in a school year of the state-sponsored scholarships, financial aid, and assistance available for college or post-secondary education; and annually report to the Department certain data for all seniors in the district.

The Committee recommends that section 100.2 of the Regulations of the Commissioner of Education be amended, as submitted, effective August 15, 2024, as an emergency rule upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare to conform the Commissioner's regulations to Part C of Chapter 56 of the Laws of 2024, which takes effect August 15, 2024.

The motion passed unanimously.

Proposed Amendment of Sections 80-2.9, 80-4.3, and 80-5.18 of the Regulations of the Commissioner of Education Relating to Flexibilities for the Supplementary Certificate and Supplementary Bilingual Education Extension Requirements in

Response to the Influx of Recently Arrived and Asylum-Seeking Students [HE (A) 2] - Department staff presented a proposed regulatory amendment for adoption as an emergency rule to extend the flexibilities for the Supplementary certificate and Supplementary Bilingual Education extension requirements for certain educators who apply for this type of certificate and extension from August 31, 2024 to August 31, 2025.

The Committee recommends that sections 80-2.9, 80-4.3, and 80-5.18 of the Regulations of the Commissioner of Education be amended, as submitted, effective July 16, 2024, as an emergency rule upon a finding by the Board of Regents that such action is necessary for the preservation of the general welfare, in order to immediately continue flexibilities related to the requirements for the Supplementary certificate and Supplementary Bilingual Education extension to address staffing challenges due to the influx of recently arrived and asylum-seeking students.

The motion passed unanimously.

PROFESSIONAL PRACTICE

The Professional Practice Committee held its scheduled meeting on July 15, 2024. All members were present except for Regent Wade S. Norwood, Regent James E. Cottrell, and Regent Catherine Collins, who were excused. Chancellor Lester W. Young, Jr. was also present and voted as an ex-officio member. Vice Chancellor Judith Chin, Regent Roger Tilles, Regent Shino Tanikawa, Regent Hasoni L. Pratts, Regent, Patrick A. Mannion, and Regent Seema Rivera also attended the meeting, but did not vote on any action.

ACTION ITEMS

Professional Discipline Cases [PPC EXS (A) 2 & 3]

The Committee recommends, upon the recommendation of the Committee on the Professions, that 31 consent order applications and 17 surrender applications be granted.

These recommendations are made following the review of 48 cases involving ten registered professional nurses, ten licensed practical nurses, six certified public accountants, three licensed master clinical social workers, two chiropractors, two licensed practical nurses who are also registered professional nurses, two pharmacists, one dentist, one licensed clinical social worker, one licensed mental health counselor, one massage therapist, one ophthalmic dispenser, one pharmacy, one professional engineer, one registered professional nurse who is also certified as a nurse practitioner in Adult Health and who is also certified as a nurse practitioner in Psychiatry, and one veterinarian.
