




- Signed into law July 2014
- 6 Core Programs:
 - Title I Adult, Dislocated Worker, and Youth Programs Department of Labor
 - Title II Adult Education and Family Literacy Act Education Department
 - Title III Wagner-Peyser Act Employment Service Programs Department of Labor
 - Title IV Vocational Rehabilitation
 - General ACCES-VR Education Department
 - Blind NYS Office of Children and Family Services, Commission for the Blind
- First Combined State Plan submitted April 2016 effective July 2016

SYSTEM FOUNDATION IN NEW YORK STATE


- 33 Local Workforce Development Areas
- Each area must have a minimum of one comprehensive center
 - Key requirement of a comprehensive center must have real-time access to each core partner
- Areas may include affiliate and specialized centers
 - NYS has over 100 such centers
- Each Core Program partner location is a part of the workforce system network
