ACCES-VR Mission

ACCES-VR assists individuals with disabilities to achieve and maintain employment and to support independent living through training, education, rehabilitation and career development.

ACCES-VR Overview

- Twenty- five District Offices across the state
- 651 staff including over 300 Vocational Rehabilitation Counselors (VRCs)
- Approximately 93,000 participants
- Disabilities: physical disabilities, learning disabilities, mental health, developmental disabilities, deaf/hard of hearing, substance abuse and autism (not blind/visually impaired)
- 55% of caseloads consist of youth

- Services are primarily provided by contracted vendors (over 600 contracts)
- Job Placement
- Supported Employment
- Psychological Assessments
- College Supports
- Non Degree Technical Training
- Vehicle Modification
- Home Modification
- Independent Living Centers

- Every state has a State Rehabilitation Council (SRC)
- Established as part of the federal Rehabilitation Act of 1973
- Purpose of the SRC is to advise the Board of Regents and State Education Department on issues related to the delivery of vocational rehabilitation services to New Yorkers with disabilities.
