

Petition of Abraham Kipp and Moses Cantyne to operate a ferry across the Hudson River, July 1, 1752



Ots Boat to Garry Fravellers and Their Howes Cattle and Goods to and from the West and Eastfides of the said River acrofs the same River but withe great Inconvenience and Disadvantage to Thomsdow and Travellers for the want of the Priviledge of an -Established Ferry whereby they may be Enabledto maintain the fame in the bast manner. That no other Person but your Petilioners have been Ufed any Ferry crops the said River within about Jen Miles either north or fouth from your Petitioner's said Landings. That there is no Established Ferry crofs Hudson's Priverlo the northward neaver to the said andings than at the City of albany which is about Picty miles distant from your said Petitioner's tondings nor any Established Ferry to the South ward over the said River near or than newborough which is about forty miles die tant from your Pelitioner's Landings

Served as colonial governor of New York from 1755 to 1757.






Message of Governor Hardy to the General Assembly, with a petition of the inhabitants of Goshen, Orange County, setting forth their defenseless condition. January 13, 1756




