

- Third state library in the country
- Copies of federal law, interstate exchange of statutes
- Natural History of New York
- Exchanges with European libraries




Library Origins and Themes

- Reports and laws from new territories/states
- Documents Relative to the Colonial History of the State of New York
- At first, no formalized system for cataloging, storing, and providing access to items
- Unprecedented collection growth
- Unprecedented collection use
- "Library of Congress" for New York State



Goals and Work

- Collecting and organizing resources and creating access points for New Yorkers to connect with them. These resources:
- Support State employees working to innovate New York's services and infrastructure
- Inform all New Yorkers to be active participants in their community and government

Over 20 million items, with strengths in:



Reference

- Unlike many research libraries, the New York State Library is open to the public
- Reference and MSC librarians on the 7th and 11th floors accept questions via phone, email, US mail, and in person
- Researchers are often referred to us from other state agencies, the courts, and librarians in public or academic libraries
- Patrons often report that no one else was able to find this information for them



- Largest collection of published NYS documents in the world
- Regional Federal Depository Library
- Preservation Steward for the U.S. Government Publishing Office (the largest publisher in the world) with pledge to keep select print collections of historical and current government publications produced by the GPO
- U.S. Patent and Trademark Resource Center since 1871
- Thousands of industry standards and specifications, or rules for making products and services compatible, safe, replaceable, and connectable

Draft Farewell Address rescued from the Capitol Fire of 1911


Damaged dress sword retrieved from the rubble and repaired
