Revising the 180-Day Requirement

- Education Law §1704(2) & §3604: School districts must provide 180 days of instruction.
- Commissioner's Regulations §175.5: An instructional day must have at least the following number of "actual instructional or supervised study" hours:
 - Half-day kindergarten: 2.5 hours
 - Full-day kindergarten-Grade 6: 5.0 hours
 - Grades 7-12: 5.5 hours

- The New York State Education Department (NYSED) has never included lunch or recess in the hours counted toward "actual instructional or supervised study."
- Sessions may not be held on legal holidays or Saturdays.
- Sessions may only be held between September 1 and rating day in June.

- Superintendent's Conferences:
 - Districts may hold up to four session days per year that count toward the 180-day requirement.
 - Up to two conference days may be held during the last two weeks of August.
 - May be broken up into smaller segments, such as a half day; the total of the segments still counts as one session day.

- "Shortened Sessions" for additional staff development and parent-teacher conferences:
 - In a week where the total instructional hours are met in fewer than five days (e.g., 4 days of 6 hours and one half day of 3.5 hours), the remainder of the half day may be used for either purpose and the day still counts.
 - Maximum of four times per semester.
 - May not be used if they would push weekly hours below the minimum requirement.

Extraordinary Conditions:

- Up to five days may be forgiven by the Commissioner, but only if the district has fully exhausted its remaining vacation days.
- By law, emergency declarations by the governor or municipal executives do <u>not</u> alone forgive districts for not holding session on those days.

Aid Loss:

 For each day below the 180-day requirement, a district loses 1/180th of its Foundation Aid allocation the following year.

Committee Feedback

The following key issues were highlighted by school districts and stakeholders through the Advisory Committee process:

- Flexibility
- Clarity
- Snow Days/Emergencies
- Collective Bargaining Agreements (CBAs)
- Recess

- Replace the Daily Minimum Hours requirement with an Annual Aggregate Minimum Hours requirement of the same length.
 - 2.5 Hours X 180 = 450 hours for half-day kindergarten
 - o 5 hours X 180 = 900 hours for grades K-6
 - 5.5 hours X 180 = 990 hours for grades 7-12
- Aggregate annual hours must still be provided over 180 school days.

- Flexibility for non-instructional hours: By eliminating the Daily Minimum Hours requirement, districts will gain greater flexibility in scheduling non-instructional time, such as lunch, recess, and parent-teacher conferences.
- Opportunity for extra instructional time to count: Districts that are currently above the Daily Minimum Hours requirement will now have those extra hours count.

- Superintendent's Conferences: Consistent with current law, up to four days worth of conference hours may be used as full or partial days toward the minimum aggregate annual requirement.
- "Shortened Session" staff development/
 parent-teacher conferences: Hour flexibility
 removes restrictions on when these hours, which
 do <u>not</u> count toward the minimum, may be used
 (such as before a holiday).

Snow Days/Other Emergencies: NYSED will
propose legislation to provide relief from the
requirement on days where schools must be closed
for reasons that are outside the district's control,
such as a state of emergency declared by the
governor.

As an interim solution, the proposed regulation suggests, but does not require, districts plan for the average number of closures from snow days the districts called over the previous five years.

 Regents Exams and Rating Day: As the Regents examination schedule is reduced in the coming years as examination phase-ins/phase-outs are complete, NYSED is exploring whether it can compress the calendar and free up current exam days for instructional time.

This will also allow for exploration into shifting Rating Day to a later point in June.

 Collective Bargaining Agreements: If any district has provisions in its CBAs that conflict with the new regulation, the district will have to, upon expiration of those CBAs, revisit its contracts consistent with the Taylor Law.

Noncompliance

 As is currently the case, noncompliance with the new provisions could result in an aid penalty.

Other Department Actions

- Guidance: Upon adoption, NYSED will issue new guidance to reflect the amended regulations.
- Model Calendars: Staff will work with stakeholders to develop model calendars that districts can use for their planning purposes.
- Legislation: The Department will draft legislation to offer, at local discretion, instructional days in August and to provide an exemption from the 180-day requirement when there is a declaration of an emergency at the state or local level.
