


Fiscal Context

State Education Department State Operations Revenue Sources (2025-26 appropriation total \$705.3M)




Local Assistance Revenue Sources By Appropriation (2025-2026 - \$47.5B)

Potential Fiscal Challenges Ahead


- Enacted State Budget gives Budget Director withhold authority on local assistance fund, if projected deficits reach \$2 billion and the legislature does not act within a certain timeframe
- Outyear gaps projected at \$7.4 billion in FY26, \$13.4 billion by FY28



Funding Schools Remains a Major Priority

- Foundation Aid fully phased in and base maintained
- Total school aid increased \$1.74 billion (4.9%) to \$37.4 billion
- School aid represents 27.9% of the total state general fund budget

Foundation Aid has Four Parts – Current Law

*



Foundation Amount: based on an analysis of the cost of educating general education pupils in successful schools, updated for inflation Pupil Needs: additional weights for certain student needs

Needs

- Free and Reduced-Price Lunch
- English language learners
- 2000 Census poverty
- Students in rural communities



Regional Cost

- An adjustment of regional cost by Labor Force Region.
- Spelled out in statute, based on 2006 analysis.

Local Contribution

Local Contribution

 Primarily a sharing ratio to split the cost between local and state responsibility

Foundation Aid Formula Adjustments

Executive Changes Adopted

- Update 2000 Census Poverty
- Replace free- and reducedprice meal counts
- Enhancements to the state sharing ratio
- Minimum increase for all districts of at least 2%

New Enacted Budget Changes

- Enhances ELL weight from 0.50 to 0.53
- Westchester County Regional Cost Index
- Enhancements to the state sharing ratio

School Aid Recommendations Not Included

- FAPE 22 no changes to state law around aid eligibility for students with disabilities who turn 21 without a diploma
- Growth aid no new aid for districts with significant enrollment growth
- Foundation Aid Formula no wholesale update to the regional cost index or the income wealth index minimum
- Prior Year Adjustment (PYA) List appropriation no funding for this list of valid claims, requested in prior years

Other School Aid Formula Changes

Career and Technical Education Enhancements

- Special Services Aid
 - 9th Graders included in
 - Per pupil increase from \$3,900 to \$4,100
- BOCES Aid
 - \$10,000 BOCES salary cap increase from \$30,000 to \$60,000 beginning in aid year 2026-27

Other Formula Based Aids

- Charter Transitional Aid
 - Persistent support for districts where more than 20% of students attend charter schools, excluding the Big 5 City districts

Board and Department Priorities

Regents Priorities Highlights – Enacted

- Dual enrollment policy creation
- NYSESLAT / Translation: An additional \$4 million
 - Continue the work creating a test that meets federal requirements
 - Translate grades 3-8 math exams, science tests, and five Regents exams into eight languages.
- Investments in Career and Technical Education- BOCES salary aid cap and Special Services Aid
- Monitors:
 - Two-year extensions for monitor authorization at four districts
 - No changes to duties or powers; funding maintained
 - New two-year monitor authorization, for Mount Vernon
 - Mount Vernon received a general aid advance

Other Funded Initiatives

- Funding was provided for two staff to support work on dyslexia and dysgraphia
- The budget included the \$500,000 proposed by the Executive for educational materials and resources focused on Indigenous cultures and history
- Funding was provided for two staff for OCUE's teacher program review work

Policy Matters in the Enacted Budget

Education Policy Changes (1 of 3)

New Dual Enrollment Policy

- SED must create a statewide policy:
 - defines dual enrollment programs
 - Provides guidelines for participation
 - Collect partnership agreements September 1, 2026
- SED to partner with SUNY and CUNY to establish data to collect
- SED to annual publish data about participation and outcomes

Zero Emission Bus Changes

- Allows two 24-month extensions to requirement
- Provides specificity around notification and NYSERDA involvement
- SED must publish waiver applications by December 31, 2025
- Sales after January 1, 2026 must include an independent range estimate or face a civil penalty

Education Policy Changes (2 of 3)

Universal Free School Meals

- Schools must adopt CEP if eligible
- State reimburses difference between paid meal and free meal for all students
- Additional \$160 million in state funds appropriated

Digitizing Working Papers for Minors

- The Department of Labor (DOL), in consultation with SED, must create and maintain a database for the employment of minors.
- Minors must register for any employment certificate or permit.
- Employers hiring individuals under the age of 18 must register in the database.
- Working papers would be available electronically
- All information would be confidential

Education Policy Changes (3 of 3)

Substantial Equivalence Changes

- Delay enforcement until 2032–33 school year
- Adds an assessment pathway that allows schools to use assessments that are not Department approved or aligned with NYS Learning Standards
- Defines "proficiency" as the 33rd percentile on a nationally norm-referenced test without local district oversight or planning requirements
- Allow nonpublic schools to change pathways at any time
- Limits local school authority review nonpublic schools to provide assurances of unclear pathway election or parental complaints

Bell-to-Bell Cell Phone Ban

- Each District, Charter School, and BOCES must consult with stakeholders to create a written policy by August 1, 2025 that:
 - Prohibits student use of personal internet-enabled devices during the school day.
 - Includes methods for parents/guardians to contact students during the school day and on-site device storage.
 - May include certain listed exceptions or exceptions on case-by-case basis for caregivers.
- Schools may not suspend students only on the grounds of violation of the policy.
- Schools must publish an enforcement report annually and mitigate significant demographic disparities, if any.
- \$13.5 million appropriation for distraction free schools implementation
