### **STANDING COMMITTEE REPORTS**

### P-12 Education

Your P-12 Education Committee held its scheduled meeting on June 20, 2011. All members were present except for Regent Norwood, who was excused.

### **ACTION ITEMS**

### Establishment of Graduation Rate Goal and Progress Targets for 2011-12 School and Local Educational Agency Accountability

Your Committee recommends that the Board of Regents approve the proposed graduation rate goal of 80 percent and that new gap reduction progress targets be established at 10 percent for the four-year graduation rate cohort and 20 percent for the five-year extended graduation rate cohort. Your Committee further recommends that the Board of Regents direct staff to seek approval from the United States Department of Education to amend New York's No Child Left Behind Accountability Workbook to use this goal and these progress targets for 2011-12 school and district accountability. [P-12 (A) 1]

### Credit for Online and Blended Coursework

Your Committee recommends that paragraph (10) of subdivision (d) of section 100.5 of the Regulations of the Commissioner of Education be added, as submitted, effective July 15, 2011 to prescribe requirements for earning credit for online or a combination of online and classroom-based coursework. Staff will come back to the Regents with additional information on how these new regulations tie in with credit recovery. [P-12 (A) 5]

### **Charter School Actions**

Your Committee recommends that the Board of Regents approves and issues the second renewal charter of the Beginning with Children Charter School as proposed by the Chancellor of the City School District of the City of New York, and that its provisional charter be extended for a term up through and including June 30, 2016; the third renewal charter of the Brooklyn Charter School as proposed by the Chancellor of the City School District of the City of New York, and that its provisional charter be extended for a term up through and including June 30, 2016; the second renewal charter of the Explore Charter School as proposed by the Chancellor of the City School District of the City of New York, and that its provisional charter be extended for a term up through and including June 12, 2016; and the fourth renewal charter of the John V. Lindsay Wildcat Academy Charter School as proposed by the Chancellor of the City School District of the City of New York, and that its provisional charter be extended for a term up through and including June 30, 2016. Your Committee recommends that the Board of Regents approves and issues the first renewal charter of the Achievement Academy Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2010; the second renewal charter of the Achievement Academy Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter of the Albany Community Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up

through and including July 31, 2011; the second renewal charter of the Albany Community Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2016; the first renewal charter of the Albany Preparatory Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2010; the second renewal charter of the Albany Preparatory Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2013; the first renewal charter of the Henry Johnson Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2012; and the first renewal charter of the KIPP Tech Valley Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2015. Your Committee recommends that the Board of Regents approves and issues the first renewal charter of the Kings Collegiate Charter School as proposed by the Board of Trustees of the State University of New York, and that its provisional charter be extended for a term up through and including July 31, 2012. Your Committee recommends that the Board of Regents approves the following charter revisions as proposed by the Trustees of the State University of New York and the provisional charters are amended accordingly: Achievement First Brownsville Charter School, Harbor Science and Arts Charter School, and Our World Neighborhood Charter School II. ### MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your P-12 Education Committee recommends, and I move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on June 21, 2011, copies of which have been distributed to each Regent.

### MATTERS NOT REQUIRING BOARD ACTION

Guidelines and Resources for Social and Emotional Development and Learning – The Committee discussed the draft guidelines which were developed through extensive collaboration with the Department's Office of Student Support Services along with educators from around the State. The guidelines provide school communities with a rationale and the confidence to address child and adolescent affective development as well as cognitive development. Final guidelines will be brought back to the Regents in July for approval. [P-12 (D) 1]

<u>Charter School Office Strategic Planning Summary</u> – Staff presented an update on the progress of the Charter School Office strategic planning process and the grant from the National Association of Charter School Authorizers. [P-12 (D) 2]

<u>Proposed Alternate Credential to Replace the Individualized Education Program Diploma</u> – This item was not discussed due to time constraints and will be presented to the Regents at a future meeting. [P-12 (D) 3]

<u>Dignity for All Students Act Program Update</u> – The Committee was given an update on the Dignity for All Students Act which will begin implementation on July 1, 2012. A Dignity for All Students Task Force has been established and has been involved with Department staff on the development of proposed amendments to regulations to be presented to the Regents at a future meeting. At the direction of the Regents, staff will work collaboratively with the Dignity for All Students Act Task Force and other stakeholders to continue work to implement the provisions of the Dignity Act. [P-12 (D) 4]

Results for Students with Disabilities and Strategies to Improve Performance – The Committee discussed data results for students with disabilities including information on classification rate, least restrictive environment, performance on State assessments and Regents examinations, and exiting data. The Committee also discussed strategies to improve performance results for students with disabilities. Strategies include a more focused monitoring review process for the 2011-12 school year with priority on quality IEP development; timeliness of individual evaluations and provision of special education services; transition planning; and the provision of IEP recommended special education program and services for students with disabilities. The Committee also discussed the Department's plan to address key instructional and related issues that lead to poor results for students with disabilities.

Panel members provided a brief summary about their individual programs and had a conversation with the Regents on such topics as how to address over-representation; classification/declassification; and reforming the certification structure for teachers. The Committee also discussed the challenges of assessing the extent of a student's disability – how to separate the levels and complexities of varying degrees of disabilities. Panel Members included:

- Julie Ludwig, Special Education School Improvement Specialist from the Central Region Special Education Technical Assistance Support Center;
- Linda Brown, Behavior Specialist from the Mid-State Special Education Technical Assistance Support Center; and
- Job Thomas, S<sup>3</sup>TAIR Statewide Facilitation Coordinator.

<u>Update on the Roosevelt UFSD and State Oversight Authority</u> – The Committee was provided with an update on the intervention strategies taking place at the Roosevelt

UFSD. Staff provided updated information on the Board of Education and budget vote, high school construction plans and accountability status. [P-12 (D) 6]

<u>Consent Agenda Items</u> – Staff presented the following item scheduled for approval on the full Board consent agenda:

Proposed amendments to regulations to amend paragraph (14) of subdivision (p) of section 100.2 of the Regulations of the Commissioner of Education relating to public school and district accountability.

### Joint P-12 Education/Adult Career and Continuing Education Services (ACCES)

Your P-12 Education Committee and ACCES Committee held a joint meeting on June 20, 2011. All members were present except for Regent Norwood, who was excused.

### MATTERS NOT REQUIRING BOARD ACTION

Transition Planning and Services for Students with Disabilities – The Committees discussed the roles of the P-12 Office of Special Education and the ACCES Vocational Rehabilitation Office for transition planning and services for students with disabilities. Transition planning and services are required by federal and State law and are designed to ensure that students with disabilities are prepared for post-school living, learning and earning. Staff presented an example of a student IEP and discussed possible obstacles that student may face in a high-need or large city school district, such as lack of resources and limited access to programs. School districts are responsible for providing transition planning and services beginning no later than the school year in which the student turns 15 and until the student graduates with a regular diploma or ages out at 21. Two years prior to expected school exit, a Vocational Rehabilitation Counselor meets with school personnel to identify potential individuals for referral to VR services and/or independent living. Staff will revisit this issue in the upcoming months and present the Regents with updated information in the fall.

### **Higher Education**

Your Higher Education Committee held its scheduled meeting on June 20, 2011. All members were present.

### **ACTION ITEMS:**

New York Career Institute – Renewal of Institutional Accreditation. Your Committee discussed and approved the renewal of institutional accreditation of New York Career Institute without conditions for a period of five years ending on June 30, 2016, with the stipulation that all recommendations in the report be met by May 20, 2013.

Memorial School of Nursing – Institutional Accreditation. Your Committee discussed and approved the accreditation with conditions of Memorial School of Nursing for a period of three years ending June 30, 2014, with the condition that all recommendations made by the peer review team are met by May 27, 2012. The School would be required to provide a progress report, due May 27, 2012, on the actions taken to address the peer review team's recommendations.

Samaritan Hospital School of Nursing – Institutional Accreditation. Your Committee discussed and approved the accreditation with conditions of Samaritan Hospital School of Nursing for a period of three years ending June 30, 2014, with the condition that all recommendations made by the peer review team are met by May 27, 2012. The School would be required to provide a progress report, due May 27, 2012, on the actions taken to address the peer review team's recommendations.

CUNY New Community College. Your Committee discussed and approved an amendment to the master plan of The City University of New York authorizing the establishment of the CUNY New Community College, New York, and its proposed A.A., A.S. and A.A.S. programs in the disciplinary areas of business, the health professions, the humanities, the physical sciences, engineering, and the social sciences. This amendment will be effective until June 30, 2012, unless the Department registers the programs prior to that date, in which case master plan amendment shall be without term.

Fei Tian College. Your committee approved a master plan amendment to authorize Fei Tian College, Cuddebackville, to offer B.F.A. and Mus.B. programs, respectively, in Classical Chinese Dance and Music (Performance) as its first baccalaureate programs in the disciplinary area of fine arts. The amendment will be effective until June 30, 2012, unless the programs are registered prior to that date, in which case master plan amendment shall be without term.

Individual Evaluation Pathway to Teacher Certification Regulation. Your Committee discussed and approved an amendment to Section 80-3.7 of the Regulations of the Commissioner of Education relating to certification in the classroom teaching service through individual evaluation. This amendment extends the individual evaluation pathway to September 1, 2013

### Discussion Items: Items not requiring Board action

Mentoring Standards - Your Committee endorsed the proposed New York State Mentoring Standards.

Economic Eligibility Guidelines for Opportunity Programs - Your Committee discussed an amendment to Section 27-1.1 of the Rules of the Board of Regents relating to student eligibility for the Higher Education Opportunity Program. This item will be submitted for action at the September 2011 meeting.

Early College High School (Smart Scholars) - Your Committee heard a presentation on the strategies Smart Scholars Early College High Schools (SS ECHS) are using to ensure the quality of instruction in college level courses provided to ECHS students. A representatives from one of the SS ECHS partnerships, Yonkers Public Schools and Westchester Community College, shared the successful collaboration in planning and implementing a College Prep Skills course for the 9th grade Smart Scholars; and Cass Conrad, the executive director of School Support and Development at CUNY provided a brief overview of the structure and success of the Early College Initiative (ECI) at CUNY, which has an eight year history of developing early college high schools.

### MOTION FOR ACTION BY FULL BOARD

Madam Chancellor and Colleagues: Your Higher Education Committee recommends, and we move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's deliberations at its meeting on June 21, 2011, copies of which have been distributed to each Regents.

### Joint Audit/Budget and Finance/State Aid

The Regents Committee on Audits/Budget and Finance and the Subcommittee on State Aid met as scheduled on June 20, 2011. Chancellor Tisch, Vice Chancellor Cofield, Chancellor Emeritus Bennett, Vice Chair Bendit, and Regents Tilles, Dawson, Cashin, Rosa, Young, Jackson, Bottar, Cottrell, Phillips, and Cea were in attendance.

### Items for Discussion

### Financial Condition of School District

The Members were briefed on the process used by the Office of Audit Services to assess the fiscal condition of school districts. Specifically, we were briefed on the results of the 2009-2010 school year.

### School District Fund balance

Staff described the effect of the changes in accounting standards as it relates to reserves and fund balance. We were also briefed on findings from the recent Property Tax Report Cards which were developed by school districts this past May and includes information on spending, tax levies, and fund balances.

### **Insolvent School Districts**

Staff also described the facts and processes used when school districts experience severe financial stress. We were told of actions that the Department and the Office of the State Comptroller can utilize in addressing these types of concerns.

### Mandate Relief

We were updated on mandate relief activities in the legislature based on Department initiatives.

### Item for Discussion

Two proposed amendments to the Regulations of the Commissioner (136.3 Hyperopia screening and 80-4.3 Teacher Certification Flexibility) were discussed and will be presented for adoption at the September Regents meeting.

### **Emergency Action**

The Committee approved the emergency amendments to the Regulations of the Commissioner for section 155.6 related to School facility report cards and 156.3 regarding School transportation (driver training and school vehicle idling reports).

A motion to approve the proposed changes was made by Chancellor Emeritus Bennett, second by Regent Young, and passed without opposition.

### May 2011 Fiscal Report

Your Committee reviewed the fiscal report. Our Chief Operating Officer briefed the Committee Members on the status of efforts to improve the fiscal health of some accounts including Teacher Tenure Hearings, Cultural Ed, GED, and Assessment.

### **Professional Practice**

Your Professional Practice Committee held its scheduled meeting on June 21, 2011. All Committee members were present, except Vice Chancellor Milton L. Cofield, and Regent Wade S. Norwood who were excused.

### **ACTION ITEMS**

### **Professional Discipline Cases**

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 7 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 43 consent order applications and 11 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Steven Michael Veroxie, Physical Therapist Assistant, Calendar No. 24707, we recommend that wherever the phrase "physical therapy assistant" is used in the application for consent order in this matter, such phrase be deemed corrected and be deemed to read "physical therapist assistant"; wherever the word "licensed" is used in the application for consent order in this matter, such word be deemed corrected and be deemed to read "certified"; and wherever the word "license" is

used in the application for consent order in this matter, such word be deemed corrected and be deemed to read "certificate."

These recommendations are made following the review of 61 cases involving eleven licensed practical nurses, ten dentists, ten registered professional nurses, five licensed practical nurses who are also registered professional nurses, five pharmacists, four pharmacies, two dental hygienists, two professional engineers, one certified public accountant, one licensed master social worker, one massage therapist, one physical therapist assistant, one podiatrist, one speech-language pathologist, and one veterinary technician.

### **Restoration Cases**

Your Committee recommends:

That, after he has presented proof to the Office of Professional Medical Conduct, New York State Department of Health, that he has fulfilled the requirements of Education Law §6524 so as to continue to qualify for licensure and registration under that statute, the execution of the Order of Surrender of the license of Samir Boutros to practice as a physician in New York State be stayed; that he then be placed on probation for two years under the terms and conditions set forth in Exhibit A of the Report of the Committee on the Professions, and that, upon successful completion of the probationary period, his limited license shall be fully restored consistent with the provisions of Education Law §6524. ### **Cultural Education**

### REGENTS COMMITTEE ON CULTURAL EDUCATION

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report.

Your Committee on Cultural Education Committee had its scheduled meeting on June 21, 2011.

In attendance were committee members: Regents Tilles, Dawson, Rosa and Bendit

In addition to CE Committee Members, in attendance were: Chancellor Tisch and Regent Cashin and Commissioner King.

### ITEMS FOR DISCUSSION

Chair's Remarks: Regent Tilles welcomed everyone and opened the meeting. Regent Tilles remarked that he would like to explore options for Board of Regents Action to have all school libraries be fully functional and appropriately staffed. Current regulations require that all schools have a library and high schools must have a certified library media specialist on staff. Chancellor Tisch remarked that many schools are out of compliance with these regulations. Commissioner King suggested that the State Aid committee should discuss methods for providing resources to districts to help them

be in compliance at a greater rate. It was agreed that an item for discussion should come before the Committee at its next regular meeting.

Chancellor Tisch raised the suggestion that the Board of Regents should hold a summit regarding Arts Education. The summit should have a statewide focus. The Chancellor commented that there is a crisis in arts education in New York State and that there is an urgent need for action. The summit should include public broadcasters, libraries and all cultural institutions chartered by the Board of Regents. Regent Tilles suggested that the recent arts summit on Long Island could serve as a template for the summit. It was agreed that an item proposing a summit should come before the committee at its next regular meeting.

### CE (D) 1 – Talking Book and Braille Library (TBBL) Update

Loretta Ebert, Director of the Resource Library provided background information in her brief report regarding TBBL and the progress of implementing new digital technologies and business processes. Sharon Phillips, the director of the Talking Book and Braille Library demonstrated the new digital book reader that is distributed by TBBL and discussed the book service called Braille and Audio Reading Download (BARD) that is offered by NLS (National Library Service for the Blind and Physically Handicapped) and is available to all TBBL patrons. Commissioner King requested that Deputy Commissioner Cannel organize a meeting of appropriate staff from P-12 and ACCES to ensure that counselors and other program staff are fully aware of the services and resources available from TBBL.

CE (D) 2 – The State Museum's World Trade Center Exhibitions: Ten Years After Clifford Siegfried, Assistant Commissioner and Director of the NYS Museum introduced Mark Schaming, Director of Exhibitions at the Museum who provided a detailed report on the World Trade Center and 9/11 collections and exhibits of the Museum and the plans to provide traveling exhibitions of the World Trade Center and 9/11 materials statewide. In observance of the tenth anniversary of the World Trade Center (WTC) attack, the Museum has produced three new traveling exhibitions that will bring this important story to locations across the state and nation. A schedule and brief summary for each of the three exhibitions are as follows:

- September 11: A Global Moment opens on September 11, 2011 the largest and most comprehensive exhibition about 9/11 – traveling to three museums across the United States though 2011-2012.
- Recovery: The World Trade Center Operation documents the recovery operations at the Fresh Kills landfill from September 2001 to July 2002 and its purpose. The exhibition travels to the Staten Island Museum and other locations through 2012.
- September 11, 2001: A Timeline is a panel exhibit designed for historical societies, libraries, and community centers that can accommodate smaller exhibitions with low security. The timeline is a summary of world events associated with the terrorist attacks on 9/11/01 and will travel across New York State sites and beyond through 2012.

Regent Tilles suggested that the Board of Regents meeting to be held on September 12 and 13 begin one day early with a nightime reception at the State Museum on September 11. Deputy Commissioner Cannell committed to working to organize the reception.


