The charter revisions have been approved by the SUNY Board of Trustees in their capacity as charter school authorizers under Article 56 of the Education Law.

The SUNY Board of Trustees approved the initial charter for Leadership Preparatory Charter School 4 in 2008. Subsequently the SUNY Board of Trustees approved revisions to the charter to permit the school to take the 2009-10, 2010-11 and 2011-12 school years as planning years and open for instruction in the 2012-13 school year. The SUNY Board of Trustees approved a revision request to allow the school to revise the enrollment plan for the school for the 2012-13 school year as indicated in the chart above.

True North Genesee Preparatory Charter School was approved by the SUNY Board of Trustees to begin instruction in 2011-12. The SUNY Board of Trustees proposes to change the name of the charter school as indicated in the chart above to True North Rochester Preparatory Charter School – West Campus.

#### **REASONS FOR RECOMMENDATION**

The proposed revised charters: (1) meet the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will permit the charter schools to operate in an educationally and fiscally sound manner; (3) are likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and, where applicable, granting these applications would have a significant educational benefit to the students expected to attend the charter school.

### **RECOMENDATION**

VOTED: That the Board of Regents approves the above listed charter revisions as proposed by the Trustees of the State University of New York and the provisional charters are amended accordingly.
