SUMMARY

I recommend that the Board of Regents approve revisions to the following charters authorized by the Board of Trustees of the State University of New York (SUNY). The charter revisions have been approved by the SUNY Board of Trustees, at their July 8, 2010 meeting, in their capacity as charter school authorizers under Article 56 of the Education Law.

The Resolution approved by the SUNY Board of Trustees explains the decrease in enrollment for Achievement First Brownsville Charter School as follows:

"The School, which is currently housed in public space, proposes to continue to expand but only serve students in Kindergarten through fifth grade rather than through seventh grade, at full capacity. Therefore, the school will have reduced enrollment in the existing public space for the remainder of its charter term.

Before opening, the School revised its charter to create an enrollment and growth plan where the School would begin and grow simultaneously both an elementary and middle school program. Under the revised enrollment and growth plan, the School will not begin its fifth grade until year five of the initial charter term. In year three, the School would operate a Kindergarten and grades one through three; in year four, Kindergarten through fourth grade; and in year five, Kindergarten through fifth grade. The School decided to delay its middle school to allow more time to find and retain an appropriate middle school leader."

REASONS FOR RECOMMENDATION

The proposed revised charters: (1) meet the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will permit the charter schools to operate in an educationally and fiscally sound manner; (3) are likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and, where applicable, granting these applications would have a significant educational benefit to the students expected to attend the charter school.

RECOMMENDATION

VOTED: That the Board of Regents approves the above listed charter revisions as proposed by the Trustees of the State University of New York and the provisional charters are amended accordingly.

The Regents action on the above listed charter schools is effective immediately.
