# STANDING COMMITTEE REPORTS

## P-12 Education

Your P-12 Education Committee held its scheduled meeting on October 17, 2011. All members were present.

## **ACTION ITEMS**

#### Charter School Actions

Your Committee recommends that the Board of Regents approves and issues the charter of the Canarsie Ascend Charter School as proposed by the Trustees of the State University of New York (SUNY) and issues a provisional charter to it for a term as prescribed by §2851(2)(p) of the Education Law. [P-12 (A) 1]

#### New York State's Next Generation Accountability System

On September 23<sup>rd</sup>, President Obama announced an ESEA regulatory flexibility initiative allowing states to apply for regulatory flexibility in certain areas for the 2012-13 and 2013-14 school years and, if certain conditions are met, flexibility may be extended to the 2014-15 school year. Your Committee recommends that the Board of Regents directs the Commissioner of Education and State Education Department staff to prepare the ESEA Flexibility Request for submission by mid-February 2012. Staff will come back to the Committee with monthly updates including a January 2012 discussion of the draft application. Your Committee further recommends that the Board of Regents designate the following members to lead the work of the Think Tank: Chancellor Emeritus Robert Bennett, Regent James Dawson, Regent Betty Rosa, Regent James Jackson, and Regent Harry Phillips [P-12 (A) 2]

#### Pre-Kindergarten Standards

Your Committee recommends that the Board of Regents approves and directs staff to release to the field the newly revised *Prekindergarten Foundation for the Common Core*, with rollout occurring in academic year 2011-12. [P-12 (A) 3]

#### Preliminary 2012-13 Budget Request for Assessments

Your Committee recommends that the Board of Regents adopt the 2012-13 *preliminary* budget request for \$10 million for Assessments and Regents Exams. [P-12 (A) 4]

#### Proposals to Improve Integrity of the State's Exams

As a follow-up to the September Regents meeting where staff were directed to further develop proposals to improve the integrity of the State's exams, the Committee discussed specific proposals on proctoring, scanning and scoring and recommends that the following actions be taken:

For school year 2011-12:

- Request funding of \$1.0 million in the 2012-13 State Budget to perform scanning/erasure analysis on 10% of 3-8 assessments and Regents exams post administration for multiple choice;
- Request funding of \$0.7 million in the 2012-13 State Budget to support additional inter-rater reliability analysis of open response scoring on 3-8 assessments and Regents exams;
- Request funding of \$0.2 million to plan and begin a computer based testing (CBT) pilot.
- Request funding of \$0.2 million to support additional data forensics, in consultation with the Technical Advisory Group, and in partnership with academic partners.
- Create a small working group to make recommendations for local monitoring protocol requirements;
- Request Independent Reviewer make recommendations on appropriate retention time of answer sheets and assessment booklets.

For school year 2012-13:

 Prohibit teachers from scoring their own student's exams. Districts must develop the capacity to implement alternative scoring processes, such as, external, regional, or distributed technology for the scoring of open responses on State assessments. Outreach to districts will be conducted on how this will be accomplished. [P-12 (A) 5]

## **Determination of Kindergarten Readiness**

Your Committee recommends that contingent on New York State winning an Early Learning Challenge Grant, the Board of Regents directs staff to develop a comprehensive proposal for implementing a common readiness tool for implementation in the 2014-15 school year, and create a Kindergarten Readiness Advisory Council made up of expert stakeholders from around the State to inform this process. [P-12 (D) 1]

## MATTERS NOT REQUIRING BOARD ACTION

<u>Making Up Incomplete or Failed Course Credit</u> – The Committee discussed the Making Up Incomplete or Failed Course Credit regulation adopted in April 2010 which is intended to ensure appropriate levels of rigor and quality for make-up (credit recovery) programs implemented by local schools. Since then, anecdotal evidence and staff observation of current practices suggest that in certain programs of credit recovery, students may be given credit without completion of appropriate work or without receiving adequate instruction. The Committee's discussion focused on the importance of ensuring that students are being given rigorous opportunities and that they are earning meaningful credits. To this end, the Regents direct staff to enlist the assistance of the Office of the State Comptroller in auditing the practice of awarding credit under the Making Up Incomplete or Failed Course Credit regulation. The audit would focus specifically on adherence to and documentation of the procedures required under Section 100.5(d)(8) of Commissioner's Regulations. [P-12 (D) 1]

<u>Proposed Regents State and Federal Legislative Priorities</u> – The Committee discussed proposed legislative priorities for Commissioner's Intervention in Chronically Underperforming Schools; Mandate Relief and Flexibility; BOCES as Regional Leaders; NCLB/ESEA Reauthorization; and Development, Relief and Education for Alien Minors (DREAM Act). Final legislative priorities will be presented to the Board of Regents for approval at their November meeting. [P-12 (A) 6]

# Adult Career and Continuing Education Services (ACCES)

Your ACCES Committee held its scheduled meeting on October 17, 2011. All members were present, with the exception of Regent Chapey and Regent Norwood, who were excused. Additional members of the Board attending where: Chancellor Tisch, Vice Chancellor Cofield, Regent Bendit, Regent Cashin, Regent Jackson and Regent Phillips.

## MATTERS NOT REQUIRING BOARD ACTION

The Committee was updated on recent developments on the GED® test. This year, the American Council on Education (ACE), who is the current provider of the GED® test, and Pearson, a for-profit educational services firm, announced that they were forming a new company called GED® Testing Service (GEDTS) LLC, which will develop a new, more rigorous GED® test. This new version of the GED® test would align with Common Core Standards and be computer based. The new test is scheduled to replace the current test in January of 2014. This development is a radical departure from the present testing system. Currently, the New York State Education Department (NYSED) is the sole administrator of the GED® test in New York State. We monitor all test centers, review and approve annual contracts, approve the appointments of all examiners, provide annual training to test examiners, score the exams, and provide high school equivalency diplomas to those who pass the test.

Under the new system, GEDTS will be responsible for most of the administrative duties; while the states or jurisdictions will continue to be responsible for the issuance of their own diplomas or certificates. These changes raise several challenges and concerns including computer based testing, the elimination of the test in French, test preparation, testing sites, testing surge, and cost. To address these concerns, we need to provide actions both short term and long term. For the short term, we need to ensure that we are prepared to continue to administer the current GED® test and handle an expected increase in testers before the new test is instituted in 2014. For the long term, we need to ensure that there are alternative pathways for those who may see the GED® test as their best option for a high school equivalency diploma. In order to ensure that the GED® test is accessible and available for New Yorkers beyond 2013, NYSED staff will work with GEDTS to address our issues and concerns, and make every effort to provide for as smooth a transition as possible.

## Audits/Budget and Finance

The Regents Committee on Audits/Budget and Finance met as scheduled on October 17, 2011. Vice Chair Bendit, Chancellor Tisch, Vice Chancellor Cofield, Regents Tilles, Phillips, Tallon, Young, and Jackson were in attendance.

Chair's Remarks: Regent Chapey welcomed everyone. She reiterated the role of the Committee in assisting the Board of Regents in its role in the reform efforts.

## Items for Discussion

## September 2011 Fiscal Report

Your Committee reviewed the fiscal report. Our Executive Deputy Commissioner briefed the Committee members on the status of Department accounts with deficit. Finances have been stabilized although concerns remain with assessment, teacher tenure hearing, and cultural education accounts. In addition, information on the status of potential Department workforce reduction was provided.

#### Completed Audits

The Committee was presented with 10 audits this month. The audits included two audits issued by the Office of Audit Services (OAS), six by the Office of the State Comptroller (OSC) and two issued by the Office of the New York City Comptroller. Audit staff briefed the Committee on the audit of the East Ramapo Central School District. Among the audits findings were weaknesses in the area of procurement, payroll, information technology controls, budgeting practices, and the level of fund balance. OAS will continue to monitor trends requiring the attention of the Committee.

# **Professional Practice**

Your Professional Practice Committee held its scheduled meeting on October 17, 2011. All Committee members were present except Regent James E. Cottrell, who was excused.

# **ACTION ITEMS**

## **Professional Discipline Cases**

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 5 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 64 consent order applications and 5 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Scott Burko, Pharmacist, Calendar No. 25859, we recommend that the September 13, 2011 Vote and Order in this matter and the Application To Surrender License granted in this matter each be deemed corrected solely insofar as the calendar number of "25860" shown on each of said documents shall reflect the correct calendar number in this matter and be deemed to read the correct calendar number of "25859"; and that the determination rendered on September 13, 2011 shall otherwise remain in full force and effect.

In the case of Mario J. Caruso, Jr., Pharmacist, Calendar No. 25860, we recommend that the September 13, 2011 Vote and Order in this matter and the Application To Surrender License granted in this matter each be deemed corrected solely insofar as the calendar number of "25859" shown on each of said documents shall reflect the correct calendar number in this matter and be deemed to read the correct calendar number of "25860"; and that the determination rendered on September 13, 2011 shall otherwise remain in full force and effect.

In the case of Jillian Rose Kelly, Licensed Practical Nurse, Calendar No. 25964, we recommend that the September 13, 2011 Vote and Order in this matter and the Report of the Regents Review Committee, Statement of Charges, and Terms of Probation in this matter each be deemed corrected solely insofar as the calendar number of "25304" shown on each of said documents shall reflect the correct calendar number in this matter and be deemed to read the correct calendar number of "25964"; and that the determination rendered on September 13, 2011 shall otherwise remain in full force and effect.

These recommendations are made following the review of 74 cases involving twenty-one registered professional nurses, seventeen licensed practical nurses, six licensed practical nurses who are also registered professional nurses, six pharmacists, three architects, two physical therapists, two podiatrists, one acupuncturist, one certified

public accountant, one dentist, one dentist who is also a holder of a dental enteral conscious sedation certificate, one psychologist, one registered professional nurse who is also a nurse practitioner, one licensed clinical social worker, one licensed mental health counselor, and one nurse practitioner.

#### **Cultural Education**

Regent Roger Tilles, Chair of the Cultural Education Committee, submitted the following written report. Your Committee on Cultural Education Committee had its scheduled meeting on October 18, 2011.

In attendance were committee members: Regents Tilles, Dawson, Rosa, Cea, Jackson, Cottrell Absent was Regent Bendit.

In addition to CE Committee Members, in attendance were: Chancellor Tisch, Regents Norwood, Phillips and Chapey, Commissioner King and Executive Deputy Commissioner Grey.

## ITEMS FOR DISCUSSION

**Chair's Remarks**: Regent Tilles welcomed everyone and opened the meeting and distributed a protype of an arts education symposium on Long Island. Regent Tilles noted that there is a follow-up meeting on November 12. Regent Tilles suggested that the Board of Regents pursue an arts education summit in Albany, based on the model from Long Island.

Regent Tilles also invited members of the committee to a meeting with the New York State BOCES Arts in Education Network to be held in meeting Rooms 216 A and B immediately following the board meeting.

Deputy Commissioner Jeffrey Cannell introduced the item for discussion today:

# CE (D) 1 – Office of Cultural Education History and Program Priorities

• Resource allocation priorities: legal mandates, collection management, research, initiatives in support of local institutions, history of cultural education in the department

This Item is a continuation from the September meeting, regarding resource allocation priorities for the Office of Cultural Education including priorities that address the competing obligations of stewardship, public programming and coordination and outreach to cultural institutions statewide.

There was lively discussion about the priorities. Regent Dawson introduced the concept that collections stewardship also includes use of the collections through research and suggested that the priority reflect the importance of use of the collections to support research. He encouraged OCE to seek ways to make the collections available to researchers, collaborate with other institutions and foster greater use of the collections outside of SED. Dawson also suggested that OCE organize a working group to develop strategies for increasing collaboration of institutions in support of collections use.

Commissioner King suggested that the primary objective of the item was to define the areas where "disciplined attention" should be focused and that by focusing on specific objectives and avoiding the diffusion of an increasingly limited set of resources, great things could be accomplished. The Commissioner cited the success of the recent 9/11 traveling exhibits as a way in which the collections and their use could be leveraged to increase public service, and collaboration with other USNY institutions.

The meeting concluded with a charge from the Commissioner who suggested that the next committee meeting include a discussion of the proposed projects that OCE will pursue over the next 2-3 years that are in alignment with the priorities articulated at this meeting.

# Amani Public Charter School BR (A) 5

(Teresi, J.), Index No. 3197-11, RJI No. 01-11-ST2637, the Board of Regents finds that the proposed Amani Public Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section 2850 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and reissues a charter and provisional charter to the Amani Public Charter School for the term of five years in accordance with §2851(2)(p) of the Education Law, *nunc pro tunc* to December 14, 2010.
