Villa Maria College of Buffalo: Master Plan Amendment to authorize the College to offer a Bachelor of Arts (B.A.) degree program in Creative Writing and Literature BR (CA) 1

STANDING COMMITTEE REPORTS

P-12 Education Committee

Your P-12 Education Committee held its scheduled meeting on February 13, 2012. All members were present except for Vice Chancellor Cofield and Regent Norwood, who were excused.

Action Items

Charter Schools

Your Committee recommends that the Board of Regents finds that the proposed revised charter for South Bronx Classical Charter School: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will permit the charter school to operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves the above listed charter revision as proposed by Chancellor of the NYCDOE and the provisional charter is amended accordingly. [P-12 (A) 1]

Your Committee recommends that the Board of Regents finds that the proposed charter school: (1) meets the requirements set out in Article 56 of the Education Law, and all other applicable laws, rules and regulations; (2) will operate in an educationally and fiscally sound manner; (3) is likely to improve student learning and achievement and materially further the purposes set out in subdivision two of section twenty-eight hundred fifty of Article 56 of the Education Law; and (4) will have a significant educational benefit to the students expected to attend the charter school, and the Board of Regents therefore approves and issues the first renewal charter of the Icahn Charter School 2 as proposed by the Board of Trustees of the State University of New York and that its provisional charter be extended for a term up through and including July 31, 2012. [P-12 (A) 2]

The Committee requested that future charter school revision and renewal items include a description of the school's student performance compared to that of other schools in the district. Also, when reviewing charter school applications, the Committee asked that staff closely look at the impact of co-location and how it might affect the rest of the district.

Motion for Action by Full Board

Your P-12 Education Committee recommends, and I move, that the Board of Regents act affirmatively upon each recommendation in the written report of the Committee's

deliberations at its meeting on February 14, 2012, copies of which have been distributed to each Regent.

Matters Not Requiring Board Action

Dignity for All Students Act

The Committee discussed proposed amendments to regulations that would establish standards for a program to train school employees and administrators to promote a positive school environment that is free from discrimination and harassment; and to discourage and respond to incidents of discrimination and/or harassment on school property or at a school function. Following a public comment period, the proposed amendments will be presented to the Committee for action in April. [P-12 (D) 1]

Career and Technical Education and Student Achievement Measures

The Committee discussed the establishment of a rigorous and aligned CTE system allowing students who receive a technical endorsement in selected areas and who earn a minimum of 65 on all required Regents exams, to be counted with full credit for accountability purposes. Staff recommends that additional steps be taken to more formally align this standard with the Regents' Aspirational Performance Measures by convening an expert advisory panel to review CTE programs and assessments. This panel will make recommendations at a future Committee meeting on which CTE diploma endorsements should be considered for students to meet the Aspirational Performance Measures. Staff also recommends that a more robust set of data be made available to educators and researches by making necessary changes to the student longitudinal data system to properly capture and report CTE data; that the expansion of allowable integrated credits continues to be explored; and that periodic updates be provided to the Board throughout the year. <u>CTE Panel Presentation</u> – **Approved CTE Programs**, **Technical Skill Assessments** and **Accountability Measures**

The panel presented overviews of their programs and answered questions relating to the quality and rigor of CTE approved programs, technical assessment administration and how these assessments are valid and reliable in measuring student achievement. Discussion focused on the benefits of CTE programs for all students and the positive impact they have on college readiness. Panelists discussed the need to get more students interested and engaged in CTE programs. This could be accomplished by providing recognition for both the students and the programs; making it a high-level

program so students feel they are taking challenging courses and preparing for college; and changing the overall perspective of CTE. [P-12 (D) 3]

Adult Career and Continuing Education (ACCES)

Your ACCES Committee held its scheduled meeting on February 13, 2012. All members were present, with the exception of Regent Chapey and Regent Norwood, who were excused. Additional members of the Board attending where: Chancellor Tisch, Regent Bendit, Regent Bottar, Regent Cashin, Regent Jackson, Regent Phillips, and Regent Tallon.

Matters Not Requiring Board Action

<u>Supported Employment Information Directory (SEID) and UCS Vendor Performance Standards</u> – The Committee was provided an update of the on-going progress being made in the development of a data driven system that evaluates and informs ACCES-VR staff and consumers on the performance of supported employment and UCS providers. (ACCES (D) 1)

Amendment of Section 100.8 of the Regulations of the Commissioner of Education Relating to Local High School Equivalency Diplomas based upon Experimental Programs – The Committee discussed the proposed amendment that would extend for an additional year, through June 30, 2013, the existing regulations that allows boards of education to award a local high school equivalency diploma based upon experimental programs. The one year extension is recommended to ensure that all current NEDP students in the approximately 18 program sites across the state are provided with an opportunity to complete their programs and earn a local high school equivalency diploma. (ACCES (D) 4)

Amendment of Section 100.5(b)(7) of the Regulations of the Commissioner of Education Relating to the Award of Local Diplomas to Certain Veterans – The Committee was informed about the Operation Recognition program for veterans and discussed how the Commissioner's Regulations section 100.5(b)(7) was amended to eliminate the local high school diploma beginning in 2008. Although the amendment provided exceptions to allow for certain groups of students in limited circumstances to receive a local high school diploma, no exception is currently provided for veterans receiving a high school diploma pursuant to Education Law section 305(29), (29-a) and (29-b). The proposed amendment is necessary to resolve this discrepancy and provide for issuance of a local high school diploma to such veterans, consistent with the statute, and to add a new subparagraph (xi) to codify in the Regulations the process for the issuance of such diplomas. (ACCES (D) 2)

<u>Alternative Pathways to the High School Equivalency Diploma</u> – The Committee discussed how the GED[®] test is the primary method to achieve a New York State High School Equivalency diploma but with the changes in the administration and content of

the GED[®] test and the increased fee that has been announced, new alternative pathways need to be considered. The Committee agreed to pursue other alternative pathways by issuing a Request for Information (RFI). (ACCES (D) 3)

Professional Practice

Your Professional Practice Committee met at the time scheduled for its meeting on February 13, 2012. All Committee members were present, except Regent Wade S. Norwood, Vice-Chancellor Milton L. Cofield, Regent Geraldine D. Chapey and Regent James E. Cottrell, who were excused. Chancellor Merryl H. Tisch and Regent James R. Tallon, Jr. were also present, but did not vote on any case or action. Because a quorum of the Committee was not present, items were discussed, but no actions taken.

Your Professional Practice Committee held a re-scheduled meeting on February 14, 2012. All Committee members were present except Vice-Chancellor Milton L. Cofield, Regent Geraldine D. Chapey and Regent James E. Cottrell, who were excused.

Action Items

Professional Discipline Cases

Your Committee recommends that the reports of the Regents Review Committees, including rulings, findings of fact, determinations as to guilt, and recommendations, by unanimous or majority vote, contained in those reports which have been distributed to you, be accepted in 10 cases. In addition, your Committee recommends, upon the recommendation of the Committee on the Professions, that 48 consent order applications and 6 surrender applications be granted. [PPC EXS (A) 1-3]

In the case of Lalu Mathew Kochumannil, Registered Professional Nurse, Calendar No. 24793, we recommend that both the caption and the headers in the report of the Regents Review Committee be deemed corrected to read respondent's name "Lalu Mathew Kochumannil", and not "Lalu Mathew Kouchumannil".

These recommendations are made following the review of 64 cases involving ten licensed practical nurses who are also registered professional nurses, nine registered professional nurses, seven licensed practical nurses, five dentists, five pharmacists, two registered professional nurses who are also nurse practitioners, one acupuncturist, one architect, one licensed clinical social worker, one licensed practical nurse who is also a registered professional nurse and who is also a nurse practitioner, one massage therapist, one ophthalmic dispenser, one pharmacy, one physical therapist, one professional engineer, one psychologist, one speech-language pathologist, and one veterinarian.

Restorations

Your Committee recommends the following:

That the Board of Regents grant the application of Gregory Foley for restoration of his license to practice as a certified public accountant in the State of New York. [PPC (EXS) 4]

That the Board of Regents table an application for the restoration of a chiropractor license. [PPC (EXS) 5].

<u>Approvals</u>

Your Committee recommends that subdivision (b) of section 76.4 of the Regulations of the Commissioner of Education be amended; that section 76.5 of the Regulations of the Commissioner of Education be repealed and section 76.7 of the Regulations of the Commissioner of Education be renumbered 76.5; and that section 76.6 of the Regulations of the Commissioner of Education be renumbered 76.8 and new sections 76.6, 76.7, and 76.9 of the Regulations of the Commissioner of Education be added, all as submitted, effective February 14, 2012, as an emergency action upon a finding by the Board of Regents that such action is necessary for the preservation of the public health and general welfare in order to implement Chapter 460 of the Laws of 2011, which becomes effective February 14, 2012, in a timely manner. Proposed Amendments to the Regulations of the Commissioner of Education Relating to the Eligibility Criteria for the Tuition Assistance Program.

Your Committee discussed amending sections 145-2.1, 145-2.2 and 145-2.4 of the Regulations of the Commissioner of Education relating to the eligibility criteria for the Tuition Assistance Program. VOTED: That sections 145-2.1, 145-2.2 and 145-2.4 of the Regulations of the Commissioner of Education be amended as submitted. If adopted at the February meeting, the proposed amendment will become effective on March 7, 2012.

Conceptual Approval of Schedule for New Certification Examinations for Teachers and School Leaders.

Your Committee discussed changing the schedule for implementation of the new certification examinations for teachers and schools leaders in order to enable program administrators and faculty to adjust their curricula and prepare their candidates to pass the new exams. Your Committee agreed to extend the deadline.

National Arts Standards Revision Update – The Committee was updated on the release of new national arts education standards scheduled for early 2013 by the National Coalition for Core Arts Standards (NCCAS). The standards will describe what students should know and be able to do as a result of a quality curricular arts education program. The primary goal of NCCAS is to help classroom educators better implement and assess standards-based arts education in their schools. The revised arts standards will address 21st century skills, guide the preparation of the next generation of arts educators, and embrace new technology, pedagogy, and changing modes of learning. As the standards rollout continues, P-12 and Cultural Education will work closely to better leverage the expertise, resources and general support that Cultural Education can offer arts education. Staff will provide updates in the coming months as the Board of Regents moves towards adoption of these standards.
